ESSEX COUNTY COLLEGE ON FRONT LINE IN FIGHT AGAINST COVID-19

When Essex County began its rollout of the Moderna COVID-19 vaccine to public healthcare employees, first responders and essential workers the last week of December, it chose Essex County College (ECC) as one of its locations.

According to Dr. Gale Gage, Chair of the College's Department of Nursing, it made perfect sense to choose ECC.

"Newark has experienced a high number of COVID-19 infections and with our resources, we are the ideal location. We are also the only urban location in the county currently administering the vaccine," she said.

Dr. Gage also had the distinction of administering the first vaccine shots at the College on December 26. The ini-(Continued on page 5)

Joseph R. Biden, Jr. sworn in as 46th United States President


Kamala D. Harris sworn in as First Madam / Black / Indian / Jamaican Vice President

This past week saw the Divisional Round of the NFL Playoffs. One game saw the Buffalo Bills completely shut down the Baltimore Ravens 17-3. Bills QB Josh Allen finished 14-24 for 206 yards and one touchdown. The win marked the eighth straight Buffalo.

TRUMP'S LAST FORMAL ADDRESS TO THE NATION AS PRESIDENT

"I'd like to begin by thanking just a few of the amazing people who made our remarkable journey possible.

"First, let me express my overwhelming gratitude for the love and support of our spectacular First Lady, Melania. Let me also share my deepest appreciation to my daughter Ivanka, my son-in-law Jared, and to Barron, Don, Eric, Tiffany, and Lara. You fill my world with light and with joy.

"I also want to thank Vice President Mike Pence, his wonderful wife Karen, and the entire Pence family.

"Thank you as well to my Chief of Staff, Mark Meadows; the dedicated members of the White House Staff and the Cabinet; and all the incredible people across our administration who poured out their heart and soul to fight for America.

"I also want to take a moment to thank a truly exceptional

group of people: the United States Secret Service. My family and I will forever be in your debt. My profound gratitude as well to everyone in the White House Military Office, the teams of Marine One and Air Force One, every member of the Armed Forces, and state and local law enforcement all across our country.

"Most of all, I want to thank the American people. To serve as your President has been an honor beyond description. Thank you for this extraordinary privilege. And that's what it is - a great privilege and a great honor.

"We must never forget that while Americans will always have our disagreements, we are a nation of incredible, decent, faithful, and peace-loving citizens who all want our country to thrive and flourish and be very, very successful and good. We are a truly magnificent nation.

"All Americans were horrified by the assault on our Capitol. Political violence is an attack

on everything we cherish as Americans. It can never be tolerated.

"Now more than ever, we must unify around our shared values and rise above the partisan rancor, and forge our common destiny.

"Four years ago, I came to Washington as the only true outsider ever to win the presidency. I had not spent my career as a politician, but as a builder looking at open skylines and imagining infinite possibilities. I ran for President because I knew there were towering new summits for America just waiting to be scaled. I knew the potential for our nation was boundless as long as we put America first.

"So I left behind my former life and stepped into a very difficult arena, but an arena nevertheless, with all sorts of potential if properly done. America had given me so much, and I wanted to give something back.

NEWARK - A police Funeral Mass has been scheduled for Sgt. Hector Moya here at the Basilica of the Sacred Heart 10:30 a.m. Saturday. The Mass is to be preceded by 6-8 p.m. Jan. 22 and 9-9:30 a.m. Jan. 23 visitations at the nearby Alvarez Funeral Home.

Moya, 55, of Jersey City, died Jan. 13 at Summit's Overlook Hospital. He is the seventh Newark Police Division officer to die from COVID-19 complications. Police colleagues escorted Moya's body from Overlook to Alvarez, at 240 Mt. Prospect Ave., that Wednesday afternoon.

Moya, who was born Nov. 23, 1965, joined the then-Newark Police Division in March 1998. Ptl. Moya, who would be promoted to sergeant, was assigned to the Fugitive Apprehension Unit, Auto Crimes Division and Special Victims Division among the 2nd, 4th and 5th precincts.

"The City deeply grieves the loss of this beloved 22-year police veteran," said Mayor Ras Baraka. "We extend our deepest condolences and prayers to Sgt. Moya's family."

"Sgt. Moya was a highly respected NPD member," added Public Safety Director Anthony Ambrose. "He always had a kind word on his lips and a bright smile on his face. He fought a valiant fight against the virus and will be sorely missed."

IRVINGTON - A DPW crew found themselves completing on Jan. 9 what a contracted backhoe operator inadvertently started on a South Ward house.

Irvington Deputy Fire Director John Brown had confirmed that Sunday that 73-75 Welland Ave, which was built in 1892, was levelled. The demolition came 10 days after township firefighters and police had fielded a house collapse report there 3:47 p.m. New Year's Eve.

The first fire and police units had arrived to find the 2.5 story wood frame house's front porch having fallen into its basement. They also found the backhoe operator standing nearby.

First responders found no one else in the house - it had been vacant for renovations - and had called PSE&G to cut all electric and gas supplies there at 5:03 p.m. IFD and Building Construction Department investigators found the backhoe operator uninjured.

"The preliminary investigation appears to be operator error," added Brown. "There was a single worker on the scene using the backhoe without a permit. The owners have been issued violation summonses and a \$4,000 fine."

Township and county property records Jamie Huerta and Martha E. Dutan bought 73-75 Welland for \$110,000 July 30, 2018. The property had been sold in the county sheriff's 2008 and 1999 tax foreclosure auctions.

"Local Talk" found 73-75 Welland's front fence and a cavity where the house had stood Jan. 19. A newly-constructed garage, a new western basement wall and a construction apparatus also remained on-site.

EAST ORANGE - Relatives and friends of the late Richard

Turner, Jr. have had to postpone their formal mourning and life celebration for nearly a month after his fatal accident.

They postponed making funeral arrangements until their GoFundMe.com page had exceeded its goal set on Dec. 28 - the day after Turner, 20, and his passenger, Laiken Nicole Salyers, 23, were found in an Athens, Ohio creek.

A passer-by altered the Ohio Highway Patrol that a 2103 Chevrolet Cruze was partially submerged in the creek early that Monday. OHP detectives believed that the Turner-Saylers vehicle had lost control on an ice covered Dairy Lane bend and had rolled over. Both Turner and Salyers were Ohio State University-Athens students at that time.

Turner's city neighbors may best remember him as a St. Joseph (elementary) School graduate and an East Orange Pop Warner Wildcats and Jaguars football player. "Pudge" applied his scholastic athleticism at Paramus Catholic High School, where he was part of the Paladins' 2017 NJSIAA Non Public Group 4 State Championship team, and with the OSU Bobcats

Turner, PCHS Class of 2019, was the oldest of four children raised by Iraqi war veteran Richard Sr. and Angela Turner. Brother Malcolm and sisters Amelia and Amirah are also among his survivors.

ORANGE - Some who remember Joyce Dwyer, 87, who died in Caldwell Jan. 13, may recall her longtime residency here and as a person who was destined to dance.

It came to no surprise to those who remembered her growing up here and in West Orange that she was a Radio City Music Hall Rockette for 38 years.

The former Joyce Madeline Hector, WOHS Class of 1951,

was written up in that year's "West-O-Rama" yearbook as ready with a wink, a smile, and to dance. Hector, in her WOHS senior year, had also begun to give dancing lessons. to younger people. Her dancing got her a mention in the 1948 yearbook while still a freshman.

Her 1951 yearbook credits included working on the junior prom's floor and decorations, being a student council alternate and being awarded the class' best female brunette.

Hector, although born in Newark Aug. 20, 1933, grew up in West Orange with parents Edward and Gertrude. The newlygraduated WOHS "Cowgirl" (The school's mascots were the Cowboys) moved to Orange, married a Mr. Dwyer and made the Rockettes audition.


Dwyer, who also lived in Spring Lake, is survived by nephews John and Michael Weinhofer, Robert and James Merriam and Carlo Corvaja and nieces Cecile Corvaja and Jodie Weinhofer.

Dwyer's burial, arranged by Codey & Jones Funeral Home of Caldwell, was held at East Hanover's Gate of Heaven Cemetery. memorial donations may be made to your choice of charity.

WEST ORANGE - The West Orange St. Patrick's Day Parade Committee, on Jan. 13, has postponed their 2021 march down Main Street to a later, to be announced date.

"In consultation with the township, the committee has decided to postpone the 2021 parade in March due to the ongoing COVID-19 situation," said chairman Kevin Brennan in his open letter. "We're currently evaluating other options for holding events in 2021 when the current situation and restrictions improve."

tial vaccine administered by Dr. Gage was to one of her former students who is now a public health nurse.

The ECC site has been administering between 150 and 250 injections a day, said Sharon Guerrero of the Essex County Health Department. "There's been amazing interest by the public to get vaccinated," said Ms. Guerrero standing in the hallway of the College's Gym as a steady stream of residents came to receive the shot.

The second dose is given 28 days after the initial shot.

Dr. Gage also put out a request for volunteers among the College's Nursing students. She said eight students volunteered almost immediately. Each day four or five of the volunteers assisting are ECC students. Nursing Department faculty members Majuvy Sulse and Myrna Scott also have been assisting in the effort.

"It's important to be here and it's providing me good experience," said Nursing major Roseli Araujo. Among Roseli's duties is ensuring people receiving the shot remain on site for minutes before leaving. Roseli added as soon as she heard about the call for volunteers, she was ready to help.

Fellow Nursing student Maddie Sutton was busy checking in residents and issuing them proof of vaccination cards. "It's such a good feeling helping out on something as important

as this," she said. Maddie comes to the Gym for about five hours three days a week. She hopes to continue once a week when classes start on January 19.

"This is such a fantastic learning experience for our students to see how public health workers battle a global pandemic. They are a part of history. It is especially our responsibility to educate our Black and Brown communities on the importance of receiving the COVID-19 vaccine," said ECC Interim President Dr. Augustine A. Boakye.

"As our Newark college community continues to struggle with many underlying health conditions that exacerbate the risks associated with COVID-19, we must rely on the science that the vaccination is safe," said Alfred Bundy, a member of the College's Coronavirus Alert Taskforce. "It's also good to see the College playing a key role in combatting COVID-19 in Newark," added Mr. Bundy, who is also Executive Director of Institutional Advancement at ECC.

Even as the vaccine is being administered, it remains imperative that people still adhere to all CDC health and safety guidelines, which are in place at the College. These guidelines include frequent hand washing, properly wearing a face mask, maintaining social distancing of 6 feet apart, and staying home when you feel ill. FORMER NEWARK POLICE COP **GETS NINE YEARS IN PRISON**

NEWARK - A former Newark police officer was sentenced Jan. 7 to 108 months in prison for conspiring to defraud the Newark Watershed Conservation and Development Corporation (NWCDC) and giving kickbacks to its former executive director, Acting U.S. Attorney Rachael A. Honig announced.

Janell Robinson, 45, of Newark, was previously convicted of one count of conspiracy to defraud the NWCDC facilitated by use of mails and wire transmissions, two counts of mail fraud, and one count of conspiracy to commit extortion under color of official right affecting interstate commerce, following a jury trial before U.S. District Judge Susan D. Wigenton. Judge Wigenton imposed the sentence today in Newark federal court.

According to documents filed in this case and the evidence at trial: Between March 2010 and May 2013, while Robinson was a Newark police officer, she controlled Protected and Secured Services LLC (P&S), a company that purported to provide security consulting services to its only client, the NWCDC.

Robinson conspired with Linda Watkins Brashear of West Orange, the former executive director of the NWCDC, to pay

Brashear a stream of concealed and undisclosed kickbacks from the proceeds that P&S received from the NWCDC. In exchange for Brashear's assistance with securing P&S a contract with the NWCDC and approving completely fraudulent or inflated invoices that Robinson submitted, Robinson paid Brashear cash kickbacks from the proceeds of the fraud.

The NWCDC paid P&S approximately \$289,000 during the scheme, approximately \$50,000 of which was used by Robinson used to pay Brashear kickbacks.

In addition to the prison term, Judge Wigenton sentenced Robinson to three years supervised release and ordered her to pay restitution of \$288,950 to the NWCDC.

Acting U.S. Attorney Honig credited special agents of the FBI, under the direction of Special Agent in Charge George M. Crouch in Newark, and special agents of IRS - Criminal Investigation, under the direction of Special Agent in Charge Michael Montanez, with the investigation leading to the sentencing.

The government is represented by Senior Trial Counsel Leslie F. Schwartz of the U.S. Attorney's Office Special Prosecutions Division.

11 Cops Hurt in Black Lives Matter Protest

In a scene that echoed the chaos at the Capitol from two weeks ago, a day honoring a legend of peace was marred by violence.

On the evening of Jan. 18, the date of this year's Dr. Martin Luther King, Jr. Day observance, there was a march from Brooklyn, NY to City Hall in Manhattan. Upon arriving at their destination, the protestors then started throwing objects and disrupting traffic. In all, 29 people were arrested in the incident, with 11 officers injured trying to calm the crowd.

This incident came just days after New York Attorney General Leticia "Tish" James sued the New York Police Department over how it handled the George Floyd protests in the city last year. More than 2,000 people were arrested during those demonstrations.

Nine Charged in Flint Water Crisis

Developments in the state of Michigan have piqued the interest of some residents in Newark, New Jersey.

On Jan. 14, Michigan Solicitor General Fadwa Hammoud and Wayne County Prosecutor Kym L. Worthy announced that after 12 months of grand jury proceedings nine individuals have been indicted on a total of 42 counts related to a series of alleged actions and inactions that created the historic injustice of the Flint Water Crisis.

The Chief Judge of the Seventh Circuit in Genesee County appointed Judge David Newblatt to act as a one-man grand jury to investigate crimes related to the crisis. Indictments were issued after the grand juror listened to and evaluated the evidence presented.

The following defendants were charged by Solicitor General Hammoud and Prosecutor Worthy as part of the criminal investigation into the Flint Water Crisis:

- Jarrod Agen Former Director of Communications and Former Chief of Staff, Executive Office of Gov. Rick Snyder
 - ◆ One count of perjury a 15-year felony
- Gerald Ambrose Former City of Flint Emergency Manager
 - ◆ Four counts of misconduct in office each a five-year felony and/or \$10,000 fine
- Richard Baird Former Transformation Manager and Senior Adviser, Executive Office of Gov. Snyder
 - One count of perjury a 15-year felony
 - ◆ One count of official misconduct in office a five-year felony and/or \$10,000 fine
 - ◆ One count of obstruction of justice - a five-year felony and/or \$10,000 fine
 - ◆ One count of extortion a 20-year felony and/or \$10,000 fine
- Howard Croft Former Director of the City of Flint Department of Public Works
 - ◆ Two counts of willful neglect of duty - each a one-year misdemeanor and/or \$1,000 fine
- Darnell Earley Former City of Flint Emergency Manager
 - ◆ Three counts of misconduct in office each a

five-year felony and/or \$10,000 fine

- Nicolas Lyon Former Director, Michigan Department of Health and Human Services
 - Nine counts of involuntary manslaughter each
 a 15-year felony and/or
 \$7,500 fine
 - ◆ One count of willful neglect of duty - a one-year misdemeanor and/or \$1,000 fine
- Nancy Peeler Current Early Childhood Health Section Manager, Michigan Department of Health and Human Services
 - ◆ Two counts of misconduct in office each a five-year felony and/or \$10,000 fine
 - ◆ One count of willful neglect of duty - a one-year misdemeanor and/or \$1,000 fine
- Richard Snyder Former Governor of Michigan
 - ◆ Two counts of willful neglect of duty each a one-year misdemeanor and/or \$1,000 fine

 - Nine counts of involuntary manslaughter each a 15-year felony and/or \$7,500 fine
 - ◆ Two counts of misconduct in office each a five-year felony and/or \$10,000 fine
 - One count of willful neglect of duty a one-year misdemeanor and/or \$1,000 fine

The defendants turned themselves in and were arraigned before Judge Elizabeth A. Kelly for the Seventh Circuit Court and Chief Judge Christopher Odette for the 67th District Court. Details on their arraignments and subsequent court

dates will be forthcoming.

"When an entire city is victimized by the negligence and indifference of those in power, it deserves an uncompromising investigation that holds to account anyone who is criminally culpable. That is what all residents in this state are entitled to, regardless of their ZIP code. And that is what this prosecution team did. Our approach was simple - where we believed the evidence would prove a criminal charge, we sought and obtained indictments for those crimes," said Solicitor General Hammoud.

"We must remember that the Flint Water Crisis is not some relic of the past. At this very moment, the people of Flint continue to suffer from the categorical failure of public officials at all levels of government, who trampled upon their trust, and evaded accountability for far too long. We understand that our work is not done and although the criminal justice system alone cannot remedy all the suffering that every person endured, we took our part seriously. We hope others will do the same to ensure this never, ever happens again."

With news of the charges in this case, many in the Brick City are pondering if such action will be taken against city leaders who oversaw the Newark Water Crisis.

what would have been West Orange's 69th parade may not step off for the second straight year.

The committee, township and participating organizations had first postponed the 2020 edition from March 15 to August in the face of the pandemic and its resulting shutdowns. All parties, after unable to find a way to maintain social distancing, canceled that year's parade Aug. 5.

2020's Grand Marshall Mellen Dangler and her deputy marshals John Demars, Patrick Giblin, Bobby Lamb and Robert Swenson will have to wait later into 2021 or '22 to lead marchers from Our Lady of Lourdes Church to the West Orange Municipal Building.

The Committee, said Brennan, had held mask and food distributions and donated 230 coats to Holy Trinity Church in the interim. They were joined by the likes of the Friendly Sons of the Shillelagh, Ancient Order of Hibernians and the Women of Irish Heritage in the committee's "off season" events.

"Remember, we will march again," finished Brennan. "Stay Strong. Stay Safe. Stay Irish."

SOUTH ORANGE / MAPLE-WOOD - There are a lot of parties within and from outside the South Orange-Maplewood School District who are monitoring its hybrid learning model since its Jan. 19 launch.

All Kindergarten-Second Grade, Grades 6-9, special education and English language learners, since Tuesday morning, have the option to be taught in classrooms. The entire SOMSD student body, their parents and teachers have had virtual or remote learning since the COVID-19 pandemic struck in mid-March.

Superintendent of Schools

Dr. Robert Taylor, on Jan. 12, is keeping all Grades 3-5 and 10-12 students on-line only until at least next month. Taylor had based that postponement on local and Essex County COVID transmission rates. School nurses are reporting their daily findings to South Orange and Maplewood health officers.

Members and officers of the South Orange-Maplewood Education Association are also on the hybrid learning and COVID watches.

SOMEA President Rocio Lopez, on Jan. 8, had asked for a further postponement until all of his teaching members, who are in Tier 1B, get their vaccinations and all 11 building's ventilation systems have been completed.

MONTCLAIR - Mikie Sherrill (D-Montclair) is not the only Congress member who wants to know which of her colleagues gave guided tours of the Capitol on Jan. 5 - the day before its invasion by extreme supporters of then-President Donald J. Trump.

Sherrill sent a letter to the acting U.S. Capitol police chief and acting Congressional sergeants-at-arms Jan. 13 calling for "an immediate investigation and access given to Capitol Complex visitors Jan. 5." Her letter was co-signed by 33 Congressional colleagues - including Donald M. Payne, Jr. (D -Newark), Albio Sires (D-W. New York) and three other New Jersey delegation members.

Sherrill, in her letter and Jan. 12 social media video, said she had noticed "extremely high number of outside groups in the complex" and had reported it to the then-House of Representatives Sergeant-at-Arms that Tuesday.

She and her letter co-signees said that what they saw that day was an "unusual, noticeable and concerning departure" on at least three levels. The first is that

NEWARK TAX PREPARER ADMITS TO MESSING WITH TAX RETURNS

NEWARK - A Pennsylvania man who worked as a tax preparer in Newark admitted Jan. 20 to helping his clients file falsified tax returns that generated larger refunds, Acting U.S. Attorney Rachael A. Honig announced.

Sylvain Dienhoue, 53, of Tobyhanna, Pennsylvania, pleaded guilty by videoconference before U.S. District Judge Susan D. Wigenton to an indictment charging him with three counts of aiding and assisting in the preparation of false and fraudulent tax returns.

According to documents filed in this case and statements made in court: Dienhoue worked as a tax preparer at Cadi's Multi Services in Newark. He knowingly and willfully aided and assisted in the preparation of 44 fraudulent tax returns on behalf of clients for the tax

years 2014 through 2016. Dienhoue used fabricated and inflated figures, including expenses and itemized deductions, in order to generate inflated refunds.

Each count of aiding and assisting in the preparation of false and fraudulent tax returns carries a maximum penalty of three years in prison and a fine of up to \$250,000. Sentencing is scheduled for May 24, 2021.

Acting U.S. Attorney Honig credited special agents from IRS - Criminal Investigation, under the direction of Special Agent in Charge Michael Montanez in Newark, with the investigation leading to the guilty plea.

The government is represented by Assistant U.S. Attorney Samantha C. Fasanello of the U.S. Attorney's Office's Criminal Division in Newark.

dating app. Once communication becomes regular and a certain level of trust is established, criminals share investment tips with their victims and encourage them to join a scheme.

Victims download a trading app and open an account, buy various financial products and work their way up a so-called investment chain, all under the watchful eye of their new "friend." They are made to believe they can reach Gold or VIP status.

As is often the case with such fraud schemes, everything is made to look legitimate. Screenshots are provided, domain names are eerily similar to real websites, and customer service agents pretend to help victims choose the right products.

One day, however, all contact stops, and victims are locked out of the account. They're left confused, hurt, and worried that they'll never see their money again.

INTERPOL's Financial Crimes unit has received reports from around the world of this scam and is encouraging dating app users to be vigilant, be skeptical and be safe when entering into online relationships. This has become especially important as people turn to online interactions during the COVID-19 pandemic.

Here are some tips to make sure online dating remains fun and doesn't empty your bank account:

- Always be vigilant when you are approached by someone you don't know, especially if it leads to a request for money
- Be skeptical: online investments with promises of fast, amazing returns are often too good to be true
- Think twice before transfer-

- ring money, however genuine the request might seem
- Do your research: check reviews, double check the app, the domain name, the email address, etc.
- Don't disclose personal/ confidential information
- If you realize you've been the victim of a fraud, report it.

ASIA

India's Massive Vaccine Campaign

In a major milestone in the fight against deadly diseases, United Nations agencies and humanitarian partners announced on Jan. 12, the establishment of a global Ebola vaccine stockpile, to help control future epidemics by ensuring timely access to vaccines for populations at risk, during outbreaks.

India has begun what is the world's biggest COVID vaccination campaign so far, deploying hundreds of thousands of health workers, with the training and support of the UN World Health Organization (WHO).

On Jan. 16, the first day of the campaign, 207,229 vaccine shots were given across the country, one of the worst-hit by COVID-19, with over 10 million COVID-19 infections and 150,000 deaths.

"(We) provided technical assistance to the Government of India for the development of operational guidelines and other training materials for state and district program managers and vaccinators, and establishing tracking and accountability frameworks," Roderico H. Ofrin, WHO Rep. in India said.

"WHO field officers have facilitated the highest-level oversight through regular task force meetings at state and district levels, which are chaired by the Principal Secretaries (Health) at

My Experience With The Pfizer Vaccine



It's no longer news that the FDA has approved the Pfizer vaccine for public use. Of course, it will take a while for everyone to get it, but at least there's progress. This comes as a huge relief, considering we were seemingly stuck in one spot for months.

We have toppled the first step to ridding the planet of this deadly virus with the creation of a safe and effective vaccine. The next step, and perhaps the most important, is rolling out the vaccine. Right now, the public's perception is of the vaccine is generally good, which is another piece of good news. Look at that, two favorable news in one article, we're on a roll!

However, our death rate hasn't improved; it's worsening. We are recording record cases and deaths every other week. That is bad news. I know the vaccine is available, but it's not an excuse to neglect COVID protocols, particularly if you've not been fully vaccinated.

Talking of full vaccination, I got my second Pfizer dose some time back, 21 days after the first. I think it's safe to say I have ~95% immunity now. My symptoms were simply arm soreness, and a headache. The second time around some chills. But it was nothing Tylenol couldn't take care of. I was back to work the next day, taking care of COVID patients. And I am relieved. I have been working on the frontlines taking care of COVID patients since the beginning, always afraid whether I had caught COVID or not. Now, I am more comfortable seeing patients. Don't get me wrong, I will continue to wear full PPE. My colleagues and I feel a sense of re-

I noticed many people are skeptical about the vaccine because they are unsure of the side effects and long-term effects. And I can confidently say you have nothing to worry about on both fronts. People that bring up the uncertainty of the long-term effects of the vaccine are more driven by emotions rather than data and figures.

There is no indication whatsoever that the vaccine can be potentially dangerous to us in the long run. None at all. And this is coming after several tests and studies before the vaccine got FDA approval. If the results of past vaccines are also anything to go by, you have nothing to worry about on this front. Vaccines help to end diseases, not start new ones.

Then to the immediate side effects of the vaccine. Luckily, there is little to worry about here too. There are little to no side effects at all in many people. It's saying a lot when the commonest side effect is pain around the injection site. Don't get it twisted; the vaccine itself does not cause the pain. It's just your body reacting to a needle breaking into your skin. About 85% of people that took the vaccine reported this. But not to worry, it goes away in a few days or even hours in some people. I didn't have any real injection site reactions.

Other symptoms people experience are headache, fatigue, and body pain. These are the less common symptoms. I had some fatigue and headaches, but when you work more than 200 hours a month treating COVID patients, you can't pin that to a vaccine.

These symptoms, just like the reaction to the injection site, also pass in a few days at most. You can accelerate this by using an analgesic, like Tylenol. That's it. You see, there's nothing to fear.

However, it would help if you also took some precautions to make your experience very smooth. First, take the vaccine on your free day or after work hours. While the headache is usually minor, if any at all at that, you can aggravate it by stressing yourself after. The same applies to fatigue and body pain.

You should also be prepared for slightly worse reactions to the second dose. This makes sense when you think of it. After the first dose, your body is already familiar with the vaccine, generating some immune response. Taking the second dose will see your body exhibit a stronger immune response to the vaccine because it already has the immunological knowledge and 'tools' to fight the virus. That's obviously an oversimplification, but it should do the trick.

Finally, remember you aren't completely safe until you take the second dose. You may still get the virus if exposed in the 21 days between the first and second dose. So, again, you shouldn't neglect COVID guidelines because you have taken a dose of the vaccine. Stay safe.

According to media reports, an estimated 10 million health workers are targeted to be vaccinated in the first round, followed by other front-line workers such as police, security forces and municipal staff, with plans to inoculate 300 million people by August.

Prior to the start of the campaign, UN agencies help with detailed preparations.

For its part, WHO participated in dry-run simulations and provided feedback on management of vaccines, registration of beneficiaries, as well as reporting on vaccination coverage and adverse events following immunization.

It also worked with the Government and the UN Development Program (UNDP) on real-time reporting and problem-solving when issues arose at the vaccination sites, according to Dr. Ofrin.

At the provincial level, WHO also supported implementation and monitoring of health policy, such as developing standard operating procedures, preparing technical briefs, and providing best practices from other parts of the India as well as other countries.

CARIBBEAN

Political Unrest in Haiti

Increasing political tensions in Haiti coupled with insecurity and structural inequalities could result in protests followed by violent crackdowns by authorities, the United Nations human rights office (OHCHR) warned on Jan 19.

According to the office, criminal activities, such as kidnappings, gang fights and widespread insecurity have increased, with "almost total" impunity.

Added to the volatile mix is resurging political tensions over the timing and scope of elections and a constitutional referendum proposed by the Government, OHCHR spokesperson Marta Hurtado told journalists at a regular briefing in Geneva.

"Calls for mass protests have been growing. This in turn raises concerns of renewed human rights violations by security forces during the policing of protests as seen during the months-long protests in 2018 and 2019, as well as during demonstrations in October and November of last year," Hurtado said.

standards regarding the use of force when dealing with protests; as well as ensuring that gangs do not interfere with people's right to demonstrate peacefully.

She also urged the Government to guarantee accountability for past violations and abuses, ensuring justice, truth, and reparations. Alongside, Haiti should take steps to address people's grievances and the root causes that fueled the protests, she added.

According to an OHCHR report on the unrest, protests started relatively peacefully in July 2018 but became increasingly violent over time, with many violations and abuses of the rights to life, security of the person and effective remedy.

The OHCHR spokesperson called on Haitian authorities to take "immediate action" to avoid repetition of such violations and abuses by ensuring that law enforcement officers abide by international norms and

Prayer Reformation

After the Capitol Hill riot on January 6, 2020, people have been sharing the powerful words prayed by Dr. Barry Black, the Chaplain of the Senate.

In the prayer, he asked the Sovereign Lord to help all who saw or shared in the seditious actions to recognize the deplorable nature of the actions in desecrating the Capitol building, the shedding of innocent blood, the loss of life, and "the quagmire of dysfunction that threaten our democracy." Then, for leaders to repent for the tragedy of the words that led to the actions, to resolve to protect and defend the Constitution of the United States against all enemies domestic as well as foreign, and to lead the way in bringing about healing and unity to the hurting and divided nation and world. It was a powerful prayer indeed.

After a few days when I saw new clips of the seditionists in the Capitol, I could not believe my ears, that they were praying. After they had beaten up some of the police officers and killed one, and desecrated the chambers, one stood with his bull horn and prayed quite a long prayer, directed to who he called the Almighty God and closed the prayer in the name of Jesus.

After turning away from the clip for a moment, I had to ask the Lord to help me understand his mercy. How can my God listen to prostituting prayers? Then my mind turned to a scene from centuries ago, on a mountain

called, in the land of Israel, Carmel.

As the story is told, in 1 Kings 18:16-45, the prophet of God, Elijah confronted some 400 prophets of king Ahab and queen Jezebel of Israel in one of the greatest contests of all times. The prophet Elijah brought the challenge because the people of Israel had been led astray with a lot of falsehood, into the worship of the fertility god called Baal, by king Ahab and Jezebel.

In the worship of Baal, the people were still believing that they were worshiping the God of Heaven. So, prophet Elijah invited them to a contest on Mount Carmel to prove who was the true God, the one who could stop the rain or allow it to fall. The worshippers of Baal accepted the invitation, and on the Mountain, they built their altar, offered their sacrifice and prayed from morning till evening to Baal. When Baal did not answer, they shouted and in their frustrations cut themselves, but they never got an answer.

Then evening came and Elijah repaired the altar of God that had been dedicated to God years before but now broken down. He got his two bulls and offered his sacrifice and prayed. Before long fire came down from God and burned up his sacrifice. And the people who were standing around watching the contest began to shout, "The Lord, he is God."

The rest of the story is of interest but the point of importance for us here is that a period of reformation began in Israel. Of course, in a month the reformation followed a trajectory of rebellion and the prophets and other servants of God in Israel had to constantly call for reform. Read the history in Ezra, Nehemiah, Jeremiah, Ezekiel, Joel,

and Malachi where you can hear and see the prayers of reform that were prayed. At a point, the nation became so idolatrous that it was subjected to captivity from other nations.

Yes, I am calling for prayer reform before it is too late, because from what I am noting, I would argue that for all the prayers that are being prayed during this time of crisis, not all the prayers seem to be prayed to the Sovereign of heaven. In fact, for a while I have been trying to reconcile what has been happening to the prayers at the National Prayer Breakfast, which seemed to denigrate into political rhetoric rather than prayers.

Further, I have been wondering whether our National Day of Prayer, which has been celebrated by Americans of many persuasions, including Christians of many denominations, and Sikhs, Muslims, Hindus, and Jews, has lost its meaning.

This day of prayer held on the first Thursday of May each year, when many Americans assemble in front of courthouses, as well as in houses of worship, such as churches, mosques, synagogues, and temples, and hold luncheons, picnics, and music performances revolving around praying for the nation seem has been trivialized, to the extent many are asking what is the use.

What I am trying to say is this. If we want the prayers, being offered in the congress, and at our prayer breakfasts, in our centers of faith, our prayer groups and prayer closets, to have significance we are going to need prayer reform. We are going to need clarity on who we are praying to, whether it is the God of heaven, or the Baal or (mammon) money, or some personages that we are holding dear, in the place of the God of

neaven.

I hear a lot of people tossing around the section of king Solomon's prayer in 2 Chronicles 7:14 that call us to repentance, "If my people who are called by my name humble themselves, and pray and seek my face and turn from their wicked ways, then I will hear from heaven and will forgive their sin and heal their land." (ESV), but I need say, if we are saying the words, we need to mean them.

Hope that I am not being too harsh in judging anyone's lack of sincerity, although I know that sincerity has nothing to do with truth. What I am emphasizing is that we cannot be serving God while corrupting his name with our ideas or ideological practices that contradict what his righteousness demands. As the great preacher R. A. Torrey, of a couple generations ago, said, "We have to be clear on who and what our service needs to be. If we have sin in our hearts it makes it impossible for God to answer our prayers, even though the thing for which we are praying is entirely according to His will."

The purpose of this reflection is not to discourage our prayers, but to ask that we examine who we are praying to, what we are praying for, and how we are praying. The prophet Isaiah says "Behold, the Lord's hand is not shortened, that it cannot save, or his ear dull, that it cannot hear; but your iniquities have made a separation, between you and your God, and your sins have hidden his face from you, so that he does not hear." Isaiah 59:1-2 (ESV)

May God help us to reform our prayer lives, so that the hand of God might help and heal us.

4, 5, maybe even up to 10 years to develop a vaccine. We did in nine months.

How Did This Happen? ... What Can We Do?

How, Dear God, did we get here? We always worked. We sent her to a good school. We live in a nice home. She had decent clothes. We went to church. We did everything we could to protect her. My daughter is a drug addict!

Over the years, I have worked with many families who called me to get their teen released from a detention center for the second, third or fourth time because he or she had been picked up yet again for possession and distribution of a controlled, dangerous substance which the kid had amply used.

I recall Alice, a mother of a

teen I had previously represented - twice - called me one Monday morning to say, "They picked up our boy again." Knowing exactly who "they" were, I immediately responded, "I can be downtown in an hour." Her response was, "Go ahead. He turned 18 yesterday, and I am done!" I was left with a couple of thoughts that I share with you.

First, know this. Authorities like the National Institute on Drug Abuse advise that addiction really is a disease. It occurs because of the way the brain responds to intoxicating drugs. Addiction in the medical community is considered a "chronic disease" akin to diabetes, or other diseases that involve cycles of relapse and recovery and requires continuous monitoring in order to manage the disease.

To break the arrest/jail cycle, parents must confront the disease. Parents must accept that addiction is not just the teen's problem, but may have broader implications about the entire family, for example, how family members deal with feelings, or express emotions.

- MYTH: My child is an addict because she lacks will-power and self-control.
- FACT: Addiction happens due to chemical changes in

- the brain caused by the drug.
- MYTH: Only children who are low IQ, have no talents, are academically challenged become addicted.
- FACT: Substance abuse affects smart kids, dumb kids, rich kids, and kids from all sectors of the community.

In children and teens, drug abuse may point to an underlying psychological disorder. Some of the common cooccurring mental health conditions found with substance abuse in kids include: depression, attention deficit hyperactivity disorder (ADHD), bipolar disorder and generalized anxiety disorder.

The Substance Abuse and Mental Health Services Administration states that in 2014, 2.8 million teens between 12 and 17 had an episode of major depression. The symptoms of mental illness and addition can be so similar that parents may overlook one or the other: Selfisolation, feelings of hopelessness or worthlessness, false beliefs or delusional thinking.

Alice's kid was sick. He wasn't really a criminal. I liked him, but to arrest him and not address the cause of the problem is a recipe for the problem to resurface and repeat itself.

He was a nice guy! So why

is a lawyer worried about teen drug use? Because what lawyers help their clients do is SOLVE THE PROBLEM. While the lawyer's initial issue may be getting the teen released from detention, a secondary issue is to help parents understand how not to need you again for the same issue. This means telling them what resources they need while there remains time.

We need to pay closer attention to teen behaviors so that they can be addressed while the teen is a juvenile and the policy is "rehabilitation." Once a teen turns 18 and is considered an "adult," the criminal justice system's only interest is punishment.

Second, the thought made me thank all that is holy that New Jersey has become more enlightened in its approach to criminal justice reform. But we need to do more. We need to expand treatment for juveniles. It really does little good to get the teen released and have them return to the same place, doing, or not doing the same things. It's sort of like the classic definition of insanity.

We need to make sure all police know that there are alternatives to arrest and conviction. We need juvenile drug courts, and we need to expand mental health services for our children.

public tours had ended last march due to the COVID pandemic.

Second, Sherrill, a former USAF helicopter pilot, is among those Congress members and staff who "have served in the military and are trained to recognize suspicious activity. Some of the same Congress members and staff, on Jan. 6 noticed that "members of the group that attacked the Capitol seemed to have an unusually detailed knowledge of the complex's layout."

"I intend to see that those members of Congress who had groups coming through the Capitol that I saw on Jan 5," said Sherrill Jan. 12, "be held accountable and, if necessary, ensure that they don't serve in Congress."

Sherrill and her 33 colleague's call for an investigation is in addition on why some U.S. Capitol police fraternized with the insurrectionists Jan. 6 and how and why the USCPD and related law enforcement had underprepared in the face of pre -Jan. 6 social media chatter and in comparison, to the BLM protests. Both Congressional sergeants at arms and Capitol police chief had resigned soon after Jan.

BLOOMFIELD - Township Administrator Matthew Watkins may introduce legislation at the Township Council's Jan. 25 Zoom meeting that would affect the Oakeside Cultural Center's future operation.

Watkins, on behalf of Michael Venezia, is to introduce an ordinance that would create a "Bloomfield Arts Utility," that, if passed, would oust the Oakeside Cultural Center's Board of Trustees.

Oakeside's trustees had been running the 1895 Oakes mansion here at 240 Belleville Ave. on the township's behalf since the lease was passed by Township Council resolution, under Mayor John W. Kinder's administration in 1982. The OCC was then established as an independent 501(c) (3) corporation.

The mansion was once owned by the Oakes family, who ran their textile mill across the avenue until its last descendant. Jean Oakes, 92, died here in 1980.

The self-sufficient OCC board had held tours and special events into the pandemic's start. The mansion, riage house and grounds are on the national and state historic places registerers.

Township Attorney Michael Parlavecchio told OCC Executive Director Kim Reilly last summer, however, that the township will assume Oakeside control Oct. 1 - 12 years ahead of the lease's expi-

Parlavecchio cited that Bloomfield's elders should have accepted the lease as an ordinance and not as a resolution. "Bloomfield's top lawyer" further claimed that the carriage house should never have been rented out.

NUTLEY / BELLEVILLE - Last rites for Vincent LoCurcio III, 64, co-owner of the Nutley Park and new Belleville ShopRite supermarkets, were held here at the Biondi Funeral Home Jan. 13 and at Bloomfield's Glendale Cemetery Jan. 14.

LoCurcio had died here at home in the company of relatives Jan. 9. His cause of death was not disclosed. "Vince," except for his Passaic birth and bachelor's degree from Midland, Mich.'s Northwood University, was a lifelong Nutlevite.

The Nutley High School Class of 1974 graduate was the third of four generations of LoCurcios and Infusinos who own and operate the Nutley Park ShopRite. Grandfather/Park Foods founder Vincent LoCurcio, Sr. and butcher Thomas Infusino joined forces in 1953. Father Vincent, Jr. assumed the helm after they joined Wakefern Foods/ShopRite in 1954.

Vince and co-owner David Infusino bought the former PathMark at 726 Washington Ave after parent A&P's 2012 liquidation. They reopened the minimall's remodeled anchor store in 2013. (It is not immediately known if they had any connection with the 1950s ShopRite at 165-83 Washington Ave,)

LoCurcio and Infusino received the Nutley Irish-American Association's 2019 Dr. Virginus D. Mattia Award. The longtime Nutley Chamber of Commerce President was on the Wakefern and Nutley Family Service Bureau's board of directors.

Wife Carol, mother Antoinette, sons Luke LoCurcio and Joseph Frusteri, daughter Michelle Yasso, Vincent LoCurcio IV and four other grandsons, granddaughter Ellla and sisters Ann Bator, Jeanne Clark and Carole Casale are among his survivors.
