NEWARK - Mayor Ras Baraka may have signed an ordinance by when you read this, that the Municipal Council approved March 17, that places a cap on redevelopers' "Pay-to-Play" contributions.

The Mayor like with most pother legislation, has 20 days to sign a council-passed ordinance for it to take effect. Although tis 20-day period ends April 5, Baraka may have signed on long before then.

Baraka's respective Corporate Counsel and Business Administrator, Kenyatta Stewart and Eric Pennington, had introduced this revision to the city's May 2011 "Pay-to-Play" legislation before the Council Feb. 3.

The measure repeals the previous ban on developers making contributions to municipal-level candidates' campaigns and/or political parties with a \$300 per candidate limit.

Pfizer Vaccine "100% *Effective*" on Teens

A new CDC study provides strong evidence that mRNA COVID-19 vaccines are highly effective in preventing SARS-CoV-2 infections in real-world conditions among health care personnel, first responders, and other essential These groups are workers. more likely than the general population to be exposed to the virus because of their occupations.

The study looked at the effectiveness of Pfizer-BioNTech and Moderna mRNA vaccines in preventing SARS-CoV-2 infections among 3,950 study participants in six states over a 13week period from December 14, 2020 to March 13, 2021.

Results showed that following the second dose of vaccine (the recommended number of doses), risk of in-

fection was reduced by 90 percent two or more weeks after vaccination. Following a single dose of either vaccine, the participants' risk of infection with SARS-CoV-2 was reduced by 80 percent two or more weeks after vaccination.

It takes about two weeks following each dose of vaccine for the body to produce antibodies that protect against infection. As a result, people (Continued on page 5)



NINE INDIVIDUALS CHARGED WITH CONSPIRACY TO DISTRIBUTE NARCOTICS

NEWARK - Nine Newark residents were charged for their roles in conspiracies to distribute and possess with intent to distribute narcotics, Acting U.S. Attorney Rachael A. Honig announced March 25.

Robert Covington, aka "Nachie," 55; Korey Smith, aka "Murda," 36: Jeffrey Workman, aka "Rah," 53; Yvonne Jackson, 49; Carlos Stokes, aka "Ab," 54; Karen Gamble, 50; and Alaa Covington, 21, are charged by criminal complaint with conspiracy to distribute and possess with intent to distribute at least 40 grams of fentanyl. Robert Covington, Workman, Williamson, Stokes, and Gamble are also charged with conspiracy to distribute and possess with intent to distribute cocaine. Smith is additionally charged, along with Leroy Baxter III, 55, and William Lane, 57, with conspiracy to distribute and possess with intent to distribute heroin. Stokes remains at large.

According to the documents filed in this case and statements made in court: From August 2020 through March 2021, multiple individuals were involved in selling fentanyl and cocaine in an open-air narcotics market in Bradley Court Housing Complex in Newark. These individuals comprise at least two separate drug-trafficking organizations (DTOs), which have overlapping membership.

DTO-1 involved individuals engaged in the distribution of fentanyl and included Robert Covington, Smith, Williamson, Gamble, Workman, Stokes, and Alla Covington. DTO-2 involved individuals engaged in the distribution of cocaine and included Robert Covington, Williamson, Gamble, Workman, and Stokes.

The investigation revealed that Robert Covington was one of the leaders and organizers of DTO-1's and DTO-2's distribution of fentanyl and cocaine in or around Bradley Court. Covington purchased powder cocaine and fentanyl from various including sources, Smith; "cooked" powder cocaine into crack cocaine or directed others to do so; used various "stash houses" to store and distribute fentanyl and cocaine and to store narcotics proceeds; and employed multiple drug dealers,

including Workman, Williamson, Stokes, and Alaa Covington, among others, to distribute fentanyl and cocaine to the area surrounding Bradley Court.

Smith - the fentanyl supplier for DTO-1 - was also engaged in distributing heroin in and around his residence on Fairmount Avenue in Newark from at least January 2021 to the present, along with Baxter, Lane, and others.

The conspiracy to distribute and possess with intent to distribute fentanyl charge carries a mandatory minimum sentence of five years in prison, a maximum sentence of 40 years in prison, and a \$5 million fine. The heroin and cocaine conspiracy charges each have a maximum sentence of 20 years in prison and a \$1

Biden's Next Big Goal: 200 M Shots in 100 Days

After reaching a goal to hit 100 million vaccine shots in far less than 100 days, the nation's chief executive has eyes on an even loftier goal.

In his first formal press conference, President Joseph R. Biden announced on March 25 a goal to administer 200 million COVID-19 vaccine shots in 100 days. This comes after the 100 million goal was reached in just 58 days.

"I know it's ambitious, twice our original goal, but no other country in the world has even come close - not even close - to what we are doing. And I believe we can do it," Biden said.

"And today, we've made a historic investment in reaching the hardest-hit and the most vulnerable communities, the highest -risk communities - as a consequence of the virus - by investing an addition \$10 billion in being able to reach them.

"I also set a goal, before I took office, of getting a majority of schools in K through 8 fully open in the first 100 days. Now, thanks to the enormous amount of work done by our administration, educators, parents, local, state education officials and leaders - a recent Department of Education Department survey shows that nearly half of the Kthrough-8 schools are open now full time, five days a week, for in -person learning. Not yet a majority, but we're really close. And I believe, in the 35 days left to go, we'll meet that goal as

well."

Additionally, the Biden Administration is taking actions to expand vaccination availability in underserved communities and to increase funding for health care workers.

<u>AFRICA</u>

War Criminal's Conviction Upheld

On March 30, the Appeals Chamber of the International Criminal Court ("ICC" or "Court") delivered its judgments confirming, by majority, the decision of Trial Chamber VI ("Trial Chamber") of July 8, 2019, which found Bosco Ntaganda guilty of 18 counts of war crimes and crimes against humanity, committed in Ituri, Democratic Republic of the Congo, in 2002-2003. Furthermore, the Appeals Chamber unanimously confirmed the Trial Chamber's decision of Nov. 7, 2019, by which Mr. Ntaganda was sentenced to a total of 30 years of imprisonment. The conviction and the sentence are now final.

Ntaganda and the Prosecutor had appealed the verdict and Ntaganda appealed the sentencing judgment. In the hearing, Judge Howard Morrison, Presiding Judge in these appeals, read a summary of the judgments in open court in the presence of Ntaganda. Due to the COVID-19 restrictions the judgment was delivered on a partially virtual basis, with participation either from the seat of the Court, or from separate locations outside the Court.

The Appeals Chamber found that Ntaganda did not demonstrate that his right to a fair trial was violated and also determined that, in convicting Ntaganda, the Trial Chamber did not exceed the facts and circumstances described in the charges. The Appeals Chamber also rejected his challenge to the Trial Chamber's finding that the crimes for which he was found to be criminally responsible were part of an attack directed against a civilian population pursuant to, or in furtherance of, an organizational policy. It further rejected Ntaganda's challenge to the Trial Chamber's findings on indirect co-perpetration.

The Appeals Chamber also found that the Trial Chamber provided a reasonable assessment of the evidence regarding Ntaganda's knowledge and intent of the crimes of rape and sexual enslavement of individuals under the age of 15, the recruitment, conscription and use of individuals under the age of 15 in hostilities and in relation to the remaining crimes.

The Appeals Chamber also rejected the Prosecutor's grounds of appeal on the interpretation of the term 'attack' in article 8(2)(e) (iv) of the Rome Statute.

In relation to the appeal against the sentence imposed, the Appeals Chamber rejected Ntaganda's challenge to the Trial Chamber's assessment of his degree of participation in and knowledge of the crimes, including the crime of sexual enslavement and rape of civilians.

Likewise, Ntaganda's challenges to the Trial Chamber's assessment of alleged aggravating circumstances (related to the crime of intentionally directing attacks against civilians) and mitigating circumstances (including the suffering and discrimination that he had endured as a result of his experience in the Rwandan genocide) were also rejected.

Notably, with regard to the latter, the Appeals Chamber found that Ntaganda's personal experience in the Rwandan genocide could not diminish his culpability given his criminal conduct and the gravity of the crimes which he was convicted.

<u>ASIA</u>

India Makes Huge Donation

On March 27, India shipped out 200,000 doses of COVID-19 vaccines to inoculate UN blue helmets serving in peacekeeping missions.

The donated AstraZeneca vaccines left Mumbai for the Danish capital of Copenhagen, where they will be safely stored and distributed to UN peace-keepers serving in various missions.

"a Lauding India as longstanding and steadfast supporter of peacekeeping," UN peacekeeping chief Jean-Pierre Lacroix said, "an effective rollout of the COVID-19 vaccine to all peacekeepers is a key priority for the United Nations in order to protect our personnel and their capacity to continue their crucial work, help protect vulnerable communities and deliver on their mandates."

He thanked the Government and people of India for their generous donation to safeguard peacekeeping personnel and "enable them to continue their life-saving work in a safe manner."

The head of UN Operational Support, Atul Khare, said the "important donation" will ensure that UN peacekeepers remain healthy and "deliver in some of the most difficult environments in the world without relying on already stretched national health systems or ongoing COVAX efforts."

are considered "partially vaccinated" two weeks after their first dose of mRNA vaccine and "fully vaccinated" two weeks after their second dose. These new vaccine effectiveness findings are consistent with those from Phase 3 clinical trials conducted with the vaccines before they received Emergency Use Authorizations from the Food and Drug Administration. Those clinical trials evaluated vaccine efficacy against COVID-19 disease, while this study evaluated vaccine effectiveness against infection, including infections that did not result in symptoms.

"This study shows that our national vaccination efforts are working. The authorized mRNA COVID-19 vaccines provided early, substantial real-world protection against infection for our nation's health care personnel, first responders, and other frontline essential workers," said CDC Director Rochelle P. Walensky, MD, MPH. "These findings should offer hope to the millions of Americans receiving COVID-19 vaccines each day and to those who will have the opportunity to roll up their sleeves and get vaccinated in the weeks ahead. The authorized vaccines are the key tool that will help bring an end to this devastating pandemic."

One of this study's strengths is its design: participants selfcollected nasal swabs each week for RT-PCR laboratory testing, regardless of whether they had developed symptoms of illness. Researchers were able to look for evidence of SARS-CoV-2 infection irrespective of symptoms. A small number (10.7 percent) of infections in this study were asymptomatic (i.e., did not result in symptoms). However, the majority of infections (58 percent) occurred among people whose infections were identified by testing before they developed symptoms or knew they were infected. The study demonstrates that these two mRNA vaccines can reduce the risk of all SARS-CoV-2 infections, not just symptomatic infections.

This is important because preventing both asymptomatic and pre-symptomatic infections among health care workers and


other essential workers through vaccination can help prevent the spread of SARS-CoV-2 to those they care for or serve. Findings from this study complement earlier reports that these two mRNA COVID-19 vaccines can reduce both asymptomatic and symptomatic SARS-CoV-2 infections.

This study also provided positive news about partial (onedose) vaccination. The one-dose VE estimate of this study (80 percent) is consistent with other recent VE studies following the first dose of Pfizer-BioNTech vaccine among health care providers. Studies conducted in the United Kingdom and Israel showed that one dose was about 70 percent and 60 percent effective, respectively, against SARS -CoV-2 infection. The current results provide reassurance that people start to develop protection from the vaccine two weeks after their first dose. The greatest protection was seen among those who had received both doses of the vaccine.

The study was conducted through the HEROES-**RECOVER** network, a network of prospective cohorts that share a common protocol and methods. This network is part of a vaccine effectiveness surveillance system made possible by federal pandemic flu preparedness funding.

This study is the first of many planned COVID-19 vaccine effectiveness studies CDC is conducting to evaluate the benefits of COVID-19 vaccines various populations and in across different outcomes, such as preventing infections, doctor's visits, hospitalizations, or deaths. Results from these studies assist the medical and public health experts on the Advisory Committee on Immunization Practices and CDC to make important vaccine policy decisions aimed at saving lives.

Finally, in a trial study done by Pfizer, it was discovered that so far, the two-dose Pfizer-BioNTech COVID-19 vaccine has been 100% effective in children and teens. That study was done on 2,260 youngsters between the ages of 12 and 15 in the U.S. Common side effects, such as arm pain, joint pain, fatigue, and headache were consistent with those found in adults.

We thank India...(and) remain engaged with our troop and police contributing countries to ensure that wherever possible, uniformed personnel are vaccinated through their national systems prior to deployment."

At the same time, Mr. Khare's department is leading UN system-wide arrangements to support national efforts in vaccinating UN civilian personnel and family members.

India has long played an important role in peacekeeping, particularly though its contribution of troops. Currently, more than 95,000 UN peacekeepers are deployed in 12 missions.

EUROPE

Elaborate Laundering Scheme Crushed

At the request of the French authorities, Eurojust has supported an action day in Germany and Luxembourg to tackle an organized crime group (OCG) involved in the laundering of profits from illegal drugs trafficking.

Coordinated via the Agency, multiple searches took place in Germany and Luxembourg, and four suspects were arrested. Following a large-scale police deployment, bank accounts in Luxembourg linked to the OCG have been frozen and four properties, five luxury vehicles and EUR 30,000 in cash have been seized.

EQUAL HOUSING OPPORTUNITY

The OCG had set up an elaborate scheme to launder substantial sums of cash gained through the large-scale sale of cocaine in France. Eurojust coordinated an operation against the OCG, taking place this week, at the request of the Interregional Specialized Prosecution Service (JIRS) of Lille in France but which was rolled out on the ground in Germany and Luxembourg. Europol provided analytical support to the operation.

In particular, Eurojust assisted with the execution of European Investigation Orders and enabling the freezing of the bank accounts of the suspects. In Luxembourg, the action day involved about 100 Police Grand-Ducale agents under the direction of an investigating judge of the Luxembourg District Court and the Public Prosecutor's Office (PPO) at the same court.

In Germany, the operation was coordinated by the PPOs of Stuttgart, Wiesbaden and Saarbrücken with the support of the police departments of Niederbayern, Esslingen, Heidelberg and Westhessen and the State Criminal Police Office Saarland.

Budgets and Emergency Funds

The lousiest feeling in the world is that of knowing that you are broke! It impacts your freedom and the guilt trap that comes with it can be quite depressing. If you have an income, there are things one can do to avoid/and/or minimize periods of being broke.

Jim Smith earns \$6,000 a month working as an IT Operations Consultant. His bills total about \$3,000 a month. In addition, Jim provides freelance support to a business and gets paid \$1,000 a month for his services.

The following is Jim's Budget sheet monthly:

Inflows:

Salary - Consulting 6,000.00

Freelance work 1,000.00

Total Inflows 7,000.00

Outflows:

Rent 2,000.00 Utilities 600.00 Food 800.00 Transport 400.00 Entertainment 200.00

Total 3,000.00

Difference 4,000.00

With a net income of \$4,000 per month, Jim can set up a savings rate monthly. In his case, Jim is saving for a house of his own so he decides to save 50% of net income every month into a special account. In addition, Jim is building up an Emergency fund. Jim puts \$1,500 every month or 37.5% of his net income into his Emergency Fund. With expenses of \$3,000 every month, Jim would need to save \$18,000.00 to have a 6-month nest egg. A developer may contribute more than \$300 per candidate but makes himself or herself subject to the city's "fair and open process" when filing for a contract bid.

The Council's March 17 passage and Baraka's likely signing will replace the up to \$2,800 a potential contractor or developer can contribute to a candidate's campaign. A \$2,800 contributor will have to sit out from contract bidding until the next year.

The March 17 amendment, on one hand, relaxes the formerly hard and fast rule the 2011 Municipal Council had put into law. That legislation formally put Gov. Jon S. Corzine's 2008 executive order barring potentially contract bidding contractors from making campaign contributions. Newark was among the 150 municipal and county legislatures that have put the order into their legal code.

This amendment is the first granted by the council in 10 months. Newark's elders had earlier relaxed Corzine's 2008 order and their own 2011 law May 20, 2020.

The May 20 amendments included:

- Newark-focused PAC or CPCs and Essex County political party committees being exempted from "Pay-to-Play."
- "No exemption for fair and open contracts" language removed.
- \$300 individual and \$2,500

filed in this case and statements made in court: On Dec. 3, 2018, Clarke possessed a Glock .40caliber handgun loaded with nine rounds of Remington ammunition. At that time, Clarke had previously been convicted in Essex County Superior Court of resisting and eluding arrest and of possession of a controlled substance on school property, both of which are felonies.

Baraka's administrators, on Feb. 3 and March 17, have said that the latest revision makes for a more level contribution field.

"If there's a \$300 rule for lawyers, garbage companies and everybody else who has to go before the council," asked Stewart March 17, "then why are we focused on the rule for developers? If you contribute in a fair and open process, you deserve an opportunity like anybody else."

"We'll have restrictions that'll be the same as the state and other municipalities that follow the state's guidelines - no more, no less," added Pennington. "The guidelines that are in place are to ensure that there's no quid pro quo and no untoward conduct applicable to the Municipal Council."

North Ward Councilman Anibal Ramos, Jr. viewed the latest amendment as another step away from the days when Gov. Chris Christie, Corzine's successor, had sent a monitor to observe the city's financial practices in exchange for some budget-balancing state funding.

"The city was under special conditions with the state," said Ramos. "The (Baraka) administration is looking to have a law in place which'll mirror what the state contribution limits are and build some consistency."

While these rules are set to go forward, there is no particular certainty about what would happen to those redevelopers who "pay to play" off the record.



The Significance Of Biden's 200 Million Vaccine Shots In 100 Days

As of right now, there have been more than 30.3 million cas-



es of the coronavirus in the US, and even more worrying, about 550,000 deaths. Massive but horrible numbers. The coronavirus really shut down the whole world, claiming lives, businesses, and economies along the way. Now is not the time to grief, though. TRENTON - Governor Murphy has announced the expansion of eligibility for more frontline essential workers and high-risk groups in New Jersey's COVID-19 vaccination program.

Eligible groups include individuals ages 55-64, individuals with intellectual and developmental disabilities, higher education educators and staff, and communications and utility infrastructure workers among others.

"Our Administration has worked closely with communities to build an extensive vaccination infrastructure and has opened over 700 vaccination sites across the state," said Governor Murphy.

"We are already averaging approximately half a million shots per week, and with an expected increase in our federal allocation, we are confident we

can expand our vaccination program to more of our essential workers and vulnerable populations.

"Together with our community partners and a steady supply of vaccine from the federal government, we will meet - and exceed - our goal of vaccinating 4.7 million New Jersey adults."

"New Jersey's phased vaccine rollout continues to prioritize preventing severe illness and death and supporting essential societal functioning," said New Jersey Department of Health Commissioner Judith Persichilli.

"With the anticipated increased supply of vaccine, more New Jersey residents will have the opportunity to be protected against COVID-19."

Beginning Monday, April 5, the following groups are eligible for vaccination:

- Individuals ages 55-64;
- Individuals ages 16 and up with intellectual and developmental disabilities;
- Educators, including support staff, in higher education settings;
- Communications infrastructure support, including engineers, and technicians, and members of the press;
- Real estate, building, and home service workers, including construction workers, code officials, plumbers, electricians, HVAC technicians, property management, and maintenance workers;
- Retail financial institution ٠ workers, including bank tellers, lending services, public accounting, and checkcashing workers;
- Sanitation workers providing disinfection and janitorial services. city sanitation

workers; residential, commercial, and industrial solid and hazardous waste removal workers;

- Laundry service workers, • including those working in laundromats, laundry services, and dry cleaners;
- Utility workers including, electrical generation and supply system, natural gas delivery, nuclear power plant, water supply, telephone, cable/fiber/optical/ broadband/cellular service workers; and,
- Librarians and support staff at municipal, county, and state libraries.



In fact, in contradistinction to the other messages that are being proclaimed on death and dying, such as the never-dying soul or transmigration of the soul, and other views that give the impression that death is not the total destruction of all that is human, the message of the resurrection states that, that which has been completely taken away in death, will come to life, like Jesus came to life again after he rested in the grave.

Yes, the resurrection has been the most fantastic news to be proclaimed from the day it occurred and continues to be the touchstone of the Christian faith and will be so until the day of consummation. It is the message that has been doubted by many individuals and believed by authentic followers of Christ. Those who believe find it the greatest hope for the human situation in this life of death and destruction.

The proclamation began on the morning of the resurrection. As the record states, an angel came from heaven and rolled the stone away from the tomb, and Jesus came forth from the grave in his own power (Matthew 28:2), as he proclaimed at the graveside of Lazarus, "I am the resurrection and the life, anyone who believes in me shall never die." (John 11:25). "For as the Father has life in himself, so he has granted the Son also to have life in himself." (cf. John 5:26). He has "the authority to lay down his life and to take it up again." (John 10:18)

The Roman soldiers who witnessed the presence of the angel(s) (John 20:12) and the resurrection left the tomb and began to proclaim that "He is risen." But the priests and other religious leaders who had condemned him to death and sought to secure the tomb against him rising caught wind of the soldiers' proclamation and invited them in to plot a conspiracy that the disciples had stolen the body.

For the sake of the money, the soldiers recapitulated and went to Pilate with the deception, but Pilate had overheard that Christ had already risen. Though Pilate listened to the soldiers and then the priests who came with their concocted story, he was probably convinced that the resurrection must have been true. (Matthew 28)

The priest could not stop the proclamation, for there were many who had been raised as the earth quaked at the moment of Christ's death and were going throughout the streets of Jerusa-lent Crime Initiative (VCI), which was formed in August 2017 by the U.S. Attorney's Office for the District of New Jersey, the Essex County Prosecutor's Office, and the City of Newark's Department of Public Safety for the purpose of combatting violent crime in and around Newark. As part of this partnership, federal, state, county, and city agencies collaborate and pool resources to prosecute violent offenders who endanger

lem proclaiming the message. (Matthew 27:51-53)

As a side note, it is said that those who were raised then were raised to immortality, never to die again like Lazarus and others who were raised during the time of Jesus' ministry. After walking the streets of Jerusalem, they ascended with Jesus when he returned to heaven.

As the Scripture says, "Therefore He says: "When He ascended on high, He led captivity captive, and gave gifts to men." (Ephesians 4:8). These ascended ones along with Christ are referenced by the apostle Paul as "the first fruits," of death, making it clear that resurrected life is possible to all humanity.

The proclamation of the resurrection was also carried by Mary and the other women who went to visit the tomb on resurrection morning. They saw the empty tomb and the angels who informed them that the one they sought "is risen." The women then took the message and proclaimed it to the disciples who were sorrowing in the Upper Room, the place where they had celebrated the Last Supper.

Peter and John left the rest of the disciples, ran to the tomb and returned to proclaim the message to those who had stayed back what they had seen. While they were discussing the story of the empty tomb, Jesus appeared to them. Without citing the Bible references, we can find at least 13 times that Jesus appeared to the disciples and others.

He appeared to Mary Magdalene. He appeared to the womthe safety of the community.

The early Christian church formed at Pentecost (Acts 2) proclaimed that it was founded on the one fundamental teaching - that Jesus Christ rose from the dead on the third day. The proclamation became the heart of the Pentecostal message - the central theme of New Testament preaching and teaching. And it has been at the heart of the Christian proclamation through the ages. Many efforts have been made to corrupt and remove this proclamation from the center of the Christian message, but as the apostle Paul states, if there is no resurrection, "we are to be pitied" and "our faith is vain." (1 Corinthians 15:12-19)

So while I am not able to reach everyone with my encouragement, I urge all that if you want to bring meaning into your life, peace to your soul, hope to your heart, and power into your practices, you need to take with utter seriousness the biblical teaching on the resurrection. Believe it. Proclaim it. Teach it. Live it. Let your neighbors know about it because this is the only accurate answer to death and the true comfort to all humanity.

NEWARK - If a state superior court grand jury indicts you on four counts of vehicular homicide, as they have done with a Newark woman here March 26, the police will come to arrest and process you. One will stay in Newark's Essex County Correctional Facility until when or if bail is posted, regardless of the burns you suffered in the fatal car crash that started the train of events to begin with.

Nashauna N. Johnson, 20, was held on four counts of "Reckless Death by Auto/ Vehicular Homicide" until her 11 a.m. March 30 bail hearing release. Johnson is still recovering from burns, which covered 60 percent of her body from a June 11 Route 22 car crash. She also the sole survivor and driver of the accident that took the lives of her four passenger friends.

Essex County Prosecutor's Office attorneys and Newark Police Division detectives said that Johnson was driving a Cadillac CTS which left the eastbound road and went into a right shoulder guardrail before Weequahic Park at 11:11 p.m. June 11. Taylor Hill and Kamal Johnson, both 19 of Newark, died at the scene.

First responders rushed N. Johnson, Nashaun Brooks, 20, of Irvington, and Asanti McNair, 18, of Newark, to local hospitals. N. Johnson and McNair had suffered third-degree burns.

Brooks, Irvington High School's Class of 2019 Prom King, was on a Wagner College football scholarship, died by 11:57 a.m. June 10. McNair died from his injuries July 10.

Both Johnsons, Hill and McNair were students or recent graduates of Arts High School. Gov. Phil Murphy mentioned their accident in his June 11 Coronavirus Briefing because all five were heading home from a Point Pleasant Beach party that drew 1,000 people.

N. Johnson's family, on March 27, wants to know how the ECPO arrived at the vehicular homicide charges. The family asserts that the car fire was caused when the guardrail cut open a fuel line while going through the CTS' front bumper and past the chassis. An ECPO official, on March 30, said that the Cadillac was recorded as running at 93 mph before riding on and getting pierced by the guardrail.

IRVINGTON - "Irvington's Bravest" spent the pre-dawn hours of Saturday March battling a three-alarm North Ward house fire.

Although IFD personnel brought the blaze at 46 Adams St. under control by dawn, they could not keep the fire from damaging four adjacent structures and destroying two cars. High wind gusts sent embers from the two-and-a-half story wood frame house flying next door and across the street.

The first responding IFD units found the fire engulfing the house at 3:25 a.m., prompting the incident commander to pull two more alarms. Although whether 46 Adams was vacant or occupied remains unclear as of press time, there were no injuries reported.

The fire's heat melted the vinyl siding of 42, 48 and 50 Adams St. Mechanics were replacing siding at 42 Adams as of 10 a.m. March 31. One of the two burned cars and what is left of 46's garage, remained on its driveway.

46 Ådams, built in 1953, was boarded up. Two private fire investigators tacked on "Do Not Disturb" signs alongside a third on where to reroute mail.

EAST ORANGE - A respective visitation and funeral for former East Orange School District administrator Gail Smith, 65, of Montclair, has been set for 9 and 10 a.m. April 3 at Orange's Woody's Home for Services.

Smith, said daughter Bette March 26, had died after a 13day battle against the COVID-19 Novel Coronavirus. Smith served EOSD as an assistant to principals of the Ecole Touissiant Louverture and Mildred Barry Garvin elementary schools and as a Board of Education consultant on support services and parent relations 1999-2014.

Gail Annette Smith Brown was born in Montclair Sept. 25, 1955 and had graduated from Montclair High School in 1963. She had taken courses at Essex County College and ran her own My Private Collection gift basket and delivery service since 1980.

Smith found her calling as corporate and educational administrator, starting with Citibank N.A. Bank Card Membership, for 35 years. She was also information systems manager for with KMPG Peat Marwick. Smith, as of 2021, had been running her own travel consultancy since 2017.

Lucille Piggott and Sandra Mordecai remember Smith as living in their same apartment building in the 1980s. Piggott, OHS Class of 1975, is now Pennsylvania disability rights advocate Lucille Piggott-Prawl. Modecai was most recently West Orange Board of Education President.

B. Smith has established a Gofundme.com page for her mother's funeral expenses.

ORANGE - One may want to consider the life of Arthur Hugo "Art" Gubitosa, 78, who died in Randolph March 26, on whether one can take an Orange native away but not take the Orange in the native away.

Art, who was born in 1942, brothers David and Dr. Louis and sister Margaret were raised by David Sr. and Flora (Hugo) Gubitosa at 375 Jackson St. The OHS Class of 1960 graduate and Tornados football player left for George Washington University for its undergraduate studies and its Colonials gridiron. The GWU Class of '64 graduate was among the last of that university's footballers. The lack of a home field and support facilities ended that NCAA Division I program in 1966.

Art came back to Orange to become an OHS physical, health and drivers education teacher. The charter teacher of OHSA's current 1973 building was a onetime Tornados football head coach. He would meanwhile meet, date and marry another Orange native, the former Barbara Ann Sapio.

Some of Gubitosa's students remember taking their practical drivers tests while running up and down South Orange Avenue. Others may remember his helping to chaperone a field trip to the Metropolitan Museum of Art's Cloisters - until he stayed on the school bus, saying he was suffering from "Cloisterphobia."

Art and Barbara moved out to Randolph in the 1980s where they became parishioners od St. Matthew the Apostle Church. He continued coaching several community youth teams there and, until recently, worked for GAB insurance adjusters in Parsippany.

Children Dana, Kelly, Brian and Laura and three granddaughters are also among Gubitosa's survivors. His beloved Barbara, brother David and his parents predeceased him.

Gubitosa's viewing was held at the Tuttle Funeral Home March 30, followed by a Funeral Mass at St. Matthew March 31. Memorial donations may be made to www.jdrf.com.

WEST ORANGE - Mayor Robert Parisi and Nicholas Macioci, Jr. recently came to the corner of Valley Road and Nutman Place to witness it being honorarily renamed Massi Way.

If "Nick Massi" does not ring a bell, then the bass guitar illustration on the new sign, erected March 5, should provide a clue.

"Nick Massi," for the record, is the stage name of Nicholas Macioci, Sr., one of the original "Four Seasons" singers and musicians 1960-65. Macioci/Massi provided the bass guitar, his bass voice and vocal arrangements for Franki Valli, Tommy DeVito and Bob Gaudio - first as among "The Four Lovers" and, later, the Four Seasons in their 17 Billboard Top 40 hit record heyday.

Macioci, who was born in Newark Sept. 19, 1927 and grew up near Bloomfield venue and North 16th Street, moved onto Nutman Place in 1964. He and wife Margaret raised Nick, Bobby and Patty on the one-block Valley section street.

The two-story house included a recording studio for him and DeVita and, later, his own painting studio. It was here where the patriarch died from cancer com-*(Continued on page 14)*

Chorun is listed on Young Vision Africa's founder and president website as its president. YVA was created to help children and youth in Sierra Leone. His biographical entry includes his being a teacher at a Highland Park (N.J.)'s Trinity United Methodist Church and "actively attempts to reveal and deconstruct racial, environmental and institutional injustice."

Chorun, who currently shares a Stanhope address with his father, had lived here along Garfield Place, near the South Orange and Newark borders. It is not immediately known whether he had enrolled in the South Orange-Maplewood School District. He had had four other New Jersey and California addresses.

BLOOMFIELD - Outgoing Township Administrator Matthew U. Watkins has cleaned out his desk March 31, and Anthony DeZenzo has at least temporarily taken over his Municipal Building office. April 1.

Watkins, after five-and-a-half years as Bloomfield's business administrator, had put in his retirement papers Feb. 2. The Bloomfield resident ends his 35 years in public service. The Rutgers-Newark public administration graduate and lecturer had held similar posts in Clifton, South Brunswick, Delran and, for a year, Local Government Services Director in the New Jersey Department of Community Affairs.

DeZenzo was appointed acting BA by Mayor Michael Venezia and the Township Council March 25. He has previously supervised the Bloomfield Parking Utility and the township's shared services agreements with its neighbors.

It is not known whether DeZenzo will be considered by Venezia and the council as a candidate as Watkins' ultimate successor. He currently stands as the seventh Bloomfield TA since 2001, going back to when now-Nutley Mayor Mauro Tucci, Sr. was BA.

Then-Mayor Raymond McCarthy succeeded Tucci with Yoshi Menale, who lasted 17 months before his July 1, 2014 resignation. McCarthy himself and, under Mayor Venezia, Police Director Samuel DeMaio, served as interim BAs before Watkins' hiring.

The TA, who applies governmental policies to daily municipal businesses, serves at the pleasure of the mayor with the advice and consent of the council.

MONTCLAIR - That Jordan Tassy's funeral arrangements have not yet been formalized by March 31 have not kept various Montclair residents from honoring one of their own on Instagram since March 27.

Tassy, 22, had lost his two week battle with COVID at Mountainside Hospital

that Thursday morning.

The Montclair High School Class of 2016 graduate and lifelong South End resident had been running his own curbsideto-collection recycling collection service when COVID had sidelined the township's own collectors earlier this month.

"Living the mantra of John F. Kennedy, Jordan didn't ask what his community can do for him," said Councilman Peter Yacobellis March 27. "He stepped up and asked what he can do for the community. That's who we lost and it's heartbreaking."

Tassy was the leader of neighborhood friends called "The Wolfpack," whose adventures included flying drones, creating digital art and 3D printing. He started JPolo Films to produce videos and photography.

Mother Norma Tassy said that the Gofundme.com proceeds, meant for his medical expenses, will alo be put to his to-beannounced funeral. His memorial service will most likely be at the Montclair Universal Universalist Church, where he was a member.

BELLEVILLE - A township man was among five others who are accused of running an interstate fentanyl and heroin distribution ring that federal agents had recently shut down.

Hugo Richard Villanueva Torres, 29, said U.S. Southern District of New York Attorney Audrey Strauss, was among three men - two from Harrison and one from Kearny - arrested and arraigned in Newark the week prior to her March 10 announcement. The fifth man was arrested and arraigned in Riverside, Calif.

All five were arrested after a federal grand jury indicted them for sending the said narcotics over the U.S. mail May 2020 - February 2021. The investigation was launched when USPS postal investigators found a 6 kg. package of the drugs in transit.

Using USPS to transport over 400 grams of fentanyl and 1 kg of heroin, if the defendants are found guilty, may spend between 10 years and life in prison.

NUTLEY - The Nutley Volunteer Emergency Rescue Squad, an independent nonprofit institution since 1953, became the Nutley Fire Department's Emergency Services Division April 1.

Those who call for an ambulance here will see little, if any, substantial changes. Most of the same volunteer and paid help will continue to respond from 119 Chestnut St.

NVERS' assets are now township property. Its staff are answering to the NFD - and not to the dissolved squad's board of directors. Nutley, until it finds a third party, is paying bills and issuing invoices.

The above is what the township commissioners had in mind when they adopted their changeover Resolution 66-21 at their March 16 meeting. The resolution, sponsored by Public Safety Commissioner Alphonse "Al" Petracco, at State Department of Community Services' recommendation, replaces last summer's dissolution ordinance that Petracco tabled.

Petracco tabled his ordinance Aug. 17 when NVERS leadership turned over its financial records and fired then-president Jonathan Arredondo. Arredondo was accused of misappropriating and embezzling \$105,000 from NVERS accounts for two years; his trial is pending.

Orange police officer Boris Dropic, who became NVERS' last acting president since Jan. 1, remains an NFDESD volunteer.

"It's very important that we remember the Squad (NVERS) and all the wonderful good deeds they've done for the people of Nutley; it was the premier squad in the state for a long time" said Petracco March 25. "It's very unfortunate what went on up there. I thank all the volunteers and per diems who are here and all the former members."
