# GOVERNOR MURPHY LIFTS MAJOR COVID-19 RESTRICTIONS

### Face Coverings Now Optional in Most **Places Except Public Transportation**

TRENTON - Governor Phil Murphy signed Executive Order No. 242, lifting major COVID-19 restrictions and moving forward with the state's most significant reopening steps to date. Effective on Friday, May 28, the indoor mask mandate in public spaces will be lifted, as well as the six-foot social distancing requirement in both indoor and outdoor spaces, the prohibition on dance floors at bars and restaurants, and the prohibition on ordering and eating/drinking

while standing at bars and restaurants. Additionally, effective Friday, June 4, indoor gathering and capacity limits will be lifted.

Over the last two weeks, key COVID-19 benchmarks have been achieved across New Jersey, including a dramatic increase in vaccinations, and significant decreases in new COVID-19 cases, hospitalizations, spot positivity rates, and rates of transmission, solidifying

According to documents filed in the case and statements made in court: From September 2018 to December 2018, while employed as a zoning officer with TIBCD, James represented to a cooperating witness who posed as a land developer in


Due to reduction of the cases and deaths in the US, most of the states have announced they will lift the restrictions. New Jersey has announced from June 4th, California has announced from June 15th, Virginia and Minnesota from May 28th and Massachusetts from May 29th. New York state has opened business with full capacity and 24 hours without any restrictions.

Right now, summer is almost here. People can stay out and enjoy their lives. So, they should have opened without any restrictions only for outdoors, but with restrictions indoors in my opinion.

According to AP news service; "Biden in a statement said the majority of the intelligence community had 'coalesced' around those two likely scenarios but 'do not believe there is sufficient information to assess one to be more likely than the other.' He revealed that two of the 18 intelligence agencies lean toward the animal link and "one leans more toward" the lab theory, adding, 'each with low or moderate confidence.'..."The United States will also keep working with like-minded partners around the world to press China to participate in a full, transparent, evidence-based international investigation and to provide access to all relevant data and evidence," he said.

According to the Biden Administration, out of 18 intelligence agencies, only 1 came out stating that a Wuhan laboratory was liable for coronavirus leaks. the foundation for the state's sweeping reopening steps. Per Centers for Disease Control and Prevention (CDC) guidance, individuals who are not fully vaccinated - defined as two weeks after receiving the second shot of a two-dose vaccination (Pfizer-BioNTech or Moderna) or two weeks after receiving a singledose vaccination (Johnson & Johnson) - are strongly encouraged to continue masking and social distancing.

"Throughout the COVID-19 pandemic, my administration has been guided by science, data, and facts to put New Jersey on the road to recovery with the public health and safety of all New Jerseyans as our highest priority," said Governor Murphy. "Together, we have made tremendous progress in crushing this virus, and the last two weeks have shown significant decreases in key areas of our data, including new COVID-19 cases, hospitalizations, spot positivity rates, and rates of transmission. These data points, coupled with a dramatic increase in our vaccination efforts resulting in over 4.7 million New Jerseyans with their first shot, allow us to lift major restrictions and move forward with our most significant reopening steps to date."

The following changes will go into effect on Friday, May 28:

### Lifting the mask mandate in indoor public spaces.

- Businesses and entities overseeing indoor spaces will continue to have the ability to require masking for employees, customers, and/or guests.
- Per CDC guidance, masks will continue to be required in health care settings, including long-term care facilities and office-based settings, correctional facilities, homeless shelters, and on planes, buses, trains, and other forms of public transportation, as well as transportation hubs such as airports and stations.
- Additionally, also per CDC guidance, child care centers and facilities, youth summer

camps, and public, private, and parochial preschool program premises and elementary and secondary schools, including charter and renaissance schools, are not affected by this announcement and continue to be governed by existing requirements.

- Indoor worksites that are not open to the public remain governed by existing health and safety protocols that employers must follow.
- Masks will continue to be required in public-facing state offices, such as Motor Vehicle Commission agencies.

## *Lifting the six-foot social distancing requirement.*

The requirement will be lifted in businesses, including retail stores, personal care services, gyms, recreational and entertainment businesses, and casinos, and indoor gatherings, including religious services, political activities, weddings, funerals, memorial services, commercial gatherings, catered events, sports competitions, and performances.

- Businesses and entities overseeing indoor spaces can continue to require social distancing should they choose.
- Lifting prohibition on dance floors at bars and restaurants. The prohibition on ordering and eating/drinking while standing at bars and restaurants will also be lifted.

The following changes will go into effect Friday, June 4:

- Removing the general indoor gathering limit, which is currently at 50 people.
- Removing the indoor gathering limit for political gatherings, weddings, funerals, memorial services, performances, and other catered and commercial events, which is currently at 250 people.
- Removing 30 percent capacity limitation for indoor large venues with a fixed-seating capacity over 1,000.







George Floyd

On May 25, the people of Minneapolis, the United States, and the world acknowledged a somber anniversary.

That day marked one year to the day that George Perry Floyd, Jr., a black man accused of using a fake \$20 bill, was accosted by four police officers. During the dispute, now-former officer Derek Chauvin knelt on Floyd's neck for what was initially believed to be 8 minutes and 46 seconds. Later, a trial determined that the heinous act actually took 9 minutes and 29 seconds.

That nation was outraged, with protests - some peaceful and others not - everywhere; not just in the United States, but all around the world. Many made calls to defund the police, while also saying the names of other innocent black people who lost their lives, like Breonna Taylor and Ahmaud Arbery.

All of the officers were promptly fired, with Chauvin later arrested and brought up on charges of unintentional seconddegree murder; third-degree murder; and second-degree manslaughter. On April 20, 2021, the 12 jurors overseeing his trial found the disgraced 45-year-old guilty on all three counts. His bail was immediately revoked, and he was remanded into the custody of the Hennepin County Sheriff's Office.

Additionally, Chauvin and the other fired Minneapolis Police Department officers, Tou Thao, 35; J. Alexander Kueng, 27; and Thomas Lane, 38, were hit with federal civil rights crimes for their roles in Floyd's death.

In remembering the fateful day, President Joseph Biden re-

leased the following statement: "Today, in the Oval Office, I met with George Floyd's family.

"Although it has been one year since their beloved brother and father was murdered, for the family - for any family experiencing a profound loss - the first year can still feel like they got the news a few seconds ago. And they've had to relive that pain and grief each and every time those horrific 9 minutes and 29 seconds have been replayed.

"Yet the Floyd family has shown extraordinary courage, especially his young daughter Gianna, who I met again today. The day before her father's funeral a year ago, Jill and I met the family and she told me, "Daddy changed the world." He has.

"His murder launched a summer of protest we hadn't seen since the Civil Rights era in the '60s - protests that peacefully unified people of every race and generation to collectively say enough of the senseless killings.

"Last month's conviction of the police officer who murdered George was another important step forward toward justice. But our progress can't stop there.

"To deliver real change, we must have accountability when law enforcement officers violate their oaths, and we need to build lasting trust between the vast majority of the men and women who wear the badge honorably and the communities they are sworn to serve and protect. We can and must have both accountability and trust and in our justice system.

"The negotiations on the George Floyd Justice in Policing Act in Congress are ongoing. I have strongly supported the legislation that passed the House, and I appreciate the good-faith efforts from Democrats and Republicans to pass a meaningful bill out of the Senate. It's my hope they will get a bill to my desk quickly.

"We have to act. We face an inflection point. The battle for the soul of America has been a constant push and pull between the American ideal that we're all created equal and the harsh reality that racism has long torn us apart.

"At our best, the American ideal wins out. It must again."

#### **BLM Activist Shot**

A prominent Black Lives Matter activist lies in critical condition after being shot in the head.

Information is still scarce, but Sasha Johnson, 27, was shot in Peckham, London during the early hours of May 23. Police arrived on the scene after reports of gunshots in the area, and found Johnson there.

The activist was taken by ambulance to a south London hospital where she remains in critical condition. Her family have been informed and are being supported by specialist officers.

A release from the Metropolitan Police had the following: "Detectives from the Met's Specialist Crime Command (Trident) have been conducting urgent enquiries at the scene of the incident and in the surrounding area throughout the day and are pursuing a number of priority lines of enquiry.

"It is believed that the shooting occurred in the vicinity of a house where a party was taking place and that a number of people may have been in the area.

"While the investigation is at an early stage, there is nothing to suggest that the woman who was shot was the subject of a targeted attack or that she had received any credible threats against her prior to this incident.

"Officers are very keen to hear from anyone who was at the party and who has not yet spoken to police.

"Detective Chief Inspector Jimi Tele said, 'This was a shocking incident that has left a young woman with very serious injuries. Our thoughts are with her family who are being provided with support at this terribly difficult time.

'A dedicated team of detec-

tives is working tirelessly to identify the person or persons responsible for this shooting. They are making good progress but they need the public's help.

'If you saw anything suspicious in the Consort Road area in the early hours of Sunday morning or if you have heard information since that could help detectives, it is crucial that you get in touch.

'Finally, I recognise that this incident will have shocked those in the local community and further afield. I would ask people to avoid speculating as to the motive or the circumstances behind it. If anyone does have information, the most responsible and helpful action is to share it with the police or, to remain anonymous, with Crimestoppers.'"

#### Belarus Snatches Journalist

The Office of the UN High Commissioner for Human Rights (OHCHR) has strongly condemned the arbitrary detention of an opposition journalist in Belarus, calling it an "astonishing episode" that heralds a new phase in the campaign of repression against journalists and civil society there.

On May 23, Roman Protasevich was flying on a Ryanair jet from Greece to Lithuania which was forcibly diverted to the Belarusian capital Minsk, "apparently under false pretenses and with the express purpose of capturing him," said OHCHR spokesperson Rupert Colville.

The manner, through threat of military force, in which Mr. Protasevich was abducted from the jurisdiction of another State and brought within that of Belarus, "was tantamount to an extraordinary rendition," he added.

Mr. Colville said that such blatant abuse of power against a journalist for exercising his rights that are protected under international law merited the strongest condemnation possible.

Calling for his immediate release, the spokesperson de-

In other local sports news, the Irvington Blue Knights high school varsity flag foot-



New York and New Jersey that James could facilitate the acquisition of the necessary permits for the proposed rehabilitation of a certain residential property in Irvington.

The TIBCD processed the issuance of permits for construction, renovations, and alterations to building structures in Irvington in accordance with the New Jersey Uniform Construction Code, which required that contractors registered and licensed with the State of New Jersey perform certain residential construction. The TIBCD also required the seal of a licensed New Jersey contractor on building, plumbing, and electrical permit applications to issue permits. James met with the cooperating witness on two occasions, during which he accepted a total of approximately \$1,500 in cash payments from the cooperating witness.

During the meetings, James outlined a corrupt arrangement whereby in exchange for a \$1,000 payment and a further \$1,000

payment per permit, James would arrange for licensed New Jersey contractors to place their official seals on permit applications for the Irvington property. James further guaranteed that an Irvington inspector would inspect the property and grant the necessary approvals. James told the cooperating witness that the cooperating witness' payments would also be passed on to the licensed New Jersey contractors and Irvington inspector that James recruited to the scheme.

The count of attempted extortion under color of official right carries a maximum penalty of 20 years in prison and a \$250,000 fine. Sentencing is scheduled for Sept. 29, 2021.

Acting U.S. Attorney Honig credited special agents of the FBI, under the direction of Special Agent in Charge George M. Crouch Jr. in Newark, with the investigation leading to the guilty plea.

The government is represented by Assistant U.S. Attorney Tazneen Shahabuddin of the Special Prosecutions Division.

#### Investment Options: What Type Of Investor Are You? Part 1

The past year has seen the stock market move like a roller coaster! Covid. the economic downturn and now the hesitant recovery, have all influenced the stock market. The cryptocurrency market has also seen a high level of volatility.

All the above indicate that investing in the stock market is full of risks. One must be prepared with a game plan and stay the course as much as possible. Other than that, any price changes will lead to large amounts of stress and investment decisions that may not bode well for you as an investor in the long run.

It is important to determine the type of investor that you are and the goals that you have before you start investing in the financial markets. The amount of information on financial markets is at times overwhelming. The markets only seem to become more complex with time. For one thing, a lack of knowledge about financial markets would make it difficult for you to invest in a manner that would give you a positive return. In fact, if the inflation rate is higher than the interest rate on your savings account, you can lose money with time. In other words, the value of your savings would continue to fall if the inflation rate is higher than your savings rate. Let us say for example that inflation is 3.2% per annum. By subtracting the rate of return or interest on your savings from the rate of inflation, one can determine the rate at which your money is losing value.

Meanwhile your savings account is giving you a return of 2% per annum. In effect, the money in your savings account is losing value by 3.2 - 2 = 1.2% annually! This is not a situation that one would want to be in.

When it comes to investments, one principle you may want to follow is this; if you do not understand the investment, do not put your money in it. This is a basic principle that could save you a lot of stress and hopefully help you avoid losing money. When one looks at the cryptocurrency market, with its recent fall, this is an important lesson that we all need to take note of. If you do not understand the market, how can you strategically invest without losing your shirt?

The question must be asked and answered, what type of investor are you? Are you a preinvestor? This type of person has little knowledge of the financial markets and as a result does not invest in the financial markets. Passive investors on the other hand, have chosen to invest in unit trusts or funds managed by fund managers with expertise on the financial markets.

As a result, such investors do not have many decisions to make when it comes to their investments. They leave the bulk pf the decisions up to the fund manager for example. Such investments are a credible option.

scribed Mr. Protasevich's detention and the circumstances surrounding it as an "astonishing episode" that constitutes a new phase in the country's campaign of repression against journalists and civil society in general.

He explained that penalizing a journalist just for being critical of the government went against freedom of expression and is a violation of Article 19 of the International Covenant on Civil and Political Rights.

"Under human rights law, the mere act of organizing a peaceful assembly should never be criminalized under domestic laws, including counterterrorism laws, and the arrest or detention of someone as punishment for the legitimate exercise of their rights to freedom of opinion and expression and freedom of assembly, is considered arbitrary," Mr. Colville underscored.

He added that the arbitrary arrest is a sign of an extremely

worrying escalation in the crackdown of dissenting voices, not just of journalists but also of Belarusian human rights defenders and other civil society actors, including those living abroad.

The spokesperson emphasized as well that the forced landing of the Ryanair plane terrorized passengers on board and exposed them to unnecessary danger, in violation of their human rights.

#### CDC Removing The Mask Mandate Is Not The Best Move

COVID is still very much around. We are heading to summer, a period you and I know the virus is absolutely going to love - all that crowd, rubbing against each other, the virus is probably rejoicing right now.

Sooner or later, the masks have to come off. But that should only be when there's a very reasonable number of people vaccinated. Only about 39% of the population is vaccinated currently; that's impressive, considering many didn't even expect that a vaccine will be availviolence, and their loved ones, across Israel and the occupied Palestinian territories.

able by this time of the year. But is that figure enough to cause the CDC to drop the mask mandate hell no.


We need enough people to be vaccinated, upwards of 60%, I believe, before we start making these bold and unnecessary moves. That's exactly what the CDC's move is - bold, and more importantly, unnecessary. The masks are doing a job, so why remove them?

**NEWARK** - The Newark Public Schools Board of Education's reorganization meeting was a session of at least two firsts here May 4.

The full nine-member board that Tuesday night promoted Dawn Haynes from vice president to president before a live Zoom audience. She succeeded Josephine Garcia in leading the state's largest public school system in policies.

Haynes, who was sworn into her second term minutes before, became the first hijab-wearing board member to become president. A majority of participating registered city voters chose the "Moving Newark Schools Forward" runner April 20 and in 2018.

Prior to running on the fusion or unity ticket, Haynes was a Newark Anti-Violence Coalition member. The Malcolm X Shabazz High School Class of 2001 graduate was promoted from the William H. Brown Academy of the Arts. (An earlier BOE had split the magnet elementary school between the nearby Belmont-Runyon Elementary and Arts High schools around 2012 after the 1920s-era Bergen Street School building had fallen into disrepair.)

The current board, who will preside until May 2022, then selected first-term member Flohisha Johnson and the just-reelected Vereliz Santana as First and Second vice-presidents. It is the first time the board has two "veeps."

The first swearing-in dual vice-presidents had startled some virtual audience members who felt there should have been prior public discussion. Haynes said that adding a vice president was made on recommendation by New Jersey Department of Education officials.

Haynes, Velez, Asia Norton and Daniel Gonzalez - who were all elected on April 20 - were sworn into their previous or new board seats at the meeting's start. Gonzalez was elected to complete the late Octavio "Tave" Padilla's term.

**IRVINGTON** - The township's Irvington Public Schools board of education applied Holiday Inn's "No Surprises" motto and philosophy from the mid-1970s to naming their leadership for the next 12 months here April 28.

The just-reconstituted board named Richard Williams and Audrey M. Lyon as their respective president and vice president. Longtime member Williams and second-term member Lyon were similarly named for IPS' 2020-21 school year.

Board members Annette L. Beasley, Ronald J. Brown and Gloria Chison were reinaugurated at the start of that Wednesday night meeting. A majority of participating township voters re-elected the unchallenged trio April 20.

**EAST ORANGE** - A collision between a car and a pedestrian along Central Avenue's former Evergreen Arcade business district May 6 came days after a joint safety study body had labeled this city as "the eighth unsafest" in the U.S.

An EOPD report had police officers, Pulse EMS and firefighters to Central Avenue just east of its Halsted Street intersection at 8:15 that Friday morning.

The first responders found a man lying in the westbound curb lane and the driver of a late model four-door purple coupe stopped in the left lane. The car featured a starburst windshield.

While Pulse took the stricken man to a local hospital, witnesses told authorities that he had "bounced off the windshield." The man was admitted in serious condition. Rush hour traffic, including buses on NJTransit's Nos. 94 and 97 and CoachUSA's 24 A and B routes, were detoured.

Insurify, on May 1, published a study where 27.4 drivers per 10,000 in East Orange had failed to yield right of way to pedestrians, resulting in a violation, in the past year. The finding placed the city eighth - just below seventh-ranked Paterson's 28.1 per 10,000 rate.

The study, which sought to find the 20 worst pedestrian safety records among U.S. cities, was based on four million insurance applications analyzed by the National Safety Council and the Governors Highway Safety Association. New York City's Staten Island borough was ranked the worst at 53.6 per 10,000.

East Orange City Council members have had streetscape improvements made and have asked NJDOT to install curb cuts along Freeway Drive East and West flanking I-280 in recent years.

**ORANGE** - The City Council here has kept its Cannabis Based Business ban ordinance on the table for a third straight meeting May 18. It may be lifted from the table as early as its June 1 meeting - or let it die on the table.

The ordinance, 14-2021, calls for practically banning all six classes of CBB allowed by the state within city limits. The sole exception is the bill's allowance of deliveries from outside Orange within city limits.

Orange is among the state's 565 municipalities having to tell the New Jersey Cannabis Regulatory Commission if it wants CBBs on their premises or not for the next five years on or by Aug. 20. Gov. Phil Murphy started the 180-day countdown when he signed the N.J. Cannabis Regulatory, Enforcement and Marketplace Modernization Act into law Feb. 22.

"Local Talk" has been unable to find any clause in 14-2021 which would grandfather any CBBs within Orange. There is one retailer and a reported warehouse that has set up shop here since last year.

**WEST ORANGE** - Some of the township's elders and administrators are considering adding a resident or a residents committee onto the West Orange Planning Board in the wake for greater calls for transparency at the council's May 20 meeting.

Council President Cindy Matute-Brown said in that Thursday night virtual meeting that she would consider calling for the hiring of "a public planner."

Several residents logged on to air their planning concerns and specific proposal developments before Matute-Brown and her colleagues. Many came to voice their opposition to a proposed renovation and addition to a house at 410 Main St. that is up for WOPB consideration.

The site plan applicant is asking the board for permission to convert the 1878 single family house into "a five-story mixeduse building with 31 rental apartments and 1,100 square feet of retail space."

Neighbors who object to adding more residential units in town have started a "410MainStreetWO" Facebook page and a petition drive.

**SOUTH ORANGE** - There is a reason why a village resident here on the South Orange-Maplewood School District Board of Education may have refrained from voting on, or even discussing, a particular matter since May 10.

The N.J. Department of Education Ethics Commission advised the SOMSD May 10 that Elissa Maplespina be "prohibited from participating in any and all matters related to" the disposition of a 2020 lawsuit settlement between the district and the SO-MA Black Parents Workshop.


SOMSD BOE President Thair Joshua stated that the NJDOE Ethics Commission gave its advisory at the board's request for guidance. Neither Joshua nor the school board are making accusations against the first-term Malespina.

Malespina, before she was elected to the board, joined SO-MA BPW on behalf of her son. The SOMSD-BPW settlement over racial equity and access included the district's paying financial settlements to BPW plaintiffs.

Maplespina and her son received \$30,000 - \$25,000 of which she donated to the MAP-SO Freedom School. (The balance went for her son's educational expenses.)

Joshua, May 12, stressed that neither he or the board have made actuations of impropriety against Malespina, nor are say-(Continued on page 14)

#### Transforming Loneliness

Yesterday, after listening to a grandson in dialogue with my wife (his grandmother) and a mother who prayed in our early morning prayer call this morning, I must return to the subject I hear everywhere, namely loneliness.

Our grandson told his grandmother that he is just tired of the Zoom platform and did not feel like he wanted to do any more schoolwork. He said explicitly, "I feel tired and isolated from my friends." His grandmother, the retired schoolteacher, took the time to listen to him and then assured him that the school year would soon be over, and things would become better.

She reminded him that he was blessed to have his parents and brother with him. She also assured him that she was there for him and that he could call on her any day for any needed help, and that we look forward to him spending every Wednesday with us when his parents have to be attending to other activities.

Because we understand the pandemic challenges, whenever he and his brother are with us, we try to find ways of doing novel things to break any feelings of isolation. And we do our best to explain that the loneliness is not to continue forever.

changes between the warring parties that have killed more than 250 people and injured thousands.

"Going back to normal life means having to watch very carefully where we are going; unexploded devices, we know that at least one school, one of our 278 schools, where we have established two deeply buried bombs, and we have alerted the Psychologists argue that the emotional distress of being left alone acts as an alarm bell and motivates us to draw others close and hold on - literally for dear life. The children feel that they need to cling to their caregivers no matter what, or else they will be abandoned. They feel fearful, unconnected, unmotivated, powerless, and for many, it's depression.

What our grandson said and what the mother who prayed on our prayer line express is not unique. There are many people around us who are feeling a sense of loneliness. Some feel it more intensely because for more than a year now, the Covid-19 pandemic is raging. Will the passing of the Covid-19 take away the loneliness? Maybe for some persons, but for many others, the feelings will linger a long time.

The background questions for this reflection are: How does one deal with loneliness? How can I help others deal with loneliness? I am focusing on the first question, but I hope that anyone who reads the reflection might find helpful suggestions.

As we all know, every one of us deals with loneliness at varied moments in our lives, even if we are not chronically lonely, we all need some suggestions to deal with loneliness. I will present and expand on a few suggestions, but acknowledge that my list is not comprehensive or in some cases might need fuller expatiations. In any case here is what I offer.

- 1. Accept that loneliness is a normal phenomenon of life
- 2. Everyone comes to moments in our lives when we feel

- 3. Check your feelings when you feel lonely. You might not know why you feel lonely all the time, and you do not want to spend all the time checking your feelings
- 4. Avoid self-pity Self-pity can get you more lonely, isolated and depressed
- 5. Put your experiences into perspective. If you are struggling with too many negative feelings, determine what you need to do to get on the positive side.
- 6. Resist those feelings that make you rush for immediate relief from your loneliness. Hasty decisions or stop-gap solutions never work. Don't rush to form relationships that might not be helpful. Resist using drugs or other substances to overcome your feelings.
- 7. Learn how to use the moments of loneliness for personal growth. I could cite multiple examples of individuals whose loneliness helped them grow, but I will just name Jesus, who took time in loneliness each day to grow. It is said, "Big life changes are often made alone. Time in solitude leads us to realizations that might not be apparent when we're constantly with others. Having the capacity to be yourself and stand for what you believe in, even if you're lonely, is necessary if you want to go from a relationship or situation that isn't working to one that's more compatible with your needs. There's often a feeling of loneliness in between letting go of the familiar and reach-

In your lonely times, you can pray, journalize, take a nature walk, listen to the cicadas, look at the stars, do a piece of art, play an instrument and so on. There is plenty to do.

- 8. In your lonely times, find a place to volunteer and serve others. You might be surprised what your work in compassion will do for you and those with whom you share.
- 9. Find some support. You might be one of those who say, I have no friends. I find it hard to build friendships. The bible says, "A man (person) who has friends must himself be friendly, but there is a friend who sticks closer than a brother." (Proverbs 18:24 NKJV).
- 10. Find a life coach or counselor to help you battle the demons of loneliness.
- 11. Do not forget the power of prayer - there is a multitude of prayer groups all around. Join a prayer group. Praying together does not only give us access to God but helps us to find support. As you pour out your heart, somebody will hear you and help to support you. It has been true and is still true that "For where two or three gather in my name, there am I with them." (Matthew 18:20).

Remember that it is normal to feel lonely in most circumstances. But in order to avoid becoming chronically lonely, you must seek to be transformed as well as help to others who are seeking to be transformed.

**SOUTH ORANGE / MAPLEWOOD** - Civil litigation against the South Orange-Maplewood School District, its board and a former teacher at the center of a sex scandal continues as of May 14 - after criminal juris-prudence has recently run its course.

An attorney has filed a civil suit in N.J. Superior Court-Newark's Chancery Division that Friday on behalf of a former Columbia High School student who was victimized by nine-year Ninth Grade language arts teacher Nicole Dufault.

The plaintiff, now 22, was 14-16 years old, or a CHS freshman and junior, in 2013-14. He also identified himself among the six boys who Dufault, now 41, had sexual contacts within high school classrooms, in her car while parked on school property and at her apartment.

The plaintiff, in the court filings, identified himself as being videotaped by another boy while Dufault had sexual activity with him in one encounter. That recording's appearance led to a multijurisdictional investigation that led to Dufault's Sept. 18, 2014 arrest.

Damages against Dufault, SOMSD and

the two-town school board were not specified in the filings nor disclosed by the plaintiff's attorney as of May 26. The plaintiff, however, had dropped out of CHS and had suffered from panic attacks from his encounters with Dufault.

Dufault has been serving a three-year suspended sentence since a Superior Court-Newark judge's March ruling; the alternative would have been an up to five-year state prison term.

March's ruling included surrendering her teaching license. She is subject to lifetime parole supervision and registration as a sex offender under Megan's Law.

Dufault had pleaded guilty Jan. 23, 2020 to three counts of aggravated criminal sexual contact just before jury selection. Essex County Prosecutor's Office attorneys and defense lawyer Timothy Smith made the plea bargain, which included dropping 37 of the counts against her.

Born Nicole Bradley, the Bloomfield High School Class of 1997 graduate earned an education degree at now-Caldwell University. She went on to teach at Bloomfield Middle School, Ridgefield Park Jr./Sr. High School, Little Falls' Passaic Valley Regional HS and Hawthorne High before getting hired by SOMSD in 2004.

Bradley, who became Nicole Dufault in a 2007 marriage ceremony in East Orange, divorced from Drew Dufault by July 2012. They had two children.

Victims' testimony and ECPO findings have Dufault's trail of sexual misconduct starting while she was teaching in CHS summer school in 2013.

The filing plaintiff said that Dufault would invite him and other boys to her classroom. She would use her access to the SOMSD computer system to hide the boys' truancy.

It was in the classroom where Dufault and the boys would talk "about lewd and sexual actions" and where she touched "intimate parts of their bodies" before the group.

That activity, over the next 13 months said prosecutors, would spiral out to sexual encounters in classrooms, in her car and in her home. One session was held in her car while at a local fast food restaurant's lot.

Neither SOMSD nor Dufault's attorney, citing the ongoing litigation, have declined comment on the May 14 filing. It is not known whether the other five victims will also be filing suits.

# TOO MANY SHOOTINGS IN TOO MANY COMMUNITIES

On May 19, Mr. Akram Brown of Newark was shot to death in front of his business on Mt. Vernon Place in the West Ward of the city. He died at the scene, in a shooting that took place around 8 pm that evening.

"Buster," as he was known by family and close friends, was holding a 2-year-old baby when he was shot to death. He was a business owner in the city and had a candy and T-shirt shop on Mt. Vernon Place.

Akram was a believer of the Muslim faith, and believed in giving back to the community. Right after Ramadan ended, he fed the community in front of his store for all who were hungry and in need of food. Mr. Brown was also looking forward to sponsoring several children this year to play baseball with the Ivy Hill Little League, and was going to have a banner made with his business logo to be displayed on the field in Ivy Hill Park.

It's really a shame that someone would just come up and shoot him, and injure another person at the same time. Someone in the community need to say something so that his family can get the justice they deserve.

Over the past few months, there have been several shootings, robberies, and even murders in the Ivy Hill, Vailsburg section of the city. The 6th Precinct in that area is doing the best they can, but they need the residents of the community to step up, and help them whenever there is a shooting or murder. They cannot just sit back and stay silent, because the silence helps to keep the shooters and killers on the loose.

In the Central Ward on Blum Street, a young man was shot multiple times in the face around 3:30 in the afternoon. He was pronounced a few minutes later. The victim's name was Charles Pridgen, Jr., and he was 28 years old.

We are still in the spring and with all of this violence going on, it looks like it's going to be a really hot summer, which could mean that we will see a spike in shootings and murders. Because, it's been said that when the weather heats up, the crime and violence heats up. Let's hope that this is not true this year, so that the children can enjoy their summer without attending prayer vigils and memorials.

In the South Ward of the City, over 12 rounds were fired in the area of Bergen and Avon aves. The shooter fired an automatic weapon, leaving shell casings all over the area with three people being hit by gunfire. Again, someone needs to say something, because as long as the shooter is in the community the community is not safe.

The violence continues: a male was shot in an NHA development. The shooting happened at Bradley Court around 4:30 pm. If we begin to look at the times of these shootings, it leaves one to believe that there is no respect for the neighborhood or the residents, and at any given time a person can be injured because of the carelessness and recklessness of those who have guns in their possession. Let's hope that we can reach some of these people before it's too late; either they will be a victim or will become victimizers.

Shootings are not the only violent crime going on in Newark. Just the other day, a male was stabbed to death in the Ironbound section during an argument, which turned into a domestic dispute that cost him his life. He was stabbed in the neck, and died from his injuries. Then we had two stabbings on the same street in Newark.

Stabbings have begun to rise throughout the city, with many people being hospitalized or dying from knife wounds. This too is causing a lot of pain and heartache for many families, because no one expects to get a call or a knock on the door from the police, notifying a family member of the violent incident that took the life of their loved one.

So, to be fair with this story, the violence and murders are not only in Newark. In the city of Paterson, a 36 year old female was shot dead, and her body found in an alley way. In Trenton, a male was shot near 215 Coolidge Avenue. In Jersey City, there were several shootings in the past over the past few weeks, with at least one fatality. (Continued on page 15)

Usually, a mediation session lasts about 60 to 120 minutes. The cost of mediation in comparison to litigation is good value for the dollar. Most lawyers in Essex County charge between \$375 and \$500 per hour. Once begun, litigation takes on a life of its own and you have no idea when or how it will end.

You are required to adhere to court mandated rules and procedures; getting into court for a hearing could take as long as ten weeks depending on the county where you case is venued. With a mediator, you can likely schedule an appointment within a couple of weeks. You pay your attorney each time she picks up the file to speak with someone on your behalf. Many mediators work from a flat fee paid by each party. Often an agreement can be reached in three or four sessions which could result in a Consent Order which is a document for the court to sign to make the agreement official. Or a memorandum of understanding that addresses all of the economic issues of the marriage.

At the end of the day, when you ask yourself, "Why mediate?" Here are three good reasons:

- 1. Far less expensive than litigation
- 2. You control the time, not the judge
- 3. You control the solution to the problem
- 4. You will not be in court six weeks later with the same issues because studies show when the parties agree to a solution, they usually stick to the agreement.

## What's It Like At A Mediation Session?

In this very litigious and all too often disagreeable world we live in, I am always looking for ways to find solutions without the bitterness of a knock down, earth-scorching event that all too often happens in our courts. I really like the idea of mediation.

But, what's it like in mediation? Generally speaking, it is relaxed and "informally formal." Often, mediators use a round table so that there is no subtle indication that one party to the mediation is more important that the other. If you and your domineering husband are at mediation and he enters the room first and sits at the head of the table, it might give the impression that he is charge just because he is sitting at the head of the table. Everyone gets a chance to speak and to be heard.

Usually, the day's discussion revolves around the homework that has been assigned. For example, if the issue is parenting time, the mediator might want to look at how your children spend

their time. Where they attend school, how they get to school, the hours school is in session. In today's Covid world, a valid question might be does your home have sufficient internet bandwidth such that you and the three kids can all be on line at the same time? If not, what do we need to do to resolve that issue?

If the issue relates to equitable distribution of marital assets, the mediator might ask the parties to provide documentation of monthly expenses, or investments, or pension plans so that all of the parties understand what's to be divided. The mediator is a neutral. She is not on your side, but neither is she on the other person's side. Her job is to facilitate discussion and to help the parties find a solution to their problems.

Often in a relationship, one of the parties feels dominated, "unheard," or overlooked, overtalked, disrespected by the other party. Mediation is empowering. Here's why. First, the mediator gives each party a voice. The quintessential ground rule is that only one person speaks at a time and each party gets to say what he/she thinks. On the rare occasion when one party insists on "overwhelming" the other, the mediator may separate them... either in a separate room in the office or in the waiting room if the mediation is via Zoom.

The mediator may speak to each party without the other but will never reveal what is said to the other party without that party's express permission. Mediation is about solving problems. For example, during mediation, a frequently heard question is, "Why?" If you tell us "why" the

The Hon. Borrone, 81, who died May 16 in Neptune's Jersey Shore University Medical Center, was a Township Committeeman 1977-88 and was a Municimediator and the other party can better understand your position, and perhaps suggest a possible solution that satisfies your needs and to which the other side can agree. Without the "Why" question, the parties get bogged down into the "Just because..." There is no viable compromise to just because.

Compromise is a win-win. Compromise is not I win/you lose. You have to give to get. For example, if the issue is dividing marital assets and liabilities, one party may decide that they will give up what they might be entitled to in terms of wife's pension in exchange for her accepting less of the proceeds when the house is sold. Or, one party might decide to accept less child support than the law would ordinarily give in exchange for permission to relocate out of the state in two years if they can work out a visitation scheduled.

Because you can do anything that is legal in mediation rather than do what a judge decides is best for you, mediation is empowering. You have control over how your problem is solved. You are not stuck with what the court would do, or some cookiecutter solution, but are free to act in what you believe to be your best interest. For example, I once had a couple who both wanted residential custody, but neither could make a reasonable plan without changing employment. So, they decided to share joint legal custody. They would pay support to Wife's mother to keep the children during the week, and they would alternate weekends with the children. This way, they could say that they were "co-parents" with fifty-fifty par-

Second wife Lillian and two grandchildren are also among his survivors.

Edward Jerrome Borrone was born in Weehawken July 23, 1939 to Ed., Sr. who was a Hoboken Councilman and the Hudson County Clerk in the 1950s. The St. Peter's Prep graduate parlayed his baseball scholarship for the St. Peter's College Peacocks and recruitment by MLB's Minnesota Twins. The Twins' failure to offer a bonus prompted Borrone to successfully obtain a juris doctorate from Newark's Seton Hall Law School.

Borrone's Funeral Mass was held May 22 at St. Teresa of Calcutta Parish's Church of the Ascension, in Bradley Beach. St. Peter's Prep has started a memorial scholarship in his name.

**BLOOMFIELD** - If the walls of 209 Franklin St., better known as Essex County Bloomfield Tech High School, could talk, would they be asking itself whether it is having an identity crisis? Or maybe they will be expressing relief that they are being used at all?

The 1930 vocational and technical high school is being used as a temporary site for another county district student body for the third time in four years.

Although the 2,000-student capacity building ceased being Bloomfield Tech June 30, 2018, it had been used to house students of Essex County School of Technology-West Caldwell when the latter's building was being renovated and expanded in 2019-21. The West Caldwell sign remains above Bloomfield Tech's front door May 24.

Bloomfield Tech has been housing three of Newark Tech's four grades here since May 17 and will continue to do so through 2021-22. An announcement on Newark Tech School of Technology's digital sign board at 91 W. Market St. says as much.

Although Newark Tech is the county district's youngest building, it will be undergoing renovations during the next school year. All Newark Tech sophomores, juniors and seniors are to report or log into their new address in Bloomfield.

Newark tech's freshman class, however, will be attending the district's newest campus - the Donald M. Payne, Sr. School of Technology at Newark's 498-544 W. Market St - which brings this story to a full circle. "Payne Tech," which opened Sept. 1, 2018, was the merger of Bloomfield Tech and Newark's 13th Street Tech high schools.

The Bloomfield Tech building is being used as a "swing space," where the student body continues its instruction while its home building is being renovated, expanded or replaced. The Newark Public Schools. for example, intended to use its World War One-era Central High School building before selling it to NJIT.

**MONTCLAIR** - Parents of Montclair Public School elementary students are to look for a survey about holding full-time in-person classroom instruction in their mail June 1 - and to return their responses to MPS administrators soon.

Schools Superintendent Dr. Jonathan Ponds, in his May 21 open letter, said that his staff are working on such a survey. While he nor his administration have not made a gp/no-go full-time elementary inperson decision as of press time, this 2020 -21 school year will end June 30.

"We'll evaluate variables such as; proper spacing, furniture and restructuring physical spaces," said Ponds in his Friday open letter. "We're also contemplating implementing a five-day option for Tier II and III students and those with 504s. Please know that once variables are considered. we'll implement five days based of efficiency, safety and equity in all schools."

The letter comes while MPS is opening more of its classrooms to all students. Montclair High School has reopened to Sophomores May 26, who are to be joined by juniors and seniors June 1.

**GLEN RIDGE** - While other "Local Talk" towns weigh the merits of having Cannabis Based Businesses in their municipalities between now and Aug. 20, borough elders have taken their stand for the next five years.

Mayor Patrick Stuart signed into law May 1 an ordinance passed by borough council members April 12 that bans all CBBs now through April 2026. The ordinance does allow such businesses from outside Glen Ridge borders to make deliveries within borough limits.

Councilwoman Ann Marie Morrow cited both Glen Ridge's limited commercial district and borough leaders' wait-and -see attitude with the state regulations for their decision.

"This gives us the option to think about it," said Morrow. "We're a fully built-out, residential town (with) a very small retail section. We don't have a lot of room, so we want to be thoughtful about it."

Glen Ridge joins 15 other statewide municipalities in closing, but not bolting, their doors to CBBs. Orange and Nutley are contemplating similar bans; other "Local Talk" towns are discussing the matter.

**BELLEVILLE** - Township detectives have been looking for two cars and three suspects - two of them armed - in a carjacking on a major street here since May 13.

The owner-driver of an Audi A4 told responding Belleville police officers that he was along the 35 block of Washington Avenue when a "blue BMW X7" pulled up alongside him at about 8 p.m. that Thursday.

The victim then said that two suspects armed with guns got out and took control of the Audi. The Audi and the BMW then sped away, leaving the first driver physically unharmed.

Further descriptions of the three suspects, either car or which direction they had fled were not released as of press time.
