

## FAVORITIES WIN PRIMARIES

**NEWARK** - Participating registered Democratic and Republican party voters nominated their respective General Election candidates by mostly wide margins so far June 8.

Democrats and Republicans throughout Essex County, for example, more than helped place incumbent sheriff Armando B. Fontoura and challenger Nicholas G. Parsini on Nov. 2's General Election ballot.

Fontoura, seeking his 11th term, won his nomination over two challengers by over a threeto-one ratio. Parsini received a four-to-one plurality over his challenger.

There were many party nominations on the state and municipal levels, however, where the party-backed incumbents and/or challengers received 100 percent of their

The following results, as of 12:01 a.m. June 9 remains unofficial by County Clerk Chris Durkin. Durkin and County Board of Elections Superintendent Linda von Nessi are holding off certifying the results for traditional and nontraditional reasons.

Postponing certification for 14 days, ending on June 22, allows time for any challenges or recounts. Durkin and von Nessi are granting Vote By Mail Ballots postmarked June 8 to make it into their Essex County Hall of Records offices on or by June 14 for counting.

The following figures, while also lacking to-be-counted absentee and provisional ballots, will meanwhile provide readers with some voting trends to consider.

#### GOVERNOR / LT. GOVERNOR

Incumbent Democrats Phil D. Murphy and Sheila Y. Oliver challenging Republican Jack Ciattarelli have been nominated by their respective county and statewide party voters to contest each other on the Nov. 2 General Election ballot.

Gov. Murphy, of Rumson, and Oliver, of East Orange, received all 33,664 countywide Democratic votes as of 11:57 p.m. Tuesday. Votes for write-in challenger Linda McCormick, of Rahway, were not immediately released.

Murphy and Oliver are seeing their second - and last terms. State law limits them to a pair of consecutive terms.

A majority of Republican party voters in the state and county meanwhile chose Ciattarelli over three other balloted candidates.

Ciattarelli, of Hillsborough, was Tuesday's top county votegetter at 4,386 votes or 55.72 percent of the vote. Philip Rizzo came in second-best at 1,963 or 24.94 percent.

Hirsh V. Singh came in third countywide at 1,353 or 17.19. Brian D. Levine rounded out the balloted field at 169 or 2.15.

#### STATE LEGISLATURE

27 Legislative District (South Orange, Maplewood, West Orange, five "West Essex," six Morris County Municipalities.)

State Senate

Essex County Democratic voters gave all 8,393 of their votes to incumbent Sen. Richard Codey, of Roseland. Republican voters meanwhile gave all of their 1,975 votes to West Orange's Adam Kraemer.

General Assembly (Two Seats Per LD)

Democratic voters renominated John McKeon and Mila Jasey.

McKeon, of West Orange, mustered 8,753 or 50.26. Jasey, of South Orange, drew 8,167 or 49.74.

Republican district voters gave an edge to Kevin Ryan over fellow Millburnite Jonathan Sym. Ryan registered 1,964 for 50.06. Sym received 1,959 for 549.94.

Democratic voters helped incumbent Ronald L. Rice handily turn back Quadir Selby's challenge.

Rice, of Newark, drew 7,487 or 91.96 percent of the vote. Selby, of Irvington, received the other 655 or 8.04 percent. Republican voters gave all of their 1,338 votes to Nutley's Frank Contella.

Assembly

Democratic voters here returned incumbents Cleopatra Tucker and Ralph Caputo onto the general Election ballot.

Tucker, of Newark, was top vote-getter at 7,856 or 50.97 Caputo, of Bloomfield, carried 7.558 for 49.03. Republican voters gave their nod to Anthony D'Angelo over Monique Headen. D'Angelo drew 1,295 for 51.25. Headen tallied 1,232 for 48.75.

Senate

District Democrats handed the steamroller keys to incumbent Sen. M. Teresa Ruiz Tuesday. Ruiz, of Newark, garnered all 5,502 district party votes. The Essex Republican Party Organization did not field a candidate here.

Assembly

Democratic voters nominated or renominated incumbent Newarkers Shanique Speight and Eliana Pintor Marin for November's ballot.

Speight, seeking her first full term, amassed 5,233 for 50.70. Pintor Marin mustered 5,089 for 49.30. There were no Republican candidates fielded.

#### DOJ Reclaims Some Ransomware Money

After one of the most brazen hacks in history, federal authorities acted to ensure that it was not a complete success for the criminals involved.

On June 7, the Department of Justice announced that it has seized 63.7 bitcoins currently valued at approximately \$2.3 million. These funds allegedly represent the proceeds of a May 8, ransom payment to individuals in a group known as DarkSide, which had targeted Colonial Pipeline, resulting in critical infrastructure being taken out of operation. The seizure warrant was authorized by the Honorable Laurel Beeler, U.S. Magistrate Judge for the Northern District of California.

"Following the money remains one of the most basic, yet powerful tools we have," said Deputy Attorney General Lisa O. Monaco for the U.S. Department of Justice. "Ransom payments are the fuel that propels the digital extortion engine, and today's announcement demonstrates that the United States will use all available tools to make these attacks more costly and less profitable for criminal enterprises. We will continue to target the entire ransomware ecosystem to disrupt and deter these attacks. Today's announcements also demonstrate the value of early notification to law enforcement; we thank Colonial Pipeline for quickly notifying the FBI when they learned that they were targeted by DarkSide."

"There is no place beyond the reach of the FBI to conceal illicit funds that will prevent us from imposing risk and consequences upon malicious cyber actors," said FBI Deputy Director Paul Abbate. "We will continue to use all of our available resources and leverage our domestic and international partnerships to disrupt ransomware attacks and protect our private sector partners and the American public."

"Cyber criminals are employing ever more elaborate schemes to convert technology into tools of digital extortion," said Acting U.S. Attorney for the Northern District of California Stephanie Hinds. "We need to continue improving the cyber resiliency of our critical infrastructure across the nation, including in the Northern District of California. We will also continue developing advanced methods to improve our ability to track and recover digital ransom payments."

On or about May 7, Colonial Pipeline was the victim of a highly publicized ransomware attack resulting in the company taking portions of its infrastructure out of operation. Colonial Pipeline reported to the FBI that its computer network was accessed by an organization named DarkSide and that it had received and paid a ransom demand for approximately 75 bitcoins.

As alleged in the supporting affidavit, by reviewing the Bitcoin public ledger, law enforcement was able to track multiple transfers of bitcoin and identify that approximately 63.7 bitcoins, representing the proceeds of the victim's ransom payment, had been transferred to a specific address, for which the FBI has the "private key," or the rough equivalent of a password needed to access assets accessible from the specific Bitcoin address. This bitcoin represents proceeds traceable to a computer intrusion and property involved in money laundering and may be seized pursuant to criminal and civil forfeiture statutes.

The Special Prosecutions Section and Asset Forfeiture Unit of the U.S. Attorney's Office for the Northern District of California is handling the seizure, with significant assistance from the Department of Justice Criminal Division's Money Laundering and Asset Recovery Section and Computer Crime and Intellectual Property Section, and the National Security Division's Counterintelligence

and Export Control Section. The Department components who worked on this seizure coordinated their efforts through the Department's Ransomware and Digital Extortion Task Force, which was created to combat the growing number of ransomware and digital extortion attacks.

The Task Force prioritizes the disruption, investigation, and prosecution of ransomware and digital extortion activity by tracking and dismantling the development and deployment of malware, identifying the cybercriminals responsible, and holding those individuals accountable for their crimes. The Task Force also strategically targets the ransomware criminal ecosystem as a whole and collaborates with domestic and foreign government agencies as well as private sector partners to combat this significant criminal threat.

#### **CANADA**

#### Seeking Justice For Over 200 Children

Independent UN human rights experts have urged Canadian authorities and the Holy See of the Catholic Church to conduct prompt "full-fledged investigations" into a mass grave found in British Columbia containing the remains of over 200 children at a residential school for indigenous students, who had been forcibly taken from their homes.

They called on the authorities to probe "the circumstances and responsibilities surrounding these deaths, including forensic examinations of the remains found, and to proceed to the identification and registration of the missing children."

"The judiciary should conduct criminal investigations into all suspicious death and allegations of torture and sexual violence against children, hosted in residential schools, and prosecute and sanction the perpetrators and concealers who may still be alive," said the experts.

The children's remains were found at the Kamloops Indian Residential School, run by the Catholic Church from the late 19th century to the 1960s, which

was then taken over by the federal government, and later closed in the 1970s.

It was part of the indigenous residential school system that between 1831 and 1996, hosted over 150,000 children in 130 schools - many run by the Catholic Church or the Canadian Government.

The 2015 report of Canada's Truth and Reconciliation Commission determined that aboriginal children were subjected to abuse, malnutrition and rape and that at least 4,000 died of disease, neglect, accidents or abuse, while at these schools.

"Large scale human rights violations have been committed against children belonging to indigenous communities, it is inconceivable that Canada and the Holy See would leave such heinous crimes unaccounted for and without full redress," the UN experts said.

They further called on the Government to fully implement the recommendations contained in the 2015 Report.

"For far too many years, victims and their families have been waiting for justice and remedy. Accountability, comprehensive truth, and full reparation must be urgently pursued," the human rights experts underscored.

#### WORLD

#### 800 Suspects, 32 Tons of Drugs, 16 Countries

An ambitious project from various law enforcement agencies has netted one of the largest hauls of suspects and contraband in history.

Officials from the Federal Bureau of Investigation (FBI) and Australia's Federal Police teamed up to create a phony encrypted device company to trick crooks into thinking they had a means to conduct their illegal business covertly. They were wrong.

Over the course of three years, authorities monitored their activity during a project called "Operation Trojan Shield" - or "Operation Ironside" in Australia - before finally dropping the net and bagging over 800 sus-

pects, most of them in mafia-based groups.

The app ANOM was installed on mobile phones that were stripped of other capability. The mobile phones, which were bought on the black market, could not make calls or send emails. It could only send messages to another device that had the organized crime app. Criminals needed to know a criminal to get a device.

The devices organically circulated and grew in popularity among criminals, who were confident of the legitimacy of the app because high-profile organized crime figures vouched for its integrity.

"The FBI, with our international partners, will continue to adapt to criminal behavior and develop novel approaches to bring these criminals to justice," said FBI Agent Anthony Russo. "We appreciate our long standing partnership with the Australian Federal Police in the fight against transnational organized crime."

"AN0M was an influential encrypted communications app but there are even bigger encrypted platforms that are being used by transnational and serious organized criminals targeting Australia," said AFP Commissioner Reece Kershaw.

"They are almost certainly using those encrypted platforms to flood Australia with drugs, guns and undermine our economy by laundering billions of dollars of illicit profit.

"Organized crime syndicates target Australia, because sadly, the drug market is so lucrative. Australians are among the world's biggest drug takers.

"One of the causes behind domestic violence, sexual assault, neglect of children and unspeakable tragedy, is illicit drugs.

"Our first responders, our teachers and every Australian should be able to go to work and live in our communities without being harmed by an individual under the influence of dangerous drugs."

In all, at least 800 suspects were brought in, along with 32 tons of drugs, \$148 million in various currencies, 250 firearms, and 55 high-end vehicles from 16 countries, including New Zealand, Sweden, Finland, and others.

#### Congo Still Reeling From Volcano

The UN Children's Fund (UNICEF) and partners are working to restore water supply to roughly 200,000 people, including some 100,000 children, affected by the volcanic eruption last month in Goma, in the eastern Democratic Republic of the Congo (DRC).

damaged a huge 5,000m3 reservoir, the agency said on June 7.

Without access to safe water and sanitation, children and families are at heightened risk of waterborne diseases, such as cholera.

"Cholera is particularly dangerous for the very young, the very old and the undernourished, so an outbreak could have disastrous consequences for children," said In Hye Sung, UNICEF emergency specialist.

"Children under age 5 have the highest incidence of cholera and are more likely to die from it, so it's critical we ensure that families have access to safe water as soon as possible."

Thirty people were killed and some 3,500 others lost their homes due to the volcano eruption.

In the wake of the crisis, scores of people fled Goma for neighboring towns, either because their homes were destroyed by lava or the authorities advised them to leave over fears of another eruption.

Together with domestic and international partners, UNICEF is working on the water issue, including through supporting the Stateowned water company to redirect and protect a by-pass piping system that will send supply from the pumping station next to Lake Kivu, into part of the water system.

As previous cholera epidemics in Goma started when residents collected dirty contaminated water for drinking, UNICEF has installed 15 emergency station chlorination points close to the lake.

## NEW JERSEY'S PUBLIC HEALTH EMERGENCY ORDER LIFTED

TRENTON - With all COVID-19 capacity restrictions on businesses and gathering limits having been lifted due to the continued improvement of New Jersey's public health metrics, Governor Phil Murphy has signed legislation (A5820/S3866) enabling the end of the COVID-19 Public Health Emergency that has been in place since March 9, 2020.

Immediately following the signing of the legislation, Governor Murphy signed Executive Order No. 244, ending the COVID-19 Public Health Emergency. Under the legislation, the majority of executive orders issued pursuant to the Public Health Emergency will expire 30 days from June 4.

The legislation, which was negotiated with legislative leadership and sponsored by Senate President Steve Sweeney and Assembly Speaker Craig Coughlin, allows for the termination of the Public Health Emergency while also allowing the Administration to retain the tools necessary to manage the ongoing threat posed by the pandemic.

Specifically, the Administration is authorized to issue orders, directives, and waivers under the authority in the Emergency Health Powers Act that are related to vaccination efforts; testing; health resource and personnel allocation; data collection, retention, sharing, and access; coordination of local health departments; and implementation of any CDC recommendations to prevent the transmission of COVID-19. This authority lasts until January 11, 2022, and can be extended for 90 days with the passage of a concurrent resolution by the Legislature.

"Today's lifting of the COVID-19 Public Health Emergency is a clear and decisive step on the path toward normalcy," said Governor Murphy. "The past 15 months have been a challenge, and I thank every New Jerseyan who stayed home, masked up, took precautions to keep this virus in check, and got vaccinated for allowing us to get to this point. I also thank the Senate President and the Speak-

er for working with us to responsibly end the Public Health Emergency and meet the challenges ahead."

The legislation keeps the following 14 executive orders in place until January 1, 2022, though they can be modified or rescinded prior to that date by the Governor (See https://www.state.nj.us/governor/news/news/562021/

approved/20210604b.shtml for details on each):

Further, any administrative orders, directives, or waivers that relied on the existence of the public health emergency, including Department of Health orders that govern vaccinations and testing, are extended until January 11, 2022. The Governor is authorized to seek a further 90 day extension of such orders, directives, or waivers, which can be granted by a concurrent resolution passed by the Legislature.


The legislation also states that while the State of Emergency declared in Executive Order No. 103 shall remain in effect, the previous seven-day requirement for Open Public Records Act (OPRA) responses will be restored for records unrelated to the COVID-19 response. Additionally, civil and criminal immunity given to health care professionals and facilities, including long-term care facilities, and existing waivers of regulations involving staffing ratios, overtime, shifts, and vacation time will expire on September 1, 2021. Civil immunity for health care professionals shall continue beyond September 1, 2021 only for individuals specifically engaged in vaccinations or testing related to COVID-19.



#### Inflammation Of The Heart And The Covid Vaccine

Well, well, well...

There's a developing story in the COVID vaccine saga. As it turns out, many researchers worldwide are drawing up links to inflammation of the heart, myocarditis, and the COVID vaccine. When I say the COVID vaccine, what I actually mean is the second dose of the vaccines that work on mRNA, which are the Pfizer and Moderna vaccines.

It may have started as isolated reports, but the major agencies in the world are beginning to pick up on it, so it's not just something to dismiss or neglect. According to the Israeli Ministry of Health, the condition is commonest among men between the ages of 16 and 24. Women get them too, but only in rare cases.

Before I continue, let me quickly review what myocarditis is. Myocarditis is the inflammation of the middle layer of the heart wall. It is usually caused by a viral infection, although bacterial infections have also been implicated. And since we're talking about viral infections, there should be one that springs to mind. Hint - it's the same bastard virus that has claimed the lives of close to 4 million over the last year and a half. 4 million!

A severe case of the condition can lead to heart failure, abnormal heartbeat, and sudden death. Luckily for us and everyone else that has developed the condition, the kind of myocarditis caused by the virus is mild, and that usually resolves after a few days or a couple of weeks, at most.

Back to the report. According to researchers, the condition occurs between 1 in 3000 and 1 in 6000 men. That looks worrying, if I'm being honest. However, reports from the CDC in the United States and the European Medicines Agency have quenched concerns about the prevalence rate, stating that the actual number is closer to 1 in 175,000 doses of the vaccine.

It is yet to be confirmed why and how exactly the vaccine is linked to the heart condition. It may have something to do with the mRNA technology, which I should remind you has never been used before in any vaccine until the coronavirus. And it may also have something to do with

the spacing of the second dose of those vaccines.

As it seems, many countries are resorting to delaying the vaccine's second dose up to even months, as opposed to the regular two to three weeks. It will take time to be sure of the exact effects of this measure. There's also the added advantage of more people getting one shot from the vaccine, which will, to a very reasonable level, slow down the spread and progression of the virus.

Pfizer themselves have come out to also reassure the public, stating that there are always continual tests to ensure that the vaccines are safe as possible and to identify any possible side-effects, whether short-term or long-term. So, there's that.

There's also the CDC and the EMA working round the clock to ensure that the vaccine is indeed as safe as possible. In fact, these bodies don't believe it is anything to raise eyebrows about because there are still few confirmatory tests to confirm that the condition is absolutely linked to the vaccines.

All of this news and worries coming up are daily reminders that the vaccine is not perfect. No vaccine ever is, but even more so for one whose development was greatly accelerated. However, to date, there's been nothing to worry about, except, of course, people not wanting to take them.

Stay safe. Wear a mask. Take the vaccine, please.

#### **CARIBBEAN**

#### Newark Airport Smuggler Foiled

A Jamaican man admitted on June 8 that he smuggled approximately 2.8 kilograms of cocaine into the United States, Acting U.S. Attorney Rachael A. Honig announced.

Perez Omar Gibbs, 38, of Trelawny, Jamaica, pleaded guilty by videoconference before U.S. District Judge Katharine S. Hayden to an information charging him with one count of importation of controlled substances.

According to documents filed in this case and statements made in court: Gibbs arrived at Newark Liberty International Airport aboard a flight from Montego Bay, Jamaica. Law enforcement officers discovered

that Gibbs possessed approximately 2.8 kilograms of cocaine concealed inside two bags of coffee and four picture frames.

The count with which Gibbs is charged carries a mandatory minimum penalty of five years in prison, a potential maximum penalty of 40 years in prison and a maximum fine of \$5 million. Sentencing is scheduled for Oct. 20, 2021.

Acting U.S. Attorney Honig credited special agents of the U.S. Department of Homeland

Security, Homeland Security Investigations, New Jersey Division, under the direction of Special Agent in Charge Jason J. Molina; and officers of U.S. Customs and Border Protection, under the direction of Marty Raybon, Acting Director of Field Operations, New York Field Office, with the investigation leading to the guilty plea.

The government is represented by Assistant U.S. Attorney Jonathan Fayer of the Economic Crimes Unit in Newark.

NEWARK - An out-of-court federal whistleblower lawsuit settlement against the city, Mayor Ras Baraka and Amiri "Middy" Baraka, Jr. by a former city corporate counsel attorney may be before the Municipal Council as early as their 6:30 p.m. June 16 meeting.

What the council will consider approving or rejecting is a settlement reached in late May between Willie Parker's attorney, Ty Hyderally, and lawyers Michael Critchley and Raymond M. Brown, Jr., who respectively represented Mayor and Amiri, Jr.

Parker, who had also been Newark's Chief Municipal Judge, filed the suit in U.S. Federal Court June 23, 2017. Parker and Hyderally, in their filings, asserted that the former's refusal to approve a new multi-million dollar DPW garage in mid-2016 "reveal an alarming picture of a mayor and governmental entity run riot with retaliatory animus."

Parker, while City Corporate Counsel, refused to sign off on the contract, declaring that one of its provisions "would result in the city losing millions of dollars while simultaneously benefitting private commercial interests."

Parker, in the filings, said that Amiri, Jr. first told him on Aug. 23, 2016 that he had to sign and execute the contract for "purely political reasons." Parker then called Mayor Baraka to explain why he would not sign.

Amiri, Jr and his armed security detail arrived at Parker's residence later that afternoon. The mayor's then-chief of staff asked why he "had snitched to the Mayor" and "commanded him to

return to City Hall" to then tell Mayor Baraka that "he didn't hear what he thought he had heard or had misunderstood."

Parker added that he was under intimidation and surveillance the next few weeks, leading to his October heart attack. He resigned by Dec. 31. The settlement details were being finalized as of press time.

**IRVINGTON** - Mayor Anthony "Tony" Vauss and Council President Renee C. Burgess may have given a Memorial Day weekend present to township property owners by promising no new municipal property tax increases for 2021 and 2022.

Vauss, in his May 27 announcement here at the Municipal Building, cited the financial hardship many Irvingtonians including financial - during the now-16-month long global COVID-19 pandemic for his no property tax increase on the 2021 and 22 Municipal Budgets.

The mayor called the twoyear halt "unprecedented," recalling that his administration and the council also had a zero tax increase on their 2019 municipal budget. Vauss hailed working with Burgess and the council for the freeze.

Details on how the CY 21 and 22 budgets' increased expenses would be compensated, however, were not available.

Vauss and Burgess' two-year promise only applies to their part of the quarterly tax bills Irvington property owners will receive. They are the collecting agency for Irvington Public Schools and Essex County - who set their own tax rates.

#### **EAST ORANGE / ORANGE -**

Multiple authorities, from the East Orange Police Department to the FBI, are looking for the couple who robbed the PNC Bank branch at the Brick Church Shopping Plaza in broad daylight May 19

Personnel at 565 Dr. Martin Luther King Blvd. told arriving EOPD officers and, later, FBI Newark Office detectives that a man and a woman had entered the branch midafternoon that Wednesday and demanded monAlthough the city's dispatch officer sent officers upon reception of the bank's silent alarm call, the couple had fled before the six EOPD officers and detectives arrived. The bank was closed for the rest of the day, prompting customers to go to the PNC Orange Branch at 410 Main St. or other nearby branches.

The Brick Church Plaza branch robber comes while PNC has its contractors building a new branch two blocks west at 23 Main St., Orange. Brick Church Plaza is to be replaced in stages by The Crossings at Brick Church residential/commercial complex later this year.

Wanted is a 5-ft., 11-in. Caucasian man and a 5-ft., 3-in. Caucasian female. Both were wearing hooded pullover sweatshirts during the crime.

Further details - including whether they had used a weapon during the robbery and the amount of money taken - were unavailable as of June 8.

WEST ORANGE - Township and state authorities are investigating the circumstances that led to a fatality of a Newark teenager here along Interstate 280 East Sunday.

State Police Sgt. First Class Lawrence Peele said that his Totowa Barracks dispatcher received reports of 'a crash with injuries" at 280-East Milepost 9.8 at 1:15 p.m. Sunday. West Orange's police dispatcher received those calls simultaneously.

When WOPD officers and State Troopers arrived, they found a Hyundai Genesis partly on the concrete center divider and partly in the left lane - and pointing against oncoming traffic.

Law enforcers also found a debris field across all four lanes of traffic - and two males who were ejected from the Genesis. There was also a damaged Honda Pilot SUV nearby.

One man - identified as Hyundai passenger Jose Ward, 18, of Newark - was admitted to Newark's University Hospital in serious condition. The Genesis' driver - identified as Shakur Young, 17, of Newark - was de-

clared dead at the scene.

A preliminary NJSP investigation has the Genesis striking the Honda and partially overturning onto the center divider. Investigators later learned that the Hyundai was reported as stolen from Madison.

All eastbound traffic was detoured at Exit 9 - Mt. Prospect Avenue for nearly four hours until the field investigation and cleanup were finished.

**SOUTH ORANGE / MAPLE-WOOD** - County and township authorities are searing for the killer or killers of a Columbia High School scholar-athlete and the wounding of one of his classmates here at Maplewood's Underhill Field June 6.


Family, classmates and friends of Moussa Fofana, 18, within and beyond the South Orange-Maplewood School District community are meanwhile mourning their loss. That mourning extends to Fofana's family members in Pennsylvania and Liberia. Gov. Murphy mentioned the gun violence incident in his daily briefing Monday.

Maplewood Police Chief Jimmy DuVaul said some of his officers responded to residents' 9:38 p.m. Sunday calls of gunshots coming from the Underhill Sports Complex, 58 Burr Rd. They arrived to find two people suffering from gunshot wounds at or on the property; a few residents also told MPD officers and the Essex County Prosecutor's Office Homicide Task Force detectives of seeing "several juveniles running" from the area.

One man, identified as Charles Obiagwu, 18, was rushed to Newark's University Hospital for SOMSD "treatment of a non-life-threatening gunshot" to one of his legs. Obiagwu is a linebacker on the Columbia High School football team.

The other man - Fofana - was pronounced dead at the scene by 10:24 p.m. Fofana was a player on the CHS Cougars soccer team and was pursuing a career in a professional league.

Fofana, who was born in New York and had lived with his grandfather in Monrovia, Liberia for six years, rejoined mother (Continued on page 15)

"All ships that land at the shore of grace weigh anchor from the port of sin. We must start where God starts. We won't appreciate what grace does until we understand who we are. We are rebels. We are Barabbas. Like him, we deserve to die. Four prison walls, thickened with fear, hurt, and hate, surround us. We are incarcerated by our past, our low-road choices, and our high-minded pride. We have been found guilty.

#### **MUNICIPAL**

Democratic party faithful voters in East Orange and Maplewood endorsed their mostly-incumbent candidates Tuesday. Their results, pending any unanticipated independent or write-in campaigns, may make their Nov. 2 General Elections more like coronations.

In EAST ORANGE, The ECDC-endorsed Team Green rolled on to their unopposed party nominations. Theodore "Ted" Green, who is seeking his third term as mayor, drew all 3,283

votes so far.

Respective First-Fifth Ward Council candidates - Christopher James, Christopher Awe, Bergson Leneus, Tameka Garrett-Ward and Alicia Holman - drew all 1,004, 437, 930, 450 and 848 ward votes.

In MAPLEWOOD, the contest was over who would be the top vote-getter among the two Democratic candidates for the two Township Committee seats.

Incumbent Nancy Adams took 1,680 or 50.37 percent. Jemaime Cripe came in with 1,655, or 49.53 percent. The Republican Party Organization did not field candidates in East Orange and Maplewood.

#### **GOVERNOR MURPHY ANNOUNCES** INTENTION TO CLOSE THE EDNA MAHAN **CORRECTIONAL FACILITY FOR WOMEN**

TRENTON - On June 7, Governor Phil Murphy announced his intention to close the Edna Mahan Correctional Facility for Women, New Jersey's only women's correctional facility. The Murphy Administration also released an investigative report prepared by former State Comptroller Matt Boxer and the law firm Lowenstein Sandler LLP on cell extractions at the facility that occurred on January 11, 2021.

"After learning about the violent attacks that took place on January 11 at Edna Mahan Correctional Facility for Women, I ordered an independent investigation to determine what happened, how it happened, and to ensure a situation like this never occurs again in our correctional facilities," said Governor Mur-phy. "With former New Jersey State Comptroller Matt Boxer's detailed investigative report, we now have key information about the circumstances surrounding the incidents that night and a roadmap to prevent unauthorized cell extractions and violence against inmates.

"I am deeply disturbed and disgusted by the horrific attacks that took place on January 11. Individuals in state custody deserve to be treated with dignity and respect, and the officers involved in this incident, both directly and indirectly, abused their power to send a message that they were in charge. The excessive use of force, as outlined in the report, cannot and will not be tolerated by my Administration. I am grateful to Attorney General Gurbir Grewal for his swift action in filing criminal charges against multiple officers involved in these appalling attacks.

"Edna Mahan Correctional Facility for Women has a long history of abusive incidents predating our Administration, and we must now commit ourselves to completely breaking this pattern of misconduct to better serve incarcerated women entrusted to the State's care.

"After reading the report and its recommendations, I have decided that the only path forward

is to responsibly close the facility. I look forward to working with our partners in the Legislature to responsibly close down the Edna Mahan Correctional Facility for Women and relocate inmates to a new facility or other facilities. While this will not happen overnight, I intend to work with legislative leadership during the current budget cycle to allocate funding to begin this multi-year process.

"I also welcome the various recommendations outlined in the report, including establishing independent oversight; further clarifying authorization protofor cell extractions; strengthening staff recruitment, retention, and training; accelerating the implementation and adoption of body-worn cameras and an early warning system; and improving physical infrastructure while pursuing the ultimate goal of closure of the facility. I am directing the Department of Corrections to review the recommendations with the goal of implementing them as soon as practicable."

The Lowenstein Sandler LLP investigative team was led by former New Jersey State Comptroller and federal prosecutor Matt Boxer. Other members of the investigative team included Rachel Moseson Dikovics, Esq.; Jamie Gottlieb Furia, Esq.; Rasmeet Chahil, Esq.; and Amanda Cipriano, Esq. In preparing the report, the team reviewed more than 21,000 documents, conducted interviews of State officials, reviewed over 20 hours of video footage, performed statutory research, and examined relevant legal standards and best practic-

Several paragraphs of the report on pgs. 32, 33 and 47 have been temporarily redacted at the request of the Attorney General's Office of Public Integrity and Accountability, who has stated that making those portions of the report public at this time would interfere with the ongoing criminal investigation, in which 10 New Jersey corrections officers have been charged to date.

#### I've Been ROBBED!!! Part 2

There are a couple of other scams you should be in the know about...like the "Mystery Shopper Scam."

One of my clients who has been unemployed for almost a year and who is desperately seeking a full-time job (so she can move out of her parent's home) actually fell for this one. Some guy called her to ask her if she had a job. When she replied that she did not have a job, but was looking, the caller announced, "This is your lucky day! I have to fine five people today who can work from home and who need flexible hours to become personal shoppers. We have loads of people who simply don't have the time to shop for themselves."

After twenty minutes of what I can only think of as mind-

numbing conversation, she agreed to give them \$150 of her very precious income to purchase training materials so that she could get started. The "training materials" were to be downloaded to her. After giving her credit card information, and \$150 being charged to the card, she never received the training materials, and she could not contact the firm's representative by phone!

And, let's not forget the ole Digital Greeting Card scam! With this one, you receive a digital birthday card, or holiday card, or sometimes a plain old email. When you open the card from a scammer, it unleashes malicious software (malware) to your computer that can steal your personal information and in effect, ruin your life. The worst part about the greeting card scam is that you don't necessarily know before it is too late that it's a scam because sometimes, they come from people you know whose e-mail has been hacked.

Sometimes the greeting cards come from someone with whom you communicate using Facebook or Twitter, then suddenly you receive a greeting card from the person. BEFORE you open a greeting card, it might be a good idea to call or text the sender to make sure they actually sent you a greeting card. If you open first, everything on your computer could be open to the scammers for the taking. In effect, this is

how the corporations are being held hostage. Sometimes the malware freezes the files or renders the system inoperable requiring the corporation to pay a ransom to retrieve the files.

The Dating and Romance scams are the worst because they take advantage of people's emotions and their money. They work like this. You go on the site. You select a profile. You communicate with the persona and build a rapport. Then the person starts asking you for money. Remember this: one in ten newly created dating profiles are fact. In 2020, Americans lost \$160 million in online dating scams and the average loss was more than \$20,000!

You would think that this one would be easy to spot. The person falls madly in love with you too quickly without ever having seen you. They promise to meet you, but despite "plans" the meeting never happens. That's usually when they ask you to wire them money to cover the unforeseen emergency. The one "emergency" grows into a another, into another and so on...The rule is: NEVER give money to someone you have not met!

The internet is a permanent way of modern life. There is no likelihood that we are going back to the pre-internet days of yesteryear. So, here are a couple of additional tips to help you stay safe on the internet.

If you download malicious software, get rid of it. That may be harder than it sounds because you may not know that it's there right away and because these programs are designed to be hard to detect. You may need to reset your computer to factory defaults. It is worth taking your computer to the Geek Squad to get rid of the malware.

If you send money to a scammer, you might just be out of luck because most banks invoke the "Let the Buyer Beware" policy. (That's what the bank told my friend, but the bank was kind enough to cancel her card and disallow the additional charges the scammer added to the card. She was only out of the original \$150) But, you should report it to the bank at once because even if you don't get your money refunded it will help nail the scammer.

Guard your personal information, e.g., social security number, bank account number, address, birthday, with your life!

Use a VPS and avoid public WIFI. It sounds good to say that I am going to Panera Bread or Starbucks to use the public WIFI, but public WIFI is the cybercriminals heaven. If you use public WIFI, make sure that you have installed a VPN (Virtual Private Network) on your device so you can protect yourself. A VPN is the best option other than simply no using public networks.

GLEN RIDGE - Borough residents, parents and colleagues of a 22-year Glen Ridge High School librarian have one last appeal to reinstate her during the Glen Ridge Public Schools June 14 virtual Board of Education meeting.

Those objecting to the effective June 30 dismissal of MaryLynn Savio had been appealing to the board and schools super-

intendent Dirk Phillips since their passage of the 2021-22 school year budget April 26 and though the panel's May meetings.

The budget the board had unanimously passed included eliminating the job title of GRHS Library Media Specialist. Phillips, back then, further prosed converting the 1968-built library into a large group meeting space and cooperative area over this summer. The former GRHS principal cited declining use of traditional books and periodicals by students for the job cut and space reuse.

"We're looking to make it a less traditional space," said Phillips, "where we're having the resources still available when it comes to electronics."

Objectors have cited that the GRHS librarian has assisted in helping teachers prepare resources for their sixth, or extra paid, classes.

Savio and borough resident/ Bloomfield Public Library Director Holly Bell, have testified for the former's job retention at the board's May 10 and 27 sessions. Savio also happens to be the president of the Glen Ridge Education Association teachers union.

BELLEVILLE - A resolution which would allow the township to appropriate The Great Lawn, including "by eminent domain, if necessary," was tabled by a majority of council members here June 7.

Resolution 11.1.1 had received its public hearing that Monday night prior to its being tabled. Council members may first vote to lift it from the metaphoric table before taking that second and final vote. Leaving the resolution on the table could subject it to expiration.

The Great Lawn is an eight-acre grass hill at the northwest corner of Belleville and Franklin avenues. It is crowned by the former Essex County Isolation Hospital, a 116-year-old, 10-story landmark building being converted to luxury apartments.

There has been a concern that the lawn, currently owned by the hospital's redeveloper, would be subject to commercial or retail development. "Local Talk" recalls a proposal to build a pair of single story strip mall buildings, flanking the hospital's Belleville Avenue main entrance, in the early 2000s.

The resolution's critics have said that the measure is unnecessary. They cite a 2003 planning agreement where The Great Lawn would be preserved in perpetuity.

**NUTLEY** - Mayor Mauro G. Tucci and a majority of Township Commissions have signed, sealed and delivered their stance on having cannabis-based businesses within Nutley's limits to Gov. Phil Murphy's administrators in Trenton when you read this.

Tucci and fellow commissioners John V. Kelly IV, Thomas Evans and Joseph Scarpelli voted to ban almost all classes of CBBs for the next five years. The ban does allow out-of-town cannabis and/or CBB providers to deliver to their Nutley

The June 1 vote, absent Commissioner Alphonse "Al" Petracco, came after Nutley's elders held a public hearing earlier that evening. Nutley joins Glen Ridge, who voted for a similar five-year ban April 27, among "Local Talk" towns in shutting, but not locking, their doors to CBBs.

Murphy's administrators wanted each of New Jersey's 565 municipalities to make a decision on CBBs on or before Aug. 20. Towns may revisit their bans or allowances in 2026.
