



Hello Readers,

The biggest news right now is the meeting between U.S. President Joseph Biden and Russian President Vladimir Putin. The meeting was held at Geneva, Switzerland.

According to Fox News: "U.S. reporters and producers were aggressively pushed and shoved by Russian security officials Wednesday at the start of the highly-anticipated meeting in Geneva between President Biden and Russian President Vladimir Putin, denying the press full access to what was expected to be a short press availability before the hours-long summit."

Right after the meeting, Russian President Putin held a press conference first. The main topics at the conference between the two world leaders was about nuclear stability, climate change and cybersecurity. Putin did not accept any blame for the computer hacking, and blamed countries like the U.S. and Canada for most of the world's hacking. He also did not address the fate of Alexei Navalny, a Putin opponent who was poisoned with a nerve agent and is currently in Russian custody.

In his press conference, Biden made it clear that while he is confident in civility between the two countries, certain things such as water and other critical infrastructure should not be in play for hacking. He also made it clear that there would be consequences if Russia did not behave.

A former secretary of state said that by both presidents holding solo press conferences, the talk has failed or did not receive any result.

According to CNBC: "On Tuesday, a Kremlin aide said nuclear stability, climate change and cybersecurity were on the agenda for the summit, Reuters reported, as well as the outlook for Russian and U.S. nationals imprisoned in each other's countries. Nonetheless, the aide said he was not sure any agreements could be reached. The meeting

between Biden and Putin comes on the heels of Biden's first international trip as president, where he reaffirmed alliances with G-7 leaders and NATO allies. The American president is expected to strike a different tone with his Russian counterpart compared to his predecessor Donald Trump."

According to Fox News; "Putin thanked Biden for 'the initiative to meet today,' noting that U.S. and Russian relations 'have a lot of issues accumulated that require the highest level meeting,' and said that he hoped the meeting 'will be productive.' Biden said that he thinks it is always better to meet face to face, to try and determine where we have mutual interests to cooperate, and where we don't. At the start of the meeting, Biden was asked by a reporter if he and Putin could trust each other, and whether he trusted the Russian president. Biden nodded affirmatively."

Not long after, a Biden spokesperson made it clear that the nod was an acknowledgement of the reporter, and not any confirmation that he trusted Putin



He completed his fellowship at Newark Beth Israel Medical Center where he worked with Dr. Victor Parsonnet, the world-renowned cardiac surgeon and pioneer, for whom the award is named. Led by Dr. Parsonnet, Dr. Atherley was a member of the innovative team that implanted the first double-chambered nuclear powered pacemaker in the United States.

He has participated in numerous international medical missions to the Caribbean, Central and South America. In addition, he has received several awards and honors for his local and regional healthcare activities. In 2016, he received the Silver Crown of Merit from the government of Barbados, and the City of Newark also recognized his serviced to the community by declaring May 4, 2004 Trevor H. # Pulse Nightclub Remembered

The following is a statement from President Biden on the anniversary of the Pulse Nightclub shooting:

"Five years ago today (June 12, 2016) in Orlando in the middle of Pride Month, our nation suffered the deadliest attack affecting the LGBTQ+ community in American history, and at the time, the deadliest mass shooting by a single gunman.

"Within minutes, the Pulse nightclub that had long been a place of acceptance and joy turned into a place of unspeakable pain and loss. Forty-nine people were there celebrating Latin night were murdered, even more injured, and countless others scarred forever - the victims were family members, partners and friends, veterans and students, young, Black, Asian and Latino - our fellow Americans.

"A few days later, I traveled with President Obama to pay respects to them and their families, to thank the brave first responders and the community who found strength and compassion in each other, and to pledge that what happened would not be forgotten.

"Over the years, I have stayed in touch with families of the victims and with the survivors who have turned their pain into purpose, and who remind us that we must do more than remember victims of gun violence and all of the survivors, family members, and friends left behind; we must act.

"In the coming days, I will sign a bill designating Pulse Nightclub as a national memorial, enshrining in law what has been true since that terrible day five years ago: Pulse Nightclub is hallowed ground.

"But there is more we must do to address the public health epidemic of gun violence in all of its forms - mass shootings and daily acts of gun violence that don't make national headlines.

"It is long past time we close the loopholes that allow gun buyers to bypass background checks in this country, and the Senate should start by passing the three House-passed bills which would do exactly that. It is long past time we ban assault weapons and high capacity magazines, establish extreme risk protection orders, also known as "red flag" laws, and eliminate gun manufacturers' immunity from liability.

"We must also acknowledge gun violence's particular impact on LGBTQ+ communities across our nation. We must drive out hate and inequities that contribute to the epidemic of violence and murder against transgender women - especially transgender women of color. We must create a world in which our LGBTQ+ young people are loved, accepted, and feel safe in living their truth. And the Senate must swiftly pass the Equality Act, legislation that will ensure LGBTQ+ Americans finally have equal protection under law.

"In the memory of all of those lost at the Pulse nightclub five years ago, let us continue the work to be a nation at our best - one that recognizes and protects the dignity and safety of every American."

# Netanyahu Out

After multiple elections to try and lay the foundation for a functional government, the man who was de facto in charge of Israel has been removed.

Benjamin Netanyahu, the longtime Prime Minister of Israel of 12 years, has been removed from power, after a 60-59 vote in the Knesset placed Naftali Bennett as the new PM. This marks the second time that Netanyahu has been removed from the post, as he once served from 1996-1999 before his 2009-2021 tenure

One big reason for his ouster is an ongoing probe regarding

corruption charges while he was in power. He now serves as leader of the opposition, which is the powerful Likud Party he still commands.

"On behalf of the American people, I congratulate Prime Minister Naftali Bennett, Alternate Prime Minister and Foreign Minister Yair Lapid, and all the members of the new Israeli cabinet," said U.S. President Joe Biden in a statement. "I look forward to working with Prime Minister Bennett to strengthen all aspects of the close and enduring relationship between our two nations.

"Israel has no better friend than the United States. The bond that unites our people is evidence of our shared values and decades of close cooperation and as we continue to strengthen our partnership, the United States remains unwavering in its support for Israel's security. My administration is fully committed to working with the new Israeli government to advance security, stability, and peace for Israelis, Palestinians. and people throughout the broader region."

Despite getting the votes to be PM, Bennett will not stay for long, as a power sharing agreement will split duties between leftist, conservative, and centrist leadership in the country.

## **UK to Donate Vaccine**

The UK will donate 100 million surplus coronavirus vaccine doses to the world within the next year, the Prime Minister has announced June 11.

The pledge came just ahead of the G7 Summit, which took place in Cornwall. Previously, Prime Minister Boris Johnson asked fellow G7 leaders to help vaccinate the entire world by the end of next year.

At the Summit, world leaders announce their intentions to contribute to the cause, which included the United States pledge of 500 million doses. The UK will donate 5 million doses by the end of September, primarily for use in the world's poorest countries.

The Prime Minister has also committed to donating a further 95 million doses within the next year, including 25 million more by the end of 2021. 80% of the 100m doses will go to COVAX and the remainder will be shared bilaterally with countries in need

By sharing 5 million doses in the coming weeks the UK will meet an immediate demand for vaccines for the countries worst affected by coronavirus without delaying completion of our initial domestic vaccination program.

The thinking is that by vaccinating more people around the world, not only the UK help bring an end to the global coronavirus pandemic, but it would reduce the risk to people in the UK. This includes significantly reducing the threat posed by vaccine-resistant variants emerging in areas with large-scale outbreaks.

The UK helped to establish COVAX last year and is its fourth-biggest donor, pledging £548 million to the scheme. COVAX has so far provided 81 million doses to 129 of the world's poorest countries. 96% of these were the Oxford-AstraZeneca vaccine, the development of which was funded by the UK.

With the support of the UK Government, Oxford-AstraZeneca are distributing their vaccines on a not for profit basis the world. Thanks to this commitment, half a billion people have received a dose of the Oxford-AstraZeneca vaccine so far.

# Gangs Overwhelming Haiti

An upsurge in deadly clashes between gangs in Haiti's capital, Port-au-Prince, has displaced more than 5,000 people since the beginning of the month, the United Nations said on June 10, citing preliminary estimates from its humanitarian agency, OCHA. People are fleeing to safer areas to stay with relatives, though many others, including children, are sleeping outside or (Continued on page 10)

Selecting ward district leaders or county committee members are important in that they help shape tier major party's policies and platforms. They become delegates for their respective Democratic or Republican parties' county and state committees - and, in Presidential election years, as delegates to their national conventions.

Those elected as ward leaders become neighborhood representatives to the parties - and to City Hall should their colleagues get elected onto the municipal council and/or into the mayor's

Please note that the following figures range from single to triple digits. It may be because voting for these "frontline" party members is not as exciting as voting for, say governor or higher offices.

That may not keep "higher ballot" candidates from urging voters to select their county committee candidate choices. "Local Talk" found a palm card in South Orange from Republican party candidate for county sheriff Maureen Edelson, pointing to her and two of her committee choices on the ballot's Line H.

The results below from Essex County Clerk Christopher Durkin's election office remain unofficial until June 22. Durkin may certify the results as official that Tuesday pending the lack of any challenges or recounts.

The following candidates are on the OCD line, for brevity, unless otherwise noted. Party voters are to select or endorse two candidates per district.

NORTH WARD District 2 was a Ikner family affair. Stefon Inker drew 88 votes for 50.17 percent of the vote. Evon Ikner drew 85 for 49.83.

N3 saw the re-endorsement of Coram and Linda Rimes. L. Rimes garnered 85 for 51.15 to C. Rimes 85 for 48.85.

N4 saw Paton Cunder carrying 39 for 50.65. Paula Desormes drew 38 for 39.35.

N5 had Kevin Hardaway getting 100 for 50 percent. Ward Councilwoman Tency Eason earned 91 for 45.50. Community First candidate Elisha Petite polled nine votes for 4.50.

SOUTH WARD 1 saw OCD runners turn back their Community First challengers. Mamie Greene was the top vote-getter among the balloted four runners, gathering 90 for 39.30. Councilman Clifford Ross received 85 for 37.12. Former South Ward Councilman and Community First runner Edward Marable, Jr. received 32 for 13.97. Running mate Karen J. Wells tallied 22 for 9.61.

S2 had two OCD candidates carried over five independents. Laurence Gaunt, Jr. was the district's top vote-getter at 115 for 31.42. Running mate David K. Armstrong amass 78 for 21.31. Former Councilwoman April Gaunt Butler was "best of the rest" here at 67 for 18.31. Independent Shawn Hunter was next at 52 for 14.21.

Former Orange Public Schools Board President Ernest Lydell Carter placed fifth at 26 for 7.10. Jairam Kissoom was next at 15 for 4.10. Deborah Bartly-Carter rounded out the balloted field at 13 for 3.55.

An OCD and a Community First candidate will share S4 district leader/county committee functions.

OCD incumbent Stacy Martin mustered 80 for 86.02. Community Firster and Orange Board of Education member Brenda Daugherty received the second, open seat here with 13 for 13.98.

Two familiar names got the S5 leader/committee nods. Former Councilman Elroy A. Corbitt carried 92 for 51.11. Former Orange BOE member Patricia A. Arthur amassed 88 for 48.89.

S6 was an all-Wingfield affair. Jeffrey Wingfield tallied 40 for 51.28. Jashlyn drew 38 for 48.72.

Four of the EAST WARD's five races were uncontested.

In E-1, Councilman Weldon Montague III got nine votes for 52.94. Antionette A. Hall had eight for 47.06.

The Johnsons rolled in E2. Willie Johnson got 108 for 50.23. Greta Johnson had 107 for 49.77.

The Coleys carried E4. Councilman Kerry Coley got 79 for 50.32. Lisa Coley got 78 for 49.68.

E5 saw a split between an OCD and a Community First candidate. Tazwell Lacey got 86 for 41.15. Tyrone J. Tarver got

# TS TO CONSPIRACY

NEWARK - On June 16, an Essex County man admitted to conspiracy to commit bank fraud by soliciting U.S. Postal Service (USPS) employees to steal check books and credit cards from the mail, depositing fraudulent checks, including pandemic relief checks, and using stolen credit cards without authorization, Acting U.S. Attorney Rachael A. Honig announced.

Jahaad Flip, 20, of Newark, pleaded guilty by videoconference before U.S. District Judge Susan D. Wigenton to an information charging him with one count of conspiracy to commit bank fraud.

According to documents filed in this case and statements made in court: From February 2019 to May 2020, Flip conspired to fraudulently obtain money from victim financial institutions by, among other things, depositing counterfeit checks and checks stolen from the mail into accounts and withdrawing funds from those accounts before the financial institutions identified the fraudulent checks and blocked further

Flip and his conspirators arranged for USPS employees to steal credit cards and blank check books from the mail in exchange for cash payments. USPS employees provided the checks to Flip and his conspirators, who forged the signatures of the accountholders and negotiated the checks by making them payable to individuals. Some of these individuals were New Jersey high school students who had given Flip and his conspirators access to their accounts in exchange for cash.

Flip and his conspirators also created counterfeit checks, including counterfeit pandemic relief checks. They deposited the fraudulent checks online and at various bank ATMs throughout New Jersey and later withdrew funds from the bank accounts before the victim financial institutions identified the checks as fraudulent. Flip and his conspirators obtained and attempted to obtain approximately \$280,000 from victim financial institutions.



## Moderna Booster Works!

Getting vaccinated is how we can defeat the coronavirus. There are no two ways to it, so don't get it twisted. The number of vaccinated individuals in the United States is increasing, which is great news. Although the vaccination rate has dragged recently, the US is still in an excellent position regarding vaccinations.

When President Biden came in, he set many goals for vaccine distribution, and it's fair to say the US has more than exceeded the lofty expectations. It is estimated that more than 70% of the population will have received at least one dose of the vaccine by July 4.

If you've ever wondered why there is so much pressure to get the vaccine as soon as you can, it's because the longer the virus persists, the worse it gets. And I'm not just talking about the deaths and hospitalizations resulting directly from the coro-

navirus, but that new strains are developing.


New variants of the coronavirus have developed in South Africa, Brazil and are spreading through the world. These variants are either more transmissible or deadlier than the parent virus. If there's an increased spread of these new strains, the chances of deaths and hospitalizations will also increase. While that's the immediate threat, it is far from being the only threat.

There is also the possibility of new strains developing from these new strains. We haven't even figured exactly how to beat these new strains, and there may be newer strains yet. Do you see why there's so much pressure about getting vaccinated as soon as possible now?

For all the noise that has been made about getting vaccinated, vaccination isn't absolute. Don't get me wrong; getting vaccinated will effectively give you the immunity you need to resist the coronavirus, but experts are starting to suggest this immunity will eventually wane. Wait, don't freak out! At least, not yet.

The coronavirus is a novel virus, and its vaccines are also new. No one knows exactly when the immunity these vaccines provide will wane. In fact, no one knows for sure if the immunity provided will wane. Still, experts worldwide believe it will at some time, including Dr. Fauci and top CDC officials.

I believe at this point, I can introduce you to what a vaccine booster is. Medically, a booster is an extra administration of a vaccine after an earlier dose to serve as a re-exposure to the immunizing antigen. In simple terms, it's just a way of reactivating immunity, permit me to



call it that. The vaccine booster should also protect against new strains.

In light of the emergence of new strains and breakthrough cases, many vaccine companies are releasing boosters for their vaccines. Breakthrough cases are cases that occur even after getting immunized against a particular infection.

Moderna, one of the approved vaccine producers, has developed a booster using the same mRNA technology with which they created the COVID vaccine in the first place. According to their CEO, this is to bolster waning immunity and to protect against new virus mutations. Recent studies and tests have shown that the Moderna booster works.

in informal shelters.

UN Spokesperson Stéphane Dujarric said the newly displaced require urgent assistance and protection.

"Priority needs include sanitation, shelter, access to clean water and food," he told journalists. "Response efforts are underway to assist some 2,000 of the most vulnerable people.

These efforts are led by the Municipality and Civil Protection, with the support of the UN."

The violence has left several people dead, or injured, as rival gangs battle to exert control over populous areas such as Martissant, Cité-Soleil and Bel Air. Hundreds of homes and small businesses have also been burned.

The latest displacement adds to the more than 4,000 people uprooted in the last 12 months due to similar incidents.

OCHA reported that the national police force is often not able to provide security and protection during the clashes, leaving vulnerable populations to fend for themselves.

Police stations have also come under fire. One policeman was killed and another injured when armed assailants attacked all three police stations in Cité-Soleil on Saturday, stealing several weapons.

"The unprecedented level of violence and subsequent displacements is creating a host of secondary issues, such as the disruption of community-level social functioning, family separation, increased financial burdens on host families, forced school closures, loss of livelihoods and a general fear among the affected populations," OCHA said in a situation report earlier this week.

**NEWARK** - Signs of the former St. James Hospital's new lease on life as a Newark public high school may first appear as renovation contractors' vehicles in 155 Jefferson St.'s parking lot this summer.

It is not clear as of presstime is how much of the 70,000-square-foot 1962 hospital and its 2011 wing will be transformed into the Newark Public Schools' new High School of Architecture and Interior Design. Nor is it clear whether its current tenants - internal medicine and eye clinics and doctors' offices - will be allowed to stay or are being given eviction notices.

What is clear is that the high school's inaugural Class of 2025 - an estimated 120 students and 20 teachers - are to move in before Labor Day. NPS Superintendent of Schools Roger Leon projects a full enrollment of 960 students and at least 60 teachers for 2024-25.

Leon, after three months' negotiations with owner Equity3, of Paramus, announced the signing of a 20-year, \$160 million lease on SJH May 28, after the Board of Education examined and passed its approval earlier that Friday. Its terms include paying \$3-to-5 million in annual rent to Equity3 with options to renew or buy in 2041.

The new school, whose curriculum will include vocational-technical courses, is one of several specialized magnet high schools Leon and the board have been creating since 2019. The A&ID HS may help overcrowding at the nearby East Side High School.

Equity3 had been renting out SJH's space to medical professionals since then-owner Cathedral Healthcare System closed it in 2008 and in 2008 and sold off the 189-bed hospital. Its parking lot was where old St. James Church stood 1854-1980; the hospital is the parish's best-known community contribution.

**IRVINGTON** - A Springfield Avenue house remains uninhabitable, and its 10 residents displaced as of press time since a lightning strike here June 8 set it ablaze.

All available Irvington Fire Department personnel plus fire-fighters from four other towns responded in the pouring rain that Tuesday to a 3:45 p.m. call that 1293-95 Springfield Ave. had caught fire.

The first units found flames and smoke coming from the roof and top bedroom window of the three-story building. Witnesses told firefighters that they saw a flash, heard an explosion and saw fire.

The incident commander, while assisted by Irvington police in closing the county road between Lyons Avenue and 20th Street, promptly pulled the second and third alarms. Units from Maplewood, Orange, Montclair and Union arrived to assist. Ambulances from RWJBarnabas and other hospitals and EMS squads also appeared.

It took firefighters 30 minutes to enter the 1920 wood frame house and search for any more occupants. The building owner, who was inside until builders next door awakened him, got his mother out and searched before the smoke became overpowering.

Several reporters said that up to 10 people from three families were rendered homeless; some had to wait until at least 11 p.m. for help from the local American Red Cross chapter and other agencies.

A severe thunderstorm front passed through the area that afternoon, leaving lightning strikes in Irvington and Hillsdale, flooding in Hackensack and signal problems scattered among NJTransit's commuter rail lines.

NJTransit buses from its nearby Hilton garage, including those on its 25 and 70 routes, were among the detoured traffic.

IFD Deputy Chief Kaimu Suggs told WPIX-11 that township firefighters were working on two other blazes when the 1293-95 Springfield call came. No injuries were reported.

EAST ORANGE - A city man, accused of burglary and attempted burglary in Bloomfield, remains in Newark's Essex County Correctional Facility pending his posting of three State Superior Court-Newark bail bonds.

Shaquan S. Parker, 33, has been held in the county jail since May 26 on those three outstanding bonds, an outstanding Orange Municipal Court warrant and seven counts of burglary and related charges by the Bloomfield Police Department.

A resident of the township's Clinton Street told arriving BPD officers that she saw a man break a window of one neighbor's house and had attempted to enter another neighbor's house through a window there May 25. The suspect, when confronted by the witness, fled the street.

Bloomfield Public Safety Director Sam De Maio, without elaborating, said that BPD patrol officers located and arrested Parker, based on the witness' description, later that day. Parker has since been charged with an earlier attempted breaking and entering of a Glenwood Avenue residence.

Parker has been out on a Bloomfield summons and court appearance since April 28. He was arrested and charged back then for breaking and entering a vehicle parked along Watsessing Avenue.

Parker's Clinton Street charges are four counts of burglary by entering, two counts of criminal mischief by damaging property and a count of theft of movable property.

**ORANGE** - City police officers are asking the public to "be on the lookout" for a particular car that was carjacked by its border with East Orange near midnight June 12.

Orange Police Director Todd Warren said that the owner of a BMW flagged down several of his officers at Central and Oakwood avenues early that Saturday morning.

The driver/victim said that a suspect had forced him out of his car at that major intersection at 11:55 p.m. June 11. The victim was not physically injured.

Wanted is a black late-model BMW 328i with NJ license plate numbers N88-NBZ. carjacking Central and Oakwood Avenues. No further details have been disclosed as of press time.

WEST ORANGE - A Boston arena has indefinitely banned a spectator from its premises since his arrest for assaulting a visiting township resident there May 30 - a ban that may last the "fan's" lifetime.

TD Garden officials have told Cole Buckley, 21, of Braintree, Mass., to stay away from the arena, where the Suffolk County District Attorney's Office had charged him with a single count of felony assault.

Buckley, a University of Rhode Island student, is accused of throwing a bottle of Dasani water at Kyrie Irving, 29, of West Orange, while the latter was walking off the TD Garden basketball court at the end of that Sunday's game against the hosting Boston Celtics. The Brooklyn Nets guard had helped his team to a 141-126 victory over the Celtics in the first Garden capacity crowd since the March 2020 COVID global pandemic outbreak.

Buckley's missile throwing, which may have or have not grazed Irving's head, was captured by others' cell phones and posted on social media - which got the attention of TG Garden Security. Guards identified and detained Buckley and turned him over to Boston Police - who held him until his June 2 arraignment.

County DA Rachel Rollins, while not charging Buckley with hate crime or civil rights violations, pressed for one felony count of assault and battery with a dangerous weapon. Buckley was released on \$500 bail and is

# Dark Money

Yesterday, after reading that one senator sued and won a case for the \$250,000 that he lent to his political campaign and is now suing for \$37.5M that former President Trump supposedly lent to his 2016 election campaign, I began to think more seriously of the term "Dark Money," that is bantered around these days.

Although these two suits make obvious some of the money spent on their political campaigns, most of the money raised and spent is from nonprofit organizations that do not disclose their donors' identities. In fact, since the Supreme Court decision in 2010, favoring Citizens United, opaque nonprofits and shell companies have been able to give unlimited amounts of money to super PACs.

Super PACs are legally required to disclose their donors; however, some groups are effectively dark money outlets where the bulk of their funding cannot be traced back to the original donor. It is said that these dark

money groups have spent billions of dollars - mainly on television, online ads and mailers - to influence elections.

Tragically, while citizens are barraged with political messages paid for with the money coming from undisclosed sources, citizens are often too naive to consider the credibility and possible motives of the wealthy corporate or individual funders behind the messages. As a result, many individuals are being subjected to groupthink and do not know it.

Although I have used the concept of "Dark Money" to speak of the corrupting influence on the public political system and the services being rendered by our public servants, my mind is more drawn to what took place in the Jerusalem Temple in the time of Jesus. The biblical record states that Jesus went to Passover:

"And He found in the temple those who sold oxen and sheep and doves, and the money changers doing business. When He had made a whip of cords, He drove them all out of the

temple, with the sheep and the oxen, and poured out the changers' money and overturned the tables. And He said to those who sold doves, 'Take these things away! Do not make My Father's house a house of merchandise!' Then His disciples remembered that it was written, 'Zeal for Your house has eaten Me up.'" (cf. John 2:14-17 NKJV).

What a sight it must have been with Jesus and the money changers! The Gospel of John that records the event quoted above shows that the money changers were very unhappy with Jesus' actions and how they tried to argue about his authority for doing what he did. The record of the incident in the other Gospels states that the money changers ran away and then later returned to ask Jesus by what authority he was doing what he did, and who gave him such authority. (cf. Mark 11:28; Luke 20:2; Matthew 21:23). After the event, the money changers sought every opportunity how they might destroy him.

Their reaction has led me to state that anyone who will spend time to fight the dark money in the political culture of the day needs to understand that they are taking on a risky fight. Those who control the corrupt systems in the public arena or some parts of the religious world will seek to destroy any who challenge

their corrupting influence with money.

However, I am also thinking that although we need to understand the risk of speaking out, we need to do what needs to be done to challenge the system because many persons are in the system who do not understand what is going on and are being just dragged into the demonic forces around them.

Further, it needs to be made clear that while many political figures use money to buy power and gain popularity (in the sociopolitical culture or any other sphere), money does not buy character, decency, dignity, integrity, health, happiness, lasting relationships or eternal life.

Jesus was right when he spoke to a young man who came to him asking how he might have eternal life. Jesus said, "Go and sell all that you have, and give to the poor, then come and follow me." (cf. Luke 18:22). The proverb attributed to one of the richest men this world has ever seen says, "A fool and his money will soon depart." (Proverbs 21:20).

**BLOOMFIELD** - A public memorial for Candace "Candy" Straight, a political candidate who helped other women into that arena, is being planned for some time in July. Relatives and friends held a private graveside service for her before press time.

Straight, 73, died June 13 at Hackensack University Medical Center. The lifelong Bloomfielder had blood cancer, a stroke and a heart attack descend on her the

previous two weeks.

Straight's LinkedIn resume has investment banking and film production as her day jobs. The Wilson College and NYU Stern School of Business graduate lists "An Acceptable Loss" and "Equity" as among her production credits.

Readers may be more familiar with Straight running for several offices, including against Joseph DiVincenzo for Essex County Executive in 2002 and for Freeholder-at-Large in 2005.

The longtime Equal Rights

Amendment supporter's greatest influence may well be in cofounding Women for a Stronger New Jersey, a Republican PAC for female candidates, among helping similar organizations.

Candace L. Straight, was born Oct. 5, 1947, while grandfather Francis R. Jewkes was Township Councilman until losing his seat in 1954. Grandmother Dorothea Jewkes became the first woman council member by winning back the seat in 1956. Her ERA support came while she saw gender inequity while

rising from an entry-level secretary into corporate boardrooms.

move its Board of Education to an elective panel, barring a legal challenge or an unforeseen event, is to appear on Nov. 2's General Election ballot - again.

Township Clerk Angelese Bermudez Nieves has sent the question to Essex County Clerk Chris Durkin since Vote Montclair's petition had 1,033 valid signatures on May 21. Vote Montclair, who had submitted their petition April 26, needed at least 1,020 valid signatures - or 15 percent of the township's registered voters - to make the ballot.

Montclair, East Orange and nine other public school boards in New Jersey are Type I boards, where the mayor appoints its members. Orange Public Schools, who transitioned to a Type 2 elected board after their 2017-18 referenda, was the latest to join the 97 percent of school boards who are on that format statewide.

The question, on one hand, had been put before voters five times over a 46year period: 1963, 69, 71, 95 and 2009. A majority of participating registered Montclair voters last turned down the question - 5,576-4,282 for a 56.56/43.44 percentage split - on the Nov. 3, 2009 General Election ballot.

The question, on the other hand, comes in the wake of Mayor Sean Spillar's new day job. A majority of New Jersey Education Association voters elected then-Vice President Spillar as the state teachers union's next president.

The NJEA is the parent to the Montclair Education Association, which represents 80 percent. of Montclair Public School's employees. Spillar meanwhile appoints the nine-member Board of Education, including a pool of five members who may become its Negotiations Committee up before the MEA's counterpart over the next contract talks.

Spillar, in an April 26 Facebook posting, said he will abide by however Montclair voters decide on the Type 1 or Type 2 school board question.

Vote Montclair made its petition drive as its advocacy for greater voter participation in elections. Its website also calls for moving Montclair's municipal-level elections from the May nonpartisan date also onto November's General Election ballot.

GLEN RIDGE - Thirteen of the borough's finest added one more honor to their late colleagues by running past his home here June 11.

Mayor Michael Melham and First Ward Councilwoman Marie Strumolo-Burke unveiled the Risoli Way sign at Lake Street's southwest corner with Franklin Street before an estimated 24 spectators here June 6.

Brother Barton "Barney" Risoli, sister -in-law Joyce, Nutley Commissioner Dr. Joseph Scarpelli and Newark North Ward Councilman Anibal Ramos, Jr. were among the unveiling's witnesses.

Lake Street's northernmost block, between Franklin Avenue and Honiss Street, honors 20-year Public Works Commissioner, First Ward Councilman and Deputy Mayor Risoli. "Ang," who was born Sept. 22, 1940, also served 20 years as Belleville Republican Party Organization chairman.

Risoli, 72, died at his home, 52 Lake St., Sept. 25, 2012. The Newark Moose Club member had retired that January after 10 years as an Essex County transportation specialist. His Funeral Mass was held for him at St. Anthony of Padua, prior to his burial at Glendale Cemetery, Sept. 28, 2012.

"(Risoli) would've been proud of the last few years when two of his proteges,," said Melham, "Dr. Scarpelli and I, were serving as mayors of Nutley and Belleville. "We ran as a team for Ward Council. Our victory was historic, as never before had a majority been elected in one election in Belleville."

"Even though we didn't always see eye to eye when it comes to politics, we were good friends and I respected him much." said Strumolo-Burke. "Angelo was a good man and dedicating this street was a long time coming and well deserved."

One of Flip's conspirators, Tashon Ragan, pleaded guilty before Judge Wigenton last week to conspiracy to commit bank fraud and is due to be sentenced on Sept. 20, 2021. Charges are still pending against two other conspirators, Jeffrey Bennett and Janel Blackman. The charges against Bennett and Blackman are merely accusations, and they are presumed innocent unless and until proven guilty.

The conspiracy charge is punishable by a maximum potential penalty of 30 years in prison and a fine of up to \$1 million. Sentencing is scheduled for Oct. 19, 2021.

Acting U.S. Attorney Honig credited postal inspectors of the U.S. Postal Inspection Service, under the direction of Acting Inspector in Charge Rodney M. 
