SCIENTISTS MAKE MONUMENTAL BREAKTHROUGH IN NUCLEAR FUSION



WASHINGTON, D.C. - The U.S. Department of Energy (DOE) and DOE's National Nuclear Security Administration (NNSA) have announced the achievement of fusion ignition at Lawrence Livermore National Laboratory (LLNL - a major scientific breakthrough decades in the making that will pave the way for advancements in national defense and the future of clean power.

On December 5, a team at LLNL's National Ignition Facility (NIF) conducted the first controlled fusion experiment in history to reach this milestone, also known as scientific energy breakeven, meaning it produced more energy from fusion than the laser energy used to drive it. This historic, first-of-its kind achievement will provide unprecedented capability to support NNSA's Stockpile Stewardship Program and will provide invaluable insights into the prospects of clean fusion energy, which would be a gamechanger for efforts to achieve President Biden's goal of a netzero carbon economy.

"This is a landmark achievement for the researchers and staff at the National Ignition Facility who have dedicated their careers to seeing fusion ignition become a reality, and this milestone will undoubtedly spark even more discovery," said U.S. Secretary of Energy Jennifer M. Granholm. "The Biden-Harris Administration is committed to supporting our world-class scientists - like the team at NIF - whose work will help us solve humanity's most complex and pressing problems,

A VACCINE FOR SKIN CANCER COMING?

A Chinese Company based in Texas called Microvast received a \$200 million grant from President Joseph Biden under the infrastructure plan. The infrastructure plan was approved by bipartisan votes with power given to the President as usual for fast progress in America.

U.S. Senator John Barrasso (R-WY) on Dec. 13 wrote a letter to the Department of Energy. He stated in his letter, "I write to you with grave concerns as the Department of Energy (DOE) continues to operate in a manner that undermines and endangers our national security. In addition to the misuse of the Strategic Petroleum Reserve and security issues that have brought widespread condemnation upon the Department, DOE has awarded \$200 million to Microvast, a lithium battery company that operates primarily out of the People's Republic of China (PRC)... additionally, before Microvast received its grant from DOE, it was listed by the SEC in May of 2022 as a company not in compliance with the Holding Foreign Companies Accountable Act (HFCAA).

"This law is intended to prevent companies that employ China-based auditors, as does Microvast, from obscuring their financial records from U.S. regulators. I remind you that the Bipartisan Infrastructure Law was ostensibly intended to develop robust domestic manufacturing bases and supply chains free from the predations of the PRC. DOE distributing \$200 million in taxpayer funds to a company joined at the hip with China is demonstrably antithetical to the Bipartisan Infrastructure Law's intent. It is clear DOE's actions directly undermine the United States' position in its race against China for technological supremacy."

Senator Barrasso asked for a reply by Dec. 21, 2022. Hopefully, the DOE will reply, but I doubt it. China is the number one in producing country in the world of auto batteries. CATL (Contemporary Amperex Technology Ltd.) is a Chinese based company that provides lithiumion batteries to Tesla, Peugeot, Hyundai, Honda, BMW, Toyota, Volkswagen, and Volvo. So, in one way it is good that Biden is getting a contract to speed up the process of manufacturing in the USA. However, not providing an audit in the United States is problematic and they can steal technology from us and we wouldn't know.

As expected, the Federal Reserve increase interest rates by .50 points to curb inflation. Even though inflation has shown a reduction to 7.1 percent in November, this will help to reduce further inflation. Some experts are looking at a mild to midrange recession in 2023.

According to the World Economic Forum: "U.S. consumers have \$1.5 trillion in excess savings from pandemic stimulus programs, but it may run out some time in mid-2023, Dimon said. He also said the Federal Reserve may pause interest rate rises for 3-6 months after lifting them to 5%, but that this may 'not be sufficient' to curb high inflation."

CDC Studies Support Mpox Vaccine as Safe and Effective

Studies show vaccinated people have substantially less risk for contracting mpox compared with those who are unvaccinated and identified no major safety concerns after nearly 1 million doses administered.

New data released Dec. 9 in CDC's MMWR provide additional evidence to support that vaccination with the JYNNEOS mpox vaccine is safe and reduces the risk for getting mpox. CDC recommends vaccination for people at risk for getting mpox (fka "monkeypox").

The first report looked at vaccine safety data among children and adults and found no major vaccine safety concerns after nearly 1 million JYNNEOS doses were administered. Common adverse health events reported were consistent with studies before the vaccine was licensed, including injection site redness, swelling, or pain, and dizziness.

The second report found rates of mpox illness in unvaccinated people were 10 times higher compared to those who had received both doses of the JYNNE-OS vaccine, and there was no difference between intradermal and subcutaneous routes of administration. These findings provide additional evidence supporting the protective effect of vaccination.

"Mpox cases are decreasing, but so is public concern," said Jonathan Mermin, M.D., M.P.H., mpox response Incident Manager. "With a safe, effective vaccine in our hands, this is our chance to turn the page and finish strong."

CDC encourages everyone who is eligible for mpox vaccination to receive the complete twodose series for best protection.

FDA Authorizes Updated (Bivalent) COVID-19 Vaccines for Children Down to 6 Months of Age



On Dec. 9, the U.S. Food and Drug Administration amended the emergency use authorizations (EUAs) of the updated (bivalent) Moderna and Pfizer-BioNTech COVID-19 vaccines to include use in children down to 6 months of age.

"More children now have the opportunity to update their protection against COVID-19 with a bivalent COVID-19 vaccine, and we encourage parents and caregivers of those eligible to consider doing so - especially as we head into the holidays and winter months where more time will be spent indoors," said FDA Commissioner Robert M. Califf, M.D.

"As this virus has changed, and immunity from previous COVID-19 vaccination wanes, the more people who keep up to date on COVID-19 vaccinations, the more benefit there will be for individuals, families and public health by helping prevent severe illnesses, hospitalizations, and deaths."

What parents and caregivers need to know:

- Children 6 months through 5 years of age who received the original (monovalent) Moderna COVID-19 Vaccine are now eligible to receive a single booster of the updated (bivalent) Moderna COVID-19 Vaccine two months after completing a primary series with the monovalent Moderna COVID-19 Vaccine.
- Children 6 months through 4 years of age who have not yet begun their three-dose primary series of the Pfizer-BioNTech COVID-19 Vaccine or have not yet received the third dose of their primary series will now receive the updated (bivalent) Pfizer-BioNTech COVID-19 vaccine as the third dose in their primary series following two doses of the original (monovalent) Pfizer-BioNTech COVID-19 Vaccine.
- Children 6 months through 4 years of age who have already completed their threedose primary series with the original (monovalent) Pfizer-BioNTech COVID-19 Vaccine will not be eligible for a booster dose of an updated bivalent vaccine at this time. Children in this age group

who already completed their primary series would still be expected to have protection against the most serious outcomes from the currently circulating omicron variant. The data to support giving an updated bivalent booster dose for these children are expected in January. The agency is committed to evaluating those data as quickly as possible.

- The Moderna and Pfizer-BioNTech bivalent COVID-19 vaccines include an mRNA component corresponding to the original strain to provide an immune response that is broadly protective against COVID-19 and an mRNA component corresponding to the omicron variant BA.4 and BA.5 lineages to provide better protection against COVID-19 caused by the omicron variant.
- Individuals who receive the updated (bivalent) vaccines may experience similar side effects reported by individuals who received previous doses of the original (monovalent) mRNA COVID-19 vaccines.
- The fact sheets for both bivalent COVID-19 vaccines for recipients and caregivers and for healthcare providers include information about the potential side effects, as well as the risks of myocarditis and pericarditis.

"Vaccines remain the best defense against the most devastating consequences of disease caused by the currently circulating omicron variant, such as hospitalization and death. Based on available data, the updated, bivalent vaccines are expected to provide increased protection against COVID-19," said Peter Marks, M.D., Ph.D., director of the FDA's Center for Biologics Evaluation and Research.

"Parents and caregivers can be assured that the FDA has taken a great deal of care in our review, and we encourage parents of children of any age who are eligible for primary vaccination or a bivalent COVID-19 vaccine booster dose to consider seeking vaccination now as it can potentially help protect them from COVID-19 during a time when cases are increasing."

A VACCINE FOR SKIN CANCER COMING?

CAMBRIDGE, MA and RAH-WAY, NJ / ACCESSWIRE / December 13, 2022 - Moderna, Inc. (NASDAQ: MRNA), a biotechnology company pioneering messenger RNA (mRNA) therapeutics and vaccines, and Merck (NYSE:MRK), known as MSD outside of the United States and Canada, announced that the **KEYNOTE-942**/ Phase 2bmRNA-4157-P201 trial of mRNA-4157/V940, an investigational personalized mRNA cancer vaccine, in combination with KEYTRUDA®, Merck's anti-PD-1 therapy, demonstrated a statistically significant and clinically meaningful improvement in the primary endpoint of recurrence-free survival (RFS) versus KEYTRUDA alone for the adjuvant treatment of patients with stage III/IV melanoma (skin cancer) following complete resection. Adjuvant treatment with mRNA-4157/V940 in combination with KEYTRUDA reduced the risk of recurrence or death by 44% (HR=0.56 [95% CI, 0.31-1.08]; one-sided pvalue=0.0266) compared with KEYTRUDA alone.

"Today's results are highly encouraging for the field of cancer treatment. mRNA has been transformative for COVID-19, and now, for the first time ever, we have demonstrated the potential for mRNA to have an impact on outcomes in a randomized clinical trial in melanoma," said Stéphane Bancel, Moderna's Chief Executive Officer. "We will begin additional studies in melanoma and other forms of cancer with the goal of bringing truly individualized cancer treatments to patients. We look forward to publishing the full data set and sharing the results at an upcoming oncology medical conference, as well as with health authorities."

"These positive findings represent an important milestone in our collaboration with Moderna," said Dr. Dean Y. Li, president, Merck Research Laboratories. "Over the last six years, our teams have worked closely together combining our respective expertise in mRNA and immuno -oncology with a focus on improving outcomes for patients with cancer. We look forward to advancing this program into the next phase of development."

"The results of this randomized Phase 2b trial are exciting for the field. These data provide the first evidence that we can improve on the rates of recurrence-free survival achieved by PD-1 blockade in resected highrisk melanoma. These findings also provide the first randomized evidence that a personalized neoantigen approach may be beneficial in melanoma," said Jeffrey S. Weber, MD, PhD, principal investigator of the study and Deputy Director of the Perlmutter Cancer Center at NYU Langone. Dr. Weber is a paid consultant for Merck and Moderna.

Adverse events observed mRNA-4157/V940 with in **KEYNOTE-942** were consistent with those previously reported in a Phase 1 clinical trial. The safety profile of KEYTRUDA was consistent with that observed in previously reported studies. Serious treatment-related adverse events occurred in 14.4% of patients who received the combination arm of mRNA-4157/V940 and KEYTRUDA versus 10% with KEYTRUDA alone.

The companies plan to discuss the results with regulatory authorities and initiate a Phase 3 study in melanoma patients in 2023.

In October of this year, the companies announced that Merck had exercised its option to jointly develop and commercialize mRNA-4157/V940. Merck and Moderna will share costs and any profits equally under this worldwide collaboration.

Personalized cancer vaccines are designed to prime the immune system so that a patient can generate a tailored antitumor response specific to their tumor mutation signature. mRNA-4157/V940 is designed to stimulate an immune response by generating specific T cell responses based on the unique mutational signature of a patient's tumor. KEYTRUDA is an immunotherapy that works by increasing the ability of the body's immune system to help detect and fight tumor cells. Based on early clinical studies, combining mRNA-4157/V940 with KEYTRUDA may potentially provide an additive benefit and enhance T cellmediated destruction of tumor cells.

GLOBAL TRADE DROPS

<u>WORLD</u>

Global trade is set to reach almost \$32 trillion this year, but inflation has reversed some of the gains made in recent months.

That's according to UN trade and development agency, UNCTAD, whose analysts said that global growth "turned negative" during the second half of 2022.

The UN agency said that trade in goods and services is expected to reach \$25 trillion and \$7 trillion respectively, by the end of the year.

The downturn began in the third quarter of the year, with goods trading about one percent lower than from March to May.

In its global trade update, UNCTAD said that although services actually increased by 1.3 per cent in the third quarter, both goods and services are expected to fall in value in the run-up to the end of the year.

Demand for foreign goods "proved resilient" through 2022, the trade and development update said, with trade volumes overall increasing by three percent.

Trade volumes of east Asian economies have shown resilience, while South-South trade lagged during the third quarter.

Overall, "geopolitical frictions, persisting inflation, and lower global demand are expected to negatively affect global trade during 2023," said UNCTAD in its report highlights.

Among the negative factors teased out, are lower economic growth forecast through 2023 due to high energy prices, rising interest rates, sustained inflation in many economies and the depressive impact of the war in Ukraine.

Prices of components and consumer goods are expected to dampen demand for imports and lead to a declining volume of international trade.

Record levels of global debt and increased interest rates, "pose significant concerns for debt sustainability," increasing pressure on those governments most in debt, and "amplifying vulnerabilities."

On the upside, ports and shipping companies have adjusted to the supply chain crunch provoked by the COVID-19 pandemic, with new ships entering service, and port congestion, largely resolved, said UNCTAD.

Recently signed trade agreements such as the Regional Comprehensive Economic Partnership in the Asia-Pacific (RCEP), and the African Continental Free Trade Area (AfCFTA), "should come to fruition and provide some momentum" for the whole international system, the report highlights.

RUSSIAN OFFICIALS & OTHERS HIT WITH SANCTIONS

<u>EUROPE</u>

On Dec. 13 the UK announced a new package of 16 sanctions targeting senior Russian commanders for their involvement in the Russian military, and Iranian businessmen and officials involved in the production and/or supply of drones to the Kremlin.

The announcement comes as Russia steps up its campaign of terror against Ukraine, striking at crucial energy infrastructure and plunging its people into the dark and freezing cold of winter.

like providing clean power to combat climate change and maintaining a nuclear deterrent without nuclear testing."

"We have had a theoretical understanding of fusion for over a century, but the journey from knowing to doing can be long and arduous. Today's milestone shows what we can do with perseverance," said Dr. Arati Prabhakar, the President's Chief Advisor for Science and Technology and Director of the White House Office of Science and Technology Policy.

"Monday, December 5, 2022, was a historic day in science thanks to the incredible people at Livermore Lab and the National Ignition Facility. In making this breakthrough, they have opened a new chapter in NNSA's Stockpile Stewardship Program," said NNSA Administrator Jill Hruby. "I would like to thank the members of Congress who have supported the National Ignition Facility because their belief in the promise of visionary science has been critical for our mission. Our team from around the DOE national laboratories and our international partners have shown us the power of collaboration."

"The pursuit of fusion ignition in the laboratory is one of the most significant scientific challenges ever tackled by humanity, and achieving it is a triumph of science, engineering, and most of all, people," LLNL Director Dr. Kim Budil said. "Crossing this threshold is the vision that has driven 60 years of dedicated pursuit - a continual process of learning, building, expanding knowledge and capability, and then finding ways to overcome the new challenges that emerged. These are the problems that the U.S. national laboratories were created to solve."

"This astonishing scientific advance puts us on the precipice of a future no longer reliant on fossil fuels but instead powered by new clean fusion energy," U.S. Senate Majority Leader Charles Schumer said. I commend Lawrence Livermore National Labs and its partners in our nation's Inertial Confinement Fusion (ICF) program, including the University of Rochester's Lab for Laser Energetics in New York, for achieving this breakthrough.

"Making this future clean energy world a reality will require our physi-



cists, innovative workers, and brightest minds at our DOE-funded institutions, including the Rochester Laser Lab, to double down on their cutting-edge work. That's why I'm also proud to announce today that I've helped to secure the highest ever authorization of over \$624 million this year in the National Defense Authorization Act for the ICF program to build on this amazing breakthrough."

"After more than a decade of scientific and technical innovation, I congratulate the team at Lawrence Livermore National Laboratory and the National Ignition Facility for their historic accomplishment," said U.S. Senator Dianne Feinstein (CA). "This is an exciting step in fusion and everyone at Lawrence Livermore and NIF should be proud of this milestone achievement." "This is an historic, innovative achievement that builds on the contributions of generations of Livermore scientists. Today, our nation stands on their collective shoulders. We still have a long way to go, but this is a critical step and I commend the U.S. Department of Energy and all who contributed toward this promising breakthrough, which could help fuel a brighter clean energy future for the United States and humanity," said U.S. Senator Jack Reed (RI), the Chairman of the Senate Armed Services Committee.

IRVINGTON - Township and county authorities have been tracing a fourth bomb threat called to the Union Avenue Middle School in a month since Nov. 29. They are also looking for links to the first three threats called in Nov. 1-3.

Irvington police dispatchers, upon receiving a call from the Union Avenue main office of a threat called in at 1:50 p.m. that Thursday, called the Essex County Sheriff's Bomb Squad Unit.

Several IPD cars have closed the surrounding streets and met the bomb squad truck. The junior high school's students, faculty and administrators had been evacuated to nearby designated meeting places.

Township and county officers combed the building for any explosive or suspicious objects. The remaining school day resumed when law enforcers gave the "all clear" sign and allowed the community back in.

An anonymous caller had phoned in a threat at noon Nov. 1, 1:30 p.m. Nov. 2 and again on Nov. 3.

NEWARK - "Newark's Finest" teamed up with their Newark Public Schools Security colleagues to field two on-theproperty incidents at two separate schools Dec. 2 and 8.

Newark Public Safety Director Fritz Frage said that "a male juvenile" was taken into NPD Juvenile Services custody from Weequahic High School midafternoon Dec. 2. The unidentified student is accused of bringing a loaded handgun into the school earlier that Friday.

Members of the NPD bureau were called to the South Ward high school on an on-premises weapons possession call at 1:45 p.m. Officers met with NPS security guards, who transferred the youth and gun.

Details, including how the weapon was detected, remain unavailable as of press time. The incident remains under investigation.

NPD and NPS are also investigating what caused several fights - including those between students and adults - after Dec. 8 dismissal at the North Ward's Rafael Hernandez School Dec. 8. Security guards called for nearby Precinct Two police when several fights broke out after 3 p.m. Friday dismissal.

Responding officers found the Prekindergarten through Eighth grade elementary school locked down to secure afterschool students and administrators. Order was returned by 3:30 p.m.

EAST ORANGE - Relatives and friends of a young city mother of two have been making her funeral plans since Dec. 7 after her succumbing to injuries from an early Dec. 3 Irvington Center hit-and-run.

Acting Essex County Prosecutor Theodore "Ted" Stephens II and Irvington Public Safety Director Tracy Bowers had announced that Shauntice Paynes, 26, had died from a severe head injury.

Paynes, a Newark native, was a 2014 Arts High School graduate majoring in dance.

Paynes and another woman were walking across one of the five streets that make up Irvington's Five Points intersection at 2 a.m. Dec. 3 - and never made it across. A "light colored Mercedes-Benz " felled them and kept going.

It is unclear whether the other woman, who was admitted to Newark's University Hospital in stable condition, remains hospitalized. "Five Points" is where Springfield and Clinton avenues cross and where Maple and Union avenues start or end.

The Mercedes and its driver remain at large.

ORANGE - Riders here and East Orange may have noticed that one of Decamp Bus Lines' routes, the No. 88 to New York's Port Authority Bus Terminal, remains missing from the carrier's offerings for nearly three

The Montclair-based private bus company, on one hand, has been gradually increasing its runs on the 33, 44/99 and 66/66R routes in northern and western Essex County town since June 2021.

Decamp's No. 88 route, however, remains offline since the carrier canceled all operations March 25, 2020 in the wake of the global COVID-19 outbreak.

The 88 used to run weekdays from either Central Avenue and Scotland Road here or from East Orange's Prospect and William streets. Its Jan. 1, 2014 schedule listed eight eastbound and nine westbound runs. Only the current 44/99 routes, as of July 5, 2022, do not run on weekends or major holidays.

"Local Talk," to date, has heard an outcry over the 88's absence. That lack of loss may be due to the range of alternative transit services.

Orange Valley riders, for example, are within walking distance of either NJTransit's Morris & Essex Orange and Highland Avenue stations. East Orange's Central Evergreen Arcade and Brick Church riders can access the M&E Brick Church Station or, from Main Street/King Boulevard, the Community Coach No. 77 route.

Messages to company vice president Jonathan Decamp about the 88's future were unreturned as of 10 a.m. Dec. 14.

WEST ORANGE - The news and sorrow of Sister Joan Eileen Butler's Dec. 10 death by motor vehicle accident on the Garden State Parkway has been felt here in the Eagle Rock parish she had long served.

Butler, 88, was remembered for her health ministry teaching, sense of humor, wide reading and generosity here at Our Lady of Lourdes Roman Catholic Church. The Jersey City native and College of St. Elizabeth elementary education graduate stayed here after her 2006 retirement until June, when she moved into Convent Station's Convent of St. Elizabeth.

Butler, who was ordained as a Sister of Charity Sept. 6, 1955, was assigned to several parishes and schools in New Jersey and Massachusetts across 67 years. Her nurse's aide work at Montclair's Onma Health Care Services is among her latter assignments.

New Jersey State Police-Holmdel Barracks Sgt. Aljandro Goez said that Butler had died after a two-car collision in Aberdeen in the GSP's southbound local lanes at 10:44 a.m. Saturday.

Butler had first stopped her Ford on the right shoulder at Milepost 120.5 - and then tried to drive across all three lanes. She was struck by a Lexus NX and rushed to the nearby Holmdel's Bayshore Medical Center. The Lexus driver, a 49year-old man from Middlesex, sustained minor injuries.

Butler's Funeral Mass was scheduled for 11 a.m. Dec. 15 at the convent's Holy Family Chapel, followed by burial at Holy Family Cemetery. Memorial donations may be made to the Sisters of Charity Development Fund, PO Box 476, Convent Station, NJ 07961-0476.

SOUTH ORANGE - Shoppers and delivery drivers who stop or park in the South Orange Parking Authority's Sloan Lot should savor the free holiday season now through Dec. 27. for two reasons.

The immediate reason is that the free parking (for no more than three hours) will end on Dec. 28, short of the New Year's Day holiday. SPOA Executive Director Mark Hartwyk, on Dec. 8, said that the shorter Dec. 13-27 period was a "compromise" between balancing his agency's budget and meeting merchants' needs.

The more permanent reason was found by the "Local Talk" delivery crew with SOPA's removal of the lot's central ticket machine Dec. 8. A "Happy Holidays" sandwich sign stood in the kiosk's place - with its last line declaring that future parking charges will be made through license plate readers.

One can say that SOPA believes that license plate readers are not just for toll crossings anymore. Authority parking employees have been using handheld readers to identify permitholding parkers throughout 2022.

What is not clear is whether the license plate readers will be installed by the lot's entrance and exit aprons. The Port Authority (Continued on page 11)

Twelve senior commanders of Russian military forces, including units implicated in attacks on Ukrainian cities, have been sanctioned. Major General Robert Baranov, identified by a Bellingcat investigation as the commander of a unit responsible for programming and targeting Russian cruise missiles, is among those targeted.

More than 6,000 Ukrainian civilians are estimated to have died since the beginning of Russia's invasion, primarily as a result of Russian missile and artillery strikes. Intentionally directing attacks against civilians and civilian objects is a serious violation of International Humanitarian Law those responsible must be held to account.

Iranian-manufactured drones have played a central role in these evil attacks on civilians. On Dec. 9, the US released information showing Iran has become one of Russia's top military backers, sending hundreds of drones to Russia in violation of its international legal obligations, which have been used to attack Ukraine's critical infrastructure and kill civilians.

Foreign Secretary James Cleverly said, "The UK stands with Ukraine. Russian forces' calculated attacks on cities and innocent civilians in Ukraine will not go unanswered.

"The Iranian regime is increasingly isolated in the face of deafening calls for change from its own people and is striking sordid deals with Putin in a desperate attempt to survive.

"Putin wants to break Ukraine's spirit, but he will not succeed. Ukraine will win, and Ukraine will rebuild.

Orange and Union, were able to extinguish the second story blaze within 30 minutes.


Both incidents are under continuing in-

Jesus Breaks The Curse

Brigid Kemmerer is a New York Times bestselling author of dark and alluring Young Adult novels. She has written a series on Breaking the Curse that includes, A Heart So Fierce and Broken, A Curse So Dark and Lonely, and A Vow So Bold and Deadly. From the reviews I have read, much of what is included in them speaks about the paranormal or bizarre.

Without any intent to rebuke her, my reflection on the series reminds me of some words of Jesus: "If a kingdom is divided against itself, that kingdom cannot stand." The incident about which Jesus makes His comment is reported in three Gospels (Matthew 12:22-30, Luke 11:14-23; Mark 3:20-27), but I quote Mark's version:

Then Jesus went home, and once again, a crowd gathered, so He and His disciples could not even eat. When His family heard about this, they went out to take custody of Him, saying, "He is out of His mind." And the scribes who had come down from Jerusalem were saying, "He is possessed by Beelzebul," and, "By the prince of the demons He drives out demons." So, Jesus called them together and began to speak to them in parables: "How can Satan drive out Satan? If

scientists continue to lead the way in developing clean energy technologies. I congratulate the scientists at Lawrence Livermore National Laboratory for their dedication to a clean energy future, and I am committed to ensuring they have all of the tools and funding they need to continue this important work."

"This is a very big deal. We can celebrate another performance record by the National Ignition Facility. This latest achievement is particularly remarkable because NIF

a kingdom is divided against itself, it cannot stand. If a house is divided against itself, it cannot stand. And if Satan is divided and rises against himself, he cannot stand; his end has come. Indeed, no one can enter a strong man's house to steal his possessions unless he first ties up the strong man. Then he can plunder his house.

I declare that Jesus was making clear that he had absolute authority over the forces of demons, not by any satanic power but by his divine power. Earlier, Mark reports that after Jesus appointed the twelve disciples, "He gave them the power to drive out demons." (Mark 3:15)

The point is that Jesus Christ has all the authority to drive out any demon or break the power of any curse, and he is willing to share his power with all he chooses. Amid the pronouncements of the first curses after the fall of humanity, the announcement was made as recorded in Genesis 3:15, "And I will put enmity between you and the woman, and between your seed and her Seed; He shall bruise your head, and you shall bruise His heel.'

This is the promise that has been recited in various ways to the antediluvians, such as Enoch and Noah, and then to the patriarchs and matriarchs, including Abraham and Sarah, to the prophets, the sages, and the people of God in ancient Biblical times, and found its fulfillment in the birth and death of Christ. This is the promise that is celebrated in our Christmas stories today.

The apostle Paul references the power of the promise when

he takes note of what is written in Deuteronomy 5:22-23 to say, "Christ has redeemed us from the curse of the law, having become a curse for us (for it is written, "Cursed is everyone who hangs on a tree"), that the blessing of Abraham might come upon the Gentiles in Christ Jesus, that we might receive the promise of the Spirit through faith." (Galatians 3:13-14 NKJV)

Yes, we have been suffering general curses. I need not detail mine here. You should know yours, as I know mine. My Bible tells me that "all have sinned and become short of the glory of God." (Romans 3:23) That means nobody is left out.

The only real solution for our cursed situation is to trust Jesus Through his life and Christ. death, He has broken the power of sin. He has taken the punishment for our sins. He has broken the curses associated with the law of God. He became accursed us. That is, he took upon himself every curse, including generational curses.

Does this mean we go about being free of all curses, including generational ones? It should and would be nice. But in case you did not notice, there is a part we need to play in the removal of the curses. And it is simply accepting Christ, birth, death, and resurrection, by faith. We can claim every victory over all enemies through Jesus Christ. It is required for us to triumph over sin and its curses by faith.

The breaking of the curses is possible for every person in the world, but not everyone will exercise faith because they trust every other form of intervention except that of Jesus. We might find exciting material for novel reading about the Breaking the

Curse Series and other literature of the kind. But still, they do not remove any curses, at least not the type that has impacted "the third and fourth generation."

Maybe I should caution you that even when you accept Jesus, Satan will challenge your position and test how much you believe in the power of Jesus. If you are fooling around, you will open yourself so that what happened to the seven sons of the priest Sceva will more than likely happen to you. The book of Acts reports it thus, "Also there were seven sons of Sceva, a Jewish chief priest, who did so. And the evil spirit answered and said, "Jesus I know, and Paul I know; but who are you?" Then the man in whom the evil spirit dwelt leaped on them, overpowered them, and prevailed against them so that they fled out of that house naked and wounded." (Acts 19:14-16 NKJV).

Be watchful. Be vigilant. Learn to effectively break the curse by putting yourself into the hands of Jesus. As is stated in the lyrics of Richard Mullan's hvmn:

> *He can turn the tides* And calm the angry sea. *He alone decides* Who writes a symphony. *He lights ev'ry star* That makes our darkness bright. *He keeps watch all through* Each long and lonely night. *He still finds the time* To hear a child's first prayer. Saint or sinner call And always find Him there.

Refrain: Though it makes him sad To see the way we live, He'll always say, "I forgive."

EAST ORANGE LINK COMPLETES RAILROAD PROJECT 100 YEARS AGO

South Orange Village.

A reversible center "rush hour express" track was added to the two east and westbound tracks.

Truesdale, the Lackawanna board of directors and Chief Engineer George J. Ray sought faster service while eliminating hazardous grade crossings. The separaincluded tions the Erie Railroad crossing at Bloomfield's Watsessing Junction and the Morris Canal plane at Newark's Orange Road.

The increasing volume of pedestrian, horse, bicycle, streetcar and automotive traffic - and their grade crossing collisions - were growing at the turn of the last century. Fatality and injury reports became as common as today's mass shooting incidents.

Although the Lacka-Railroad, wanna with state Public Utilities Commission blessing, had committed itself to the grade separation project, matters came to a head on Thursday Feb. 19, 1903.

A Lackawanna express train cut a North Jersey Street Railway Company trolley in two at Newark's Clifton Avenue grade crossing. Nine people, all Barringer High School students, were killed and 29 more people were injured.

A grand jury inquest found that unsanded icy rails on the Orange Street decline kept the streetcar motorman from stopping the trolley - which went through the lowered crossing gates.

The panel handed down manslaughter indictments against four NJSRC employees and all seven members of its leadership. A stained glass mural, dedicated to the killed students, remains on display at BHS.

The Newark Municipal Council then passed an ordinance directing grade separation of all Class One rail-

roads within city limits. The Lackawanna, Pennsylvania and Central of New Jersey railroads responded by either raising or depressing their tracks' elevation within Newark.

Parts of the Erie's Greenwood Lake Division and Newark Branch in North Newark plus a short Lehigh Valley freight line in the South Ward, however, remain at grade.

The Lackawanna particularly responded by elevating Broad Street station, its building bridges over three Newark streets and digging the Roseville Cut. It was made a priority of its initial 1903-05 grade separation project with Harrison and Summit.

The project, done while running scheduled passenger and freight trains, continued at Morristown (1912), Chatham (1915), South Orange and Madison (1916) and Orange (1918.). Nineteen grade crossings were replaced in Orange alone by 12 bridges and by changing the tracks' radius at Scotland Road.

Montclair Branch's first phase - from the Grove Street, Montclair terminal through Glen Ridge and Bloomfield - was done in 1912-13. Its Watsessing Cut Bloomfield allowed in Lackawanna trains to pass under the Erie Orange Branch's Watsessing Junction bridge.

The project - whether on the Montclair Branch or on the M&E - ended at the East Orange border until disputes with city elders were resolved.

Mayors Julian A. Gregory (1914-18) and Charles H. Martens (1918-52) and their respective City Council members first objected to the grade separation on the view that the railroad would build "a Chinese wall" that would separate the city.

Martens, on his inauguration, then suggested depressing the railroad instead across East Orange.

Ray and his engineers said that depressing the track was impossible. The "East Orange Cut" would face water runoff seepage or flooding from Watchung Mountain streams and the trains would have difficulty climbing onto the 1890 stone arch bridge over the North Oraton Parkway.

Ray offered instead building a pair of 864-footlong viaducts above East Orange and Brick Church stations. The railroad would also raise The Parkway Arches by adding 15 feet in height.

City elders had meanwhile taken to railroad to Essex County Superior Court over who will pay to replace underground water, sewer and natural gas mains. The Lackawanna a standard 10percent "municipal contribution" for the construction.

towns Some readily agreed to paying the 10 percent charge. Bloomfield, for example, saw the benefit of eliminating its Glenwood Avenue grade crossing which had among the worst collision tolls in the state.

Some other towns, like Orange, reluctantly paid. 1913 City Council President John Fineran told the "Newark Evening News" that "Orange shouldn't be asked to pay a cent for the changes" and "It's a disgrace that the death crossings are allowed to kill and maim our citizens because of a false notion of economy held by the wealthy railroad management."

East Orange and the Lackawanna Railroad had gone to court before. The city asked a judge in the 1870s to have the railroad pay for crossing flagmen at Chestnut, Walnut and Clinton streets.

The relationship had not started out as hostile. Brick Church Station, for example, started out as an M&E flag stop by the home of attorney Matthias Ogden Halsted in 1836. Halsted, after buying neighboring land and building houses, offered the Lackawanna a new station at no cost in exchange for having all express trains stopping there in 1880.

Lackawanna, before an Essex County judge in 1921, agreed to pay for the utility line replacement. The city then agreed to let the grade separation project through.

The railroad promptly hired 800 workers and put \$4 million (or \$70.955 million in today's inflation-adjusted money) into the 18 month project. A temporary grade level track was laid along then-McKinley Street (now King Boulevard and Freeway Drive West). until the concrete was poured, ballast added the new tracks were elevated.

Similar work resumed on the Montclair Branch, elevating Ampere stations and building bridges over North Grove and Rutledge streets, Springdale Avenue and Fourth Street.


The construction would be the largest project in East Orange until the Garden State Parkway (1952-54) and Interstate 280 (1968-73) were put through. I-280, after a similar right-of-way debate was built as a depressed highway.

Whether the grade separation was worthwhile can be determined by comparing the Erie Railroad's fate here.

The Erie, which never had the financial resources of the Lackawanna, had to deal with dozens of grade crossings in its Orange Branch in Newark, Belleville, Bloomfield, East Orange, Orange and West Orange.

West Orange-Jersey City passenger service ended on May 20, 1955. Daily freight service dwindled until the Erie Lackawanna Railway ended that service in 1979. Its tracks between West Orange's Erie Loop and East Orange's Meadow Street were torn up 1979-82.

East Orange and the Lackawanna went to court again on May 12, 1923. The city sought an injunction to keep the railroad from turning its below viaduct parking spaces in East Orange and Brick Church stations into stores. (South Orange had later allowed such storefront creation by the 1960s.)

LLNL's experiment surpassed the fusion threshold by delivering 2.05 megajoules (MJ) of energy to the target, resulting in 3.15 MJ of fusion energy output, demonstrating for the first time a most fundamental science basis for inertial fusion energy (IFE). Many advanced science and technology developments are still needed to achieve simple, affordable IFE to power homes and businesses, and DOE is currently restarting a broadbased, coordinated IFE program in the United States. Combined with private-sector investment, there is a lot of momentum to drive rapid progress toward fusion commer-



GLEN RIDGE - The life curtain of "Parks and Recreation" actress Helen Slayton-Hughes, which was raised here Oct. 30, 1930, has closed in her Los Angeles home Dec. 7.

Slayton-Hughes, 92, said son Duncan on her Facebook page, had died in her sleep overnight. No cause of death - nor much else of her personal life - has been disclosed.

Born Helen Slayton into a family of five here, Slayton-Hughes' portrayal of Pawnee court stenographer Ethel Beavers in the 2011-15 comedy series may be the best known of her over 200 television, film, theater and video game credits since 1980.

Slayton had earned a drama degree from Syracuse University, her family having moved to Mamaroneck, NY by 1940. Slayton, outside of local theater, had deferred her professional career until 1980.

When she first became "Selma" in the 1980 movie "Mafia on the Bounty," she had married a Mr. Hughes. The status of that marriage remains unknown as of press time.

Most of Slayton-Hughes' credits were of single-episode characters on television, including on "The Drew Carey Show," "The West Wing," "NYPD Blue" and "That's So Raven." Her parts were roughly halved into either dramatic or comedic roles.

"I love doing drama but I'm always hired to do comedy," said Slayton-Hughes, whose last public appearance was at an Oct. 8 movie screening. "The universe is getting ready for a big project; preparing for my departure."

MONTCLAIR - The township has counter filed papers in New Jersey Superior Court on Nov. 23 against former CFO Padmaja Rao's Oct. 16 hostile workplace and harassment lawsuit.

Township lawyers are seeking to have Rao's suit dismissed, asserting that "Boorish, unprofessional behavior" is not grounds for suit. Rao's suit against the township and Township Manager Timothy Stafford has led to the Township Council placing Stafford on paid leave. There is at least one more suit in court against Stafford and the township in court.

Station, Playground Bias-Tagged

Township police detectives are looking for any links between graffiti tags that were left on a respective playground and on a railroad station here Nov. 29 and Dec. 7.

Wednesday morning riders told responding MPD officers that they found "gold stars" painted on one of the NJTransit Upper Montclair Station's platform railings. This follows a swastika and other "vulgar images and phrases" made with a magic marker on seven Edgemont Park playground fixtures. Montclair's Commission on Human Rights have also been informed.

BELLEVILLE - "Local Talk" is hoping that relatives and friends of "a 57-year-old Belleville man," whose body was found in Nutley's part of The Third River Dec. 2 have gone on with the deceased's funeral arrangements.

Neither the State Regional Medical Examiner, nor ECPO, have publicly identified the man, let alone his cause of death.

Nutley police officers and firefighters, responding to a dead body call, converged on 3 Kingsland St. late that Friday morning. The river flows through the property, which includes the historic Kingsland Manor.

The first responders found the man's body at the base of the river's waterfall.

Neither Nutley Public Safety Commissioner Alphonse Petracco nor Nutley Police Chief Thomas Strumolo wanted to speculate on how the dead man got there.

Petracco noted that the manor and waterfall is "a popular location;" Strumolo said that heavy rain earlier in the week may have carried the body there.

NUTLEY - The township's volunteer fire chief is awaiting the results of a Hudson County Prosecutor's Office investigation of his actions on the North Bergen Walmart parking lot Dec. 6 - which led to Nutley police and Township Attorney Jonathan J. Bruno bringing him in for questioning here from Bloomfield and Raymond avenues.

Nutley, ECPO and Hudson County have asked Henry Meola, 33, if he was intending to meet a 14-year-old boy for sex. They are reviewing three-hour Instagram footage, recorded live by OBL Nation, had documented a sting or an entrapment.

Meola thought he was greeting the teenager, whom he had met on an app, at

the parking lot - but encountered "Remy" and two other male assistants instead. Remy runs a "To Catch a Predator" - inspired program.

Meola and the OBL trio then drove over to Petracco & Sons restaurant at 507 Bloomfield Ave. where the chief's night went from bad to worse. Bruno and several NPD officers, tipped off by live Instagram viewers, met the foursome.

Remy has given testimony and a copy of the three-hour recording to prosecutors. He said that a shorter, edited version will be reposted on Instagram.com/obl.nation.

Nutley Public Safety Commissioner Alphone Petracco said that Meola had called him and told him that he was coming to his family's eatery. Petracco said Meola only added that he was in "a bad situation."

A spokesman for Acting Essex County Prosecutor Stephens, on Dec. 8, said that the suspect (Meola) was not arrested nor had charges had been lodged against him. That was before Stephen's office transferred the case to Hudson County colleague Esther Suarez.
