HARRIS MAKES HISTORY

Becomes First Minority Woman to Nominated for President By a Major Political Party



Chicago, IL - In the history of the United States, no major political party had ever nominated a minority woman to its presidential ticket - until now.

On August 22, Vice President Kamala D. Harris accepted the nomination of the Democratic Party of the United States for the job currently served by her boss, President Joseph R. Biden. Originally, Biden himself was running for reelection. However, after a


disastrous debate against his opponent - former President Donald J. Trump - Biden was pressured to end his campaign and "pass the torch" to the 59-year-old Harris. The Party wanted the change in the hopes that it would boost fundraising efforts and change the narrative from Biden being too old at 81, to Trump being too old at 78.

EVEN MORE OFFICERS WRITTEN UP IN ATTORNEY GENERAL'S REPORT

NEWARK - There were 18 officers from four Essex County law enforcement agencies plus a college campus police department who were also written up for major discipline in the New Jersey Attorney General's Aug. 2 report.

The said officers were in addition to the 29 police officers from seven "Local Talk" area municipal departments who were so written up between June 15, 2020 to Dec. 31, 2023. By major discipline, the said officers were disciplined by being suspended for at least five days, forfeiting vacation or other accrued time, being transferred, demoted, resigning or

had the Newark Police Division landing the "top" or "worst" 10 lists of major discipline incidents with 16. The county's corrections department, with 12, also made that list of dubious distinctions. They were among the 167 law enforcement agencies who reported to the NJAG's office.

COUNTY DEPARTMENT OF CORRECTIONS

OFF. BRYAN DUNN. Suspended 150 days for unbecoming conduct and excessive absenteeism. Officer had called out Sick Without Pay unapproved, since Aug. 11, 2021. He had entered into a settlement with DOC July 27, 2021 over 120 days' SWOP.

OFF. BRIAN HANLON. Suspended six days for insubordination, neglect of duty, unbecoming conduct and incompetency. Officer was accused of arriving at a traffic control site by parking county vehicle and keeping its emergency lights - and not actually controlling traffic - during the eight hour shift. He allowed other county officers to cross Doremus AG Matthew Platkin's report Avenue without aid. Officer also addressed his report to his superior as "Provisional" Captain.

> Hanlon was earlier suspended 10 days for not responding to an activated code alarm by staying in a perimeter vestibule with two other officers and leaving in a county van.

> OFF. IDESHA HOWARD. Terminated for unbecoming conduct. An Internal Affairs investigator had found that the officer had falsified her close custody

observation report; she had reported conducting five tours when she actually did two.

SGT. JASON JARMIN. Suspended 41 days for conduct unbecoming an officer. Two civilian scheduling employees told master control that the sergeant had tried to start "inappropriate conversation" with them while on their way to drop off the 2-10 schedule and on their way out. Jarmin then entered master control and made physical contact with one of the schedulers while they were talking with the counts control of-

Jarmin was also earlier observed as being asleep at his post for 40 minutes.

SGT. EBONY MULLIN. Suspended 150 days for unbecoming conduct, withholding information or providing false information.

OFF. JAMIL OTERO. Suspended five days for unbecoming conduct, incompetency. Accused of not constantly observing an inmate in a dry cell, falling asleep while the inmate removed a contraband cellular phone from his own bodily cavity, destroying said phone and spiriting its pieces out of his cell.

OFF. RADI RICE. Suspended 20 days for sleeping in the intake and pre-book area while on duty. Lieutenant on duty had him write why he was sleeping. Accused of bypassing a cell sense machine to snap photos of master control, center control and three lieutenants' desks with her own phone.

OFF. MICHAEL ROMERO. Suspended 10 days for falling asleep and reawakening for 34 minutes while at the pre-book

OFF. KELLY ROUSE. Suspended 20 days for leaving behind his department-issued handgun in a University Hospital restroom and failing to notify his supervisor of leaving his post to retrieve the firearm.

OFF. RANDY ULERIO. Suspended 60 days for six charges of failing to perform duties, incompetence and violating county departmental rules and regulations. He was accused of opening a cell in addition to the six he was assigned to for inmate recreation - and the extra cell's inmate knocked another inmate

unconscious in the dayroom.

OFF. KIANA WILSON-CARTER. Suspended 30 days for leaving behind her department handgun in a University Hospital restroom and failing to notify supervisor of leaving her post for retrieval.

OFF. MUNAJJ ZAYID. Suspended 15 days for insubordination. Zayid was taken off inmate extraction duty after yelling at the inmate and his sergeant, "Hurry up, I don't have all day." The supervising lieutenant sent the officer to master control, where he was excused that day.

SHERIFF'S OFFICE

OFF. JAVIER COLON. Suspended seven days for "Conduct prejudicial to good order." Accused of submitting "invalid military orders."

OFF. VANESSA CUEVAS. Suspended eight days for engaging in an unauthorized pursuit of a stolen motor vehicle.

RECRUIT LOUIS SCAPPA-TICCIO. Terminated for differential treatment. Accused of making racial comments to a fellow police academy recruit.


PROSECUTOR'S OFFICE

DET. SAMOURI CLEGG. Resigned for unbecoming conduct. Provided false report of Aug. 28, 2023. He reported that the personal firearm in his vehicle was an empty holster with an empty magazine. An Essex County Sheriff's Office report and "BWC footage" indicated otherwise.

NJIT POLICE

OFF. MICHAEL CAPANO. Suspended 30 days and resigned for violating code of ethics, core values. Was arrested by Paramus Police for shoplifting. NJIT PD would have suspended the officer for 30 days regardless of his resignation.

SGT. CHARLES KIM. Suspended 60 days for neglect of duty, related charges. Sgt. was accused of abandoning his onduty shift while being the only shift supervisor and leaving Essex County with a department vehicle for "a personal, nonemergent matter."


The free-to-the-public, 7day Fan Week concluded on Sunday, August 25th. This included a 128-man field and a 128-woman field of qualifiers who competed in three rounds, with the victors gaining entry into the main draw, whose first round purse is \$100K. JUSTICE DEPARTMENT SUES REALPAGE OVER PRICING SCHEME

The Justice Department, together with the Attorneys General of North Carolina, California, Colorado, Connecticut, Minnesota, Oregon, Tennessee, and Washington, filed a civil antitrust lawsuit Aug. 23 against RealPage Inc. for its unlawful scheme to decrease competition among landlords in apartment pricing and to monopolize the market for commercial revenue management software that landlords use to price apartments.

RealPage's alleged conduct deprives renters of the benefits of competition on apartment leasing terms and harms millions of Americans. The lawsuit was filed in the U.S. District Court for the Middle District of North Carolina and alleges that Real-Page violated Sections 1 and 2 of the Sherman Act.

The complaint alleges that RealPage contracts with competing landlords who agree to share with RealPage nonpublic, competitively sensitive information about their apartment rental rates and other lease terms to train and run RealPage's algorithmic pricing software. This software then generates recommendations, including on apartment rental pricing and other terms, for participating landlords based on their and their rivals' competitively sensitive information.

The complaint further alleges that in a free market, these landlords would otherwise be competing independently to attract renters based on pricing, discounts, concessions, lease terms, and other dimensions of apartment leasing. RealPage also uses this scheme and its substantial data trove to maintain a monopoly in the market for commercial revenue management software. The complaint seeks to end RealPage's illegal conduct and restore competition for the benefit of renters in states across the country.

"Americans should not have to pay more in rent because a company has found a new way to scheme with landlords to break the law," said Attorney General Merrick B. Garland. "We allege that RealPage's pricing algorithm enables landlords to share confidential, competitively sensitive information and align their rents. Using software as the sharing mechanism does not immunize this scheme from Sherman Act liability, and the Justice Department will continue to aggressively enforce the antitrust laws and protect the American people from those who violate them."

The complaint cites internal documents and sworn testimony from RealPage and commercial landlords that make plain Real-Page's and landlords' objective to maximize rental pricing and profitability at the expense of renters. For example:

- RealPage acknowledged that its software is aimed at maximizing prices for landlords, referring to its products as "driving every possible opportunity to increase price," "avoid(ing) the race to the bottom in down markets," and "a rising tide raises all ships."
- A RealPage executive observed that its products help landlords avoid competing on the merits, noting that "there is greater good in everybody succeeding versus essentially trying to compete against one another in a way that actually keeps the entire industry down."
- A RealPage executive explained to a landlord that using competitor data can help identify situations where the landlord "may have a \$50

increase instead of a \$10 increase for the day."

Another landlord commented about RealPage's product, "I always liked this product because your algorithm uses proprietary data from other subscribers to suggest rents and term. That's classic price fixing..."

The complaint alleges that RealPage's agreements and conduct harm the competitive process in local rental markets for multi-family dwellings across the United States. Armed with competing landlords' data, Real-Page also encourages loyalty to the algorithm's recommendations through, among other measures, "auto accept" functionality and pricing advisors who monitor landlords' compliance.

As a result, RealPage's software tends to maximize price increases, minimize price decreases, and maximize landlords' pricing power. RealPage also trained landlords to limit concessions (e.g., free month(s) of rent) and other discounts to renters. The complaint also cites internal documents from Real-Page and landlords touting the fact that landlords have responded by reducing renter concessions.

The complaint separately alleges that RealPage has unlawfully maintained its monopoly over commercial revenue management software for multifamily dwellings in the United States, in which RealPage commands approximately 80% market share. Landlords agree to share their competitively sensitive data with RealPage in return for pricing recommendations and decisions that are the result of combining and analyzing competitors' sensitive data. This creates a self-reinforcing feedback loop that strengthens RealPage's grip on the market and makes it harder for honest businesses to compete on the merits.

MIDDLE EAST POLIO VACCINES ARRIVE IN GAZA

United Nations Secretary-General António Guterres is closely following negotiations in Doha focused on trying to end the war in Gaza, where the situation continues to remain catastrophic after more than 10 months of unrelenting war.

The UN Children's Fund (UNICEF) announced on Aug. 26 the arrival of 1.2 million doses of vital polio vaccines in Gaza, amid urgent calls for humanitarian pauses to reach hundreds of thousands of at-risk children.

More than 640,000 children are targeted to receive the polio type two (nOPV) vaccines, UNICEF said in a post on X.

The World Health Organization (WHO), the UN's main agency assisting Palestine refugees (UNRWA) and other partners aim to coordinate to reach the unvaccinated as the war grinds on against the backdrop of multiple civilian displacements.

The Israeli government agency COGAT said vaccine shipments had arrived in Gaza through the Kerem Shalom Crossing, adding that the vaccination campaign will be conducted in coordination with the Israeli Defense Forces (IDF) as part of "routine" humanitarian pauses.

Gaza has been in the grip of an ongoing war following the October 7 terror attacks last year by Hamas and other Palestinian armed groups in southern Israel.

More than 40,000 people have lost their lives in the enclave, according to the Strip's health ministry, and critical infrastructure, including schools-

Here now are excerpts of Harris' historic acceptance speech.

"Good evening. To my husband, Doug, thank you for being an incredible partner to me and father to Cole and Ella. And happy anniversary. I love you so very much.

"To Joe Biden - Mr. President. When I think about the path we have traveled together, I am filled with gratitude. Your record is extraordinary, as history will show. And your character is inspiring. Doug and I love you and Jill. And I am forever thankful to you both.

"And to Coach Tim Walz, you are going to be an incredible Vice President. And to the delegates and everyone who has put your faith in our campaign - your support is humbling.

"America, the path that led me here in recent weeks, was no doubt ... unexpected. But I'm no stranger to unlikely journeys...

"...I grew up immersed in the ideals of the Civil Rights Movement. My parents had met at a civil rights gathering. And they made sure we learned about civil rights leaders, including lawyers like Thurgood Marshall and Constance Baker Motley. "Those who battled in the courtroom to make real the Promise of America. So, at a young age, I decided I wanted to do that work. I wanted to be a lawyer.

"And when it came time to choose - the type of law I would pursue - I reflected on a pivotal moment in my life.

"When I was in high school, I started to notice something about my best friend Wanda. She was sad at school. And there were times she didn't want to go home.

"So, one day, I asked if everything was alright. And she confided in me that she was being sexually abused by her stepfather. And I immediately told her she had to come stay with us.

"And she did. That is one of the reasons I became a prosecutor.

"To protect people like Wanda. Because I believe everyone has a right: To safety. To dignity. And to justice.

"As a prosecutor, when I had a case, I charged it not in the name of the victim. But in the name of. 'The People.'

"For a simple reason. In our system of justice, a harm against any one of us is a harm against all of us. I would often explain this, to console survivors of crime. To remind them: No one should be made to fight

alone. We are all in this together.

"Every day in the courtroom, I stood proudly before a judge and said five words: 'Kamala Harris, for the People.' And to be clear: My entire career, I have only had one client. The People.

NEWARK - What started out as a downtown bus ride for a NJTransit passenger and his bus driver Aug. 16 ended with both being booked at Newark Police Headquarters for aggravated assault - on each other.

Police division officers, said Newark Public Safety Director Fritz Frage, came to the corner of Court and Broad streets on a report of an onboard bus fight at 1 p.m. They arrived to find the bus driver and the passenger beating each other before about 24 onboard passengers.

Officers separated the duo and began interviewing them and the riders. The driver, identified as Toron Walker, and passengers said that the altercation began when the rider spat on the driver, igniting a war of words. The bus was at Broad and Lafayette streets after Noon.

Those words, going by passengers' onboard cell phone video recordings, escalated to where Walker parked the bus at Broad and Court, got out of his seat, ordered passengers to move to the rear of or exit the bus and began punching the alleged spitter. The driver was shown putting the rider in a chokehold before throwing him down onto the center aisle.

Although neither suffered serious injuries, Walker was charged with aggravated assault - as was the rider for spitting on him. Both Newark and NJTransit Police are investigating the incident.

A NJTransit spokesman con-

firmed that there was an assault aboard one of its buses and the agency does not condone such on any of its vehicles and facilities. The driver is "out of service." The rep reminded the public that assaulting any transit employee is punishable by fine, up to seven years' imprisonment and a permanent riding ban.

IRVINGTON - Funeral arrangements were not immediately available as of press time for resident and retired Irvington Police Division Sgt. Winchester Beaumont.

Beaumont, 52, according to IPD Police Benevolent Association Local 29's Facebook page, had died Aug. 24.

Local 29's posting said that Beaumont was first hired by Irvington Township as a telecommunication specialist, answering 911 calls, in 1994. He joined "Irvington's Finest" July 20, 2000 after taking training at the Essex County Police Academy. "Chad" was promoted to sergeant before retiring Dec. 1, 2020.

Beaumont's mother, wife and two daughters are among his survivors.

It is anticipated that Beaumont's last rites will be held in the local church where he was a deacon.

EAST ORANGE - City elders are honoring a city pioneer by giving visitors to the East Orange Fire Department Headquarters a new entrance in her name in early 2026.

Mayor Theodore "Ted" Green and Interim Fire Chief Bruce Davis unveiled an artist's rendering of the coming Alberta E. Daniels Heritage Hall at the headquarters here July 31. The Daniels Hall, which will be built on 486 Dr. Martin Luther King, Jr. Blvd.'s west side, will eliminate visitors having to enter by walking through a fire engine bay door.

The Art Deco era headquarters and the Elmwood Fire Station 5 at 205 Elmwood Ave. are being renovated and modernized. Station 5's fire engine and ladder truck, for example, had been earlier moved east across Stuyvesant Avenue to a temporary tent erected on the former Vernon L. Davey Middle School/first Langston Hughes School parking lot.

Daniels, who turned 95 in

August, was also among the announcement's dignitaries. The East Orange High School graduate was the first woman appointed to the East Orange Board of Fire Commissioners 1986-2005. The East Orange Women's Alliance co-founder is the longest-serving East Orange Democratic Committee member.

Daniels, then and now, is a Fifth Ward resident. Former Essex County then-Freeholder and Registrar and once-city councilwoman Carol Clark is her daughter.

ORANGE - Mayor Dwayne D. Warren, Council President Adrienne Wooten, East Ward Councilman Kerry Coley and atlarge councilors Clifford Ross and Weldon "Monty" Montague III made some 10 stops on their annual National Night Out tour Aug. 20 wearing "Orange United" t-shirts.

The white shirts featured a black shield with the city, police and fire department logos on the corners and "2024 A City United" working at the center. Below that line is: "Our Fight, Our Time, Our City."

Montague, who "Local Talk" met up at the "Rock the Vote" Ebenezer Baptist Church voter registration sign up at the corner of Park and William streets Aug. 24, explained the reasoning behind the "City United" slogan.

"We've had, 'Moving Orange Forward' during political times," said Montague. "We're a family who have had their argument. Now it's time for, 'A City United.'

Montague added that the "United" shirts debuted at the 40th anniversary NNO last year. 2023 was also when Rock the Vote and EBC started holding voter registrations together.

"We're a Democratic state but our turn out is low," said Montague. "We've some 17,000 registered voters in a city of 30to34,000 but our turnout is in the hundreds or low thousands."

Saturday's registration drive, meet-and-greet and cookout was held between 10 a.m. and 2 p.m. Two people, with children in tow, signed up the first 30 minutes; another two promised to return later.

WEST ORANGE - Township elders and representatives of the Black Inventors Hall of Fame are working on the details of landing the former's museum at the Mayfair Farms site.

BIHOF Executive Director James Howard, from his Wharton headquarters Aug. 14, announced that the institution had bought a 5.5-acre parcel of the former banquet hall property. An artist's rendition has a new building attached to a to-be-renovated mansion-turned-catering kitchen.

The combined old-new structure will be an overall 105,000 square feet to house the hall of fame, museum and a STEAM learning center. It is not clear whether the 5.5 acres include the intended site of a four-story assisted living center.

The West Orange Planning Board had earlier approved subdividing Mayfair Farms for senior housing and commercial uses after it ended its 80-year run in 2022. Township planners allowed Wonder Group caterers to move in. Wonder, known for its final food preparation vans appearing at clients' doors, had applied to add 10 BBQ meat smokers to 481 Eagle Rock Ave. to the property July 8.

BIHOF has a touring display; "The Three Era of African American Inventor Experience Journey," that has made stops at Essex Community College's Newark Main Campus, Princeton and as distant as Alexandria, Va. It has inducted said inventors annually since 2022.

Inductee Lewis Latimer (1848-1928) had collaborated with Thomas A. Edison 1884-1911 on several inventions and was a legal patent consultant here. He was the first African American member of the Edison Pioneers.

THE FINAL 2024 PARIS OLYMPICS WRAP UP

"The important thing in life is not the triumph, but the fight; the essential thing is not to have won but to have fought well." -The Olympic Creed.

NEWARK - At least three United States Olympic Committee team athletes who call the "Local Talk" area home have arrived to celebrate their respective Paris Summer Games gold medal efforts.

Edrice Femi "Bam" Adebayo, of Newark, and Jackie Dubrovich, of Maplewood, earned gold medals with their respective men's basketball and women's fencing foil teams before the 2024 Paris games ended Aug. 11.

Upper Montclair's Jesse Grupper meanwhile placed 18th in sport climbing.

Adebyo was part of the USA team who defeated the hometown French national team, 98-87, for the gold Aug. 10. Some of the Newark native's teammates, including Stephen Curry, made a last minute scoring drive to give Team USA its fifth straight team gold medal.

The International Olympic Committee had allowed professional basketball players onto member teams, which led to the landmark 1992 USA "Super Team." France had several players from the NBA while the US had Curry, LeBron James and a deep roster of potential NBA Hall of Fame candidates.

That US roster includes Adebayo, who plays for the Miami Heat. Other locals like Shaquille O'Neal and Kyrie Irving have played for the US Men's team in the past.

Dubrovich and her fencing

colleagues meanwhile won the US' first team gold medal in foil competition. She, Lee Keifer, Lauren Scruggs and Maia Weintraub had defeated the Italian national team that had defeated them for the bronze medal in the "2020" Summer Games at Tokyo. (The latest Tokyo games were postponed to 2021 by the global COVID-19 pandemic.)

The Riverdale, NJ native had moved to Maplewood to run the New Jersey Fencing Alliance in that township's Hilton section.

Grupper, while finishing 18th in sport climbing's respective lead and boulder competition, was unable to qualify for the finals. He scored a respective 18.9 points and 30.9 points compared to gold medalist Sorato Anraku's 69 and 137 points.

Sydney McLaughlin-Levrone, daughter of East Orange High School track and field runner Willie McLaughlin, attained a gold medal in the 400-meter hurdles Aug. 8 and set a 50.37 sec. world record.

McLaughlin-Levrone's second straight Olympic gold came by beating herself. She had set a 51.46 sec. world record while winning the "2020" Summer Olympic Games at Tokyo Aug. 5, 2021.

Levrone, career-wise, had gone farther than her father. Willie McLaughlin. W. McLaughlin was a multiple All American awardee from Manhattan College got as far as 400m in the 1984 USOC Olympic Trials' semifinal.

The above results are from the 1,800 athletes and coaches the USOC sent to Paris. It does not include any "Local Talk" athletes who competed under another nation's or committee's flag.

The former League of Women Voters chapter president was also active with the Maplewood/South Orange Peace and Community Action in the 1960s and 70s. She was a protester against nuclear testing and the wars in Vietnam and Iraq.

The former Edith Brodsky was born in Brest Litovsk, then in Poland, July 4, 1920. She and younger sister Selma emigrated with the family to Newark in 1925. Edith and Selma graduated from schools in Newark and Irvington; they lived at Newark's 109 Hillside Ave. in 1940.

Edith graduated from Montclair State Teachers College/Normal School in 1942 and had volunteered as a nurse's aide in local hospitals during World War Two. She became Edith Oxfeld after marrying the civil liberties lawyer in 1947.

Emil, who founded the ACLU of New Jersey in 1960 and was its president until 1985, and Edith also collected contemporary art. Edith, post-Emil, attended chamber orchestra performances in Maplewood and opera in New York until recently.

The Oxfelds thank Casimira, Elisabete and Patricia Paulo for their caretaking since 2020. A gathering, not a formal memorial service, is to be announced. Memorial donations may go the ACLU-NJ Foundation and/or New Jersey Peace Action.

BLOOMFIELD / GLEN RIDGE -

There should be no surprise to see mourners from here, Montclair, West Orange, South Orange and Maplewood having paid respects to Cong. William "Bill" Pascrell (D-Paterson) at Paterson's Cathedral of St. John the Baptist Aug. 27-28.

Pascrell, 78, who died of breathing conditions Aug. 21 at Livingston's Copperman-Barnabas Medical Center, was those "Local Talk" towns' "Our Man on Capitol Hill" 1997-2001 despite his being a lifelong Patersonian.

Pascrell was first elected to Congress' House of Representatives via the old Eighth District in 1997. The "Old Eighth" included the eight "Local Talk" towns until they were drawn out after the 2000 Census. The 14-term Congressman and his home city became the core of the current Ninth District in 2013.

He created legislation which created and funded the USDOT rush hour railroad station minibus grant program in 1998, basing it on the pioneering 1996 Maplewood jitney service. The bill led to jitney service in Bloomfield, Glen Ridge, Montclair, West Orange, South Orange, Irvington and Union County's Springfield plus expanding Maplewood's service. (Orange had jitney service for two years; East Orange was awarded a mini grant.)

Pascrell, who was on the Houses' Ways and Means Committee and was an original Homeland Security Committee member, also led the bid to designate Paterson's Great Falls district a National Historic Park.

William James Pascrell, Jr. born the

grandson of Italian Immigrants Jan. 25, 1937, was first appointed onto Paterson Board of Education before running successfully as an assemblyman in the "old 35th" State Legislative District in 1987. The former Paramus High School teacher left the State House to get elected as Paterson's mayor in 1990. He left that city hall to take his Capitol Hill seat in 1997.

Democrats in the 9th CD's 35 Passaic, Bergen and Hudson are to replace Pascrell's name on the Nov. 5 General Election ballot on or before Aug. 29. Pascrell won his party's June 4 primary towards a 15th two-year term.

Wife Elise, sons Bill III, David and Glenn, daughter Kelly, sisters Barbara Pascrell and Joyce Ferraro, three grandsons and three granddaughters are among the former U.S. Army reservist's survivors. Memorial donations may be made to the Brain Injury Alliance of New Jersey, Eva's Kitchen and/or the Kessler Foundation.

MONTCLAIR - The Montclair Public Schools will be launching a five-year strategic plan along with the 2024-25 school year.

The Montclair Board of Education concluded 10 months of plan development by approving it at their Aug. 12 meeting. The plan, which was introduced in October, was refined through three community planning sessions last November and December.

The plan has set goals in five areas for the district through 2030: Achievement for

BELLEVILLE / NUTLEY

- Belleville motorists, bus riders, pedestrians and business owners who have endured NJDOT's Washington Avenue rehabilitation project so far may want to take up to three years' worth of patience with them here - and in Nutley when the project comes

to them.

NJDOT and its contractors have closed Washington's two center lanes along a five block stretch in Belleville since early this summer. All traffic - including NJTransit buses and delivery vehicles - have to take the right hand lanes.

Curbside parking along that stretch has been suspended. The construction zone's Jersey barriers have blocked pedestrian and vehicular cross street intersection traffic.

NJDOT, in an August update, said that the "Route 7 Rehabilitation" project is advancing northward in eight stages, which began in April between Howard Place and Rutgers Street. This summer's work is between Rutgers and Holmes Street.

The remaining Belleville stages are to be between Holmes and Joralemon Street, Joralemon and Little Street, Little and Greylock Parkway, Greylock to Carmer Avenue. and Carmer into Nutley's Hancox Place. The all-Nutley and last stage is to be Hancox to Centre Street.

The two-mile NJ Route 7 stretch of Washington Avenue is to benefit from \$20 million worth of milling, paving, traffic signal upgrading and highvisibility crosswalks and curb cuts. Essex County had concluded its own two-mile repaving and fiber optic cable installation project along Newark's Broadway in May.



turned displacement shelters, hospitals and clinics has been destroyed.

A case of polio was confirmed in Gaza last week, in a 10-month-old child. It was the first such instance of the lifelong crippling disease in over 25 years. Though there is no cure, vaccines against the disease can protect a child for life.

The child had developed paralysis in the lower left leg and is reported to be in a stable condition.

"Polio will not make the distinction between Palestinian and Israeli children," UNRWA chief Philippe Lazzarini said last week, highlighting the need for urgent pause in fighting to mitigate the risk of spread of the disease.

He reiterated the call on Aug. 26, stressing that UN agencies and partners "stand ready to vaccinate children, but need a humanitarian pause."

Meanwhile, the plight of civilians in the war-ravaged Gaza Strip continues unabated.

According to UNRWA, due to ongoing military operations in Deir Al-Balah in central Gaza only three of the area's 18 water wells remain functional, resulting in 85 percent water shortfall.

"Not only are people in Gaza in constant fear for their lives, but they struggle to meet even their most basic needs," the agency said.

Risk of other deadly infectious disease also remains high with water and sanitation systems disrupted across the enclave, including at hospitals, WHO warned.

Its effort to mitigate the threat continues. The agency recently provided hospitals in north and south Gaza with a range of critical medical supplies, including anesthesia and analgesic drugs to cover the needs of around 44,500 patients.

Some 200 ICU beds were also delivered to Gaza and are expected to support at least five health facilities in expanding bed capacity, the agency added in a separate post.

EUROPE DUTCH AUTHORITY SMOKES UBER

On Aug. 26, the Dutch Data Protection Authority (DPA) imposed a fine of 290 million euros on Uber. The Dutch DPA found that Uber transferred personal data of European taxi drivers to the United States (US) and failed to appropriately safeguard the data with regard to these transfers. According to the Dutch DPA, this constitutes a serious violation of the General Data Protection Regulation

(GDPR). In the meantime, Uber has ended the violation.

"In Europe, the GDPR protects the fundamental rights of people, by requiring businesses and governments to handle personal data with due care," Dutch DPA chairman Aleid Wolfsen says. "But sadly, this is not self-evident outside Europe. Think of governments that can tap data on a large scale. That is why businesses are usually obliged to take additional measures if they store personal data of Europeans outside the European Union. Uber did not meet the requirements of the GDPR to ensure the level of protection to the data with regard to transfers to the US. That is very serious."

The Dutch DPA found that Uber collected, among other things, sensitive information of drivers from Europe and retained it on servers in the US. It concerns account details and taxi licenses, but also location data, photos, payment details, identity documents, and in some cases even criminal and medical data of drivers.

For a period of over 2 years, Uber transferred those data to Uber's headquarters in the US, without using transfer tools. Because of this, the protection of personal data was not sufficient. The Court of Justice of the EU invalidated the EU-US Privacy Shield in 2020.

According to the Court, Standard Contractual Clauses could still provide a valid basis for transferring data to countries outside the EU, but only if an equivalent level of protection can be guaranteed in practice.

Because Uber no longer used Standard Contractual Clauses from August 2021, the data of drivers from the EU were insufficiently protected, according to the Dutch DPA. Since the end of last year, Uber uses the successor to the Privacy Shield.

The Dutch DPA started the investigation on Uber after more than 170 French drivers complained to the French human rights interest group the Ligue des droits de l'Homme (LDH), which subsequently submitted a complaint to the French DPA.

Pursuant to the GDPR, businesses that process data in several EU Member States have to deal with one DPA: the authority in the country in which the business has its main establishment. Uber's European headquarters is based in the Netherlands. During the investigation, the Dutch DPA closely cooperated with the French DPA and coordinated the decision with other European DPAs.

All DPAs in Europe calculate the amount of fines for businesses in the same manner. Those fines amount to a maximum of 4% of the worldwide annual turnover of a business. Uber had a worldwide turnover of around 34.5 billion euro in
